## Internet suspended, 72 held in Badlapur post violence during protest over sexual abuse case

THANE: Internet services at Badlapur in Maharashtra's Thane district were suspended on Wednesday a day after a massive protest over alleged sexual abuse of two kindergarten girls, and 72 persons have been arrested in connection with the violence during the stir, officials said

At least 17 city police personnel and around eight railway cops were injured in the incidents of stone-pelting at the railway station and other parts of Badlapur during the protest on Tuesday, they said.

Police have been deployed in large numbers across Badlapur to maintain law and order, and the situation in the town is back

Entire Badlapur town virtually came to a standstill on Tuesday after thousands of protesters blocked railway tracks at the station and stormed the school building, where sexual abuse of two girls by the school sweeper took place last week.

The protesters hurled stones at police personnel and vandalised the school building during the protest. The police canecharged the protesters to dis-



perse them and clear the tracks for train movement.

Talking to PTI, Sudhakar Pathare said on Wednesday that internet services in the town have been suspended in the wake of the protest and subsequent vio-

"The internet services will be restored after taking a review of the situation in the town," he

Most schools in the town remained shut on Wednesday, local people said.

"At least 17 city police personnel, including two officers, were injured as an angry mob attacked them with stones during the protest in Badlapur on Tuesday over the sexual abuse of two girls. We have registered three FIRs on charges of violation of prohibitory orders,

unlawful assembly, armed assault, damage to public property, among others against the miscreants," a senior police official in Badlapur said.

The injured police personnel are being treated at different local hospitals, he said.

"A total of 40 persons have been arrested so far in connection with stone-pelting and other crimes. Attempts to identify other offenders are on. CCTVs footages and video news clippings are being examined," he added.

Commissioner of Government Police (GRP) Railway Ravindra Shisve said one FIR has been registered in connection with the violence at Badlapur railway station and 32 persons have been arrested.

happened belongs to a close relative of a BJP leader from Badlapur, sources said.

Maharashtra Deputy Chief Minister Devendra Fadnavis on Tuesday said he has ordered the formation of a special investigation team headed by senior IPS officer Arti Singh, while Chief Minister Eknath Shinde said action will be taken against the school. He said the case will be fast-tracked and the guilty won't be spared.

Talking to a news channel, senior lawyer Ujjwal Nikam, who has been appointed as the special public prosecutor in the sexual abuse case, condemned the inordinate delay by the police in lodging an FIR in the case. "This is a sensitive case. It is shameful why the police officers did not not take up the matter seriously. Why the senior police officials ignored the complaint will definitely be probed and those found guilty will be punished. The most important thing is that during such cases, if the police delay in taking cognisance, then crucial evidence is lost," he said.

A local court on Wednesday extended till August 26 the police remand of the accused.

## WHO calls for providing lifesaving vaccines to all kids, protecting adolescent girls from cervical cancer

NEW DELHI: The World Health Organisation on Wednesday called on the countries in its South-East Asia Region to accelerate action to protect all children with lifesaving vaccines being offered under the childhood immunisation programme, focusing on those who have missed all or some doses, and protect all adolescent girls from cervical

"We should aim for a big catch-up to vaccinate all zerodose and partially-vaccinated children, and restore the immunisation progress lost during the (COVID-19) pandemic, protect all adolescent girls from cervical cancer and accelerate efforts to eliminate measles and rubella from WHO South-East Asia by 2026," said Saima Wazed, Regional Director, WHO South-East Asia, in her inaugural address to the 15th meeting of the WHO South-East Asia Regional Immunisation Technical Advisory Group (SEAR-ITAG).

Wazed acknowledged and thanked all experts, national programme managers, immusation champions and partners, including the vaccinators and community workers and the communities themselves, on the expanded immunisation programme completing 50

"We can proudly say, in the last 50 years, together, immunisation programmes have helped hundreds of millions of people in our region live healthier, longer, more productive and prosperous lives," she said.

"Today, the South-East Asia region continues to be free of wild polio virus transmission and has maintained elimination of maternal and neonatal tetanus as a public-health problem. Five countries have eliminated measles and rubella, and six have controlled hepatitis B through immunisation.

"Seven countries consistently reach over 90 per cent of children with three doses of diphtheria, pertussis and tetanus (DTP3) vaccines," Wazed said.

However, the region missed the target to eliminate measles and rubella by 2023. The WHO-UNICEF Estimates of Immunisation National Coverage data released last month shows slow progress and no meaningful change in childhood-immunisation coverage last year compared to 2022, and the coverage is yet to be restored to the pre-pandem-

ic 2019 levels. "Nearly 2.7 million (27 lakh) children in our region did not get any vaccine and another 0.6 million (six lakh) children were partially vaccinated in 2023. We need to understand where and why these children were missed and prioritise

reaching them as soon as possible. No child should ever fall sick or die of any vaccine-preventable disease, when safe and effective vaccines exist to protect them," Wazed said.

He wondered whether the Rs 6,000 crore loss in one year does not smell of predatory pricing, as they are just an ecommerce platform and those companies are not allowed to do B2C (business to consumer) business.

As per the policy, the e-commerce platform legally can not do B2C in the country.

The minister alleged that these companies only re-route all the businesses through an entity to show that it is B2B. "How are they doing it? Should this not be a matter of

concern for us," he said.

He added that the e-commerce sector has a role, but one has to think "very" carefully and cautiously about what that role is. "How that role can be in an

He pointed out that India is not a developed nation like the US and Switzerland with high per capita income, and a large section of people need affirmative action and help here.

"Of course, I do not deny that technology will play its part, technology is a means to empower, to innovate, to meet consumer requirements, probably sometimes more efficiently, but we will have to see that it grows in an orderly fashion, he said. People have to see that this connectivity and convenience is citizen-centric, he said, adding that in the race for market share of online retailers at 27 per cent a year, "we do not land up causing huge disruption for the 100 million small retailers across the country". Amazon India is facing rising competitive intensity in India from players like Flipkart and SoftBank-backed Meesho, as well as the onslaught of firms like Blinkit, Swiggy's Instamart and Zepto that are making aggressive inroads into the market as busy consumers opt for the convenience of instant delivery of grocery and many other household items. Last year, Amazon had talked of plans to invest USD 15 billion more in India, taking its total investment in the country to USD 26 billion. After meeting with Prime Minister Narendra Modi during his visit to the US in 2023, Amazon CEO Andy Jassy said: "I had a very good and productive conversation with Prime Minister Modi. I think we share a number of goals. Amazon is one of the biggest investors in India. We have invested USD 11 billion to date and intend to invest another USD 15 billion, which will bring the total to USD 26billion. So, we are very much looking forward to the future of partnering". Goyal also criticised the report, saving he does not agree with the findings of the study 'Net Impact of e-commerce on employment and consumer welfare in India'. "I would like to completely disassociate myself from this report...I do not agree with any of these findings...I think in the urge to show that this has not had an impact on employment in India, the researchers have lost sight of even the statistics. which EY has put out," the minister said.

## AIIMS Delhi constitutes two committees to assess safety measures at campus member committee, comprising

NEW DELHI: The AIIMS Delhi administration Wednesday appealed to striking resident doctors to resume duties in the interest of patient care, saying a collaborative internal security audit will be conducted to assess safety and security measures within the

Two committees have also been constituted by the administration to look into safety issues at the institute and other concerns of the doctors. Resident doctors of AIIMS

have been on strike demanding a central legislation for the protection of healthcare workers following the alleged rape and murder of a woman trainee doctor at a state-run medical college and hospital in Kolkata.

Besides the security audit, the AHMS administration has also decided to install Al-enabled CCTV cameras at key entry and exit points of the Mother and Child Block on a pilot basis

Such cameras shall be able to recognise all visitors with facial recognition technology and shall help security staff to identify persons entering and exiting frequently thereby helping them in access control of unauthorised personnel.

AIIMS Director Dr V Srinivas said the entire AIIMS family stands behind the cause of safety of all healthcare pro-

fessionals at the premier hospital and across the country.

"However, as doctors, our supreme duty is also to ensure that patients visiting our portals do not go unattended," he said in an appeal document.

Srinivas said the administration has decided to undertake a collaborative internal security audit at AIIMS, New Delhi with regard to the safety and security of healthcare professionals, staff, patients and visitors and to facilitate the same, a 15-member committee has been constituted.

The committee will be headed by Dr Puneet Kaur, Head, Department

Biophysics. There will be representatives of FAIIMS, Resident Doctors Association, Students Union, Nurses Union and Society of Young Scientists among others in the panel.

The committee will visit AIIMS campuses, including outreach campuses like NCI Jhajjar, Haryana, NDDTC Ghaziabad, Uttar Pradesh, CRHSP Ballabgarh, Haryana, etc during the day and at night and survey security measures,

The committee will also deliberate on any additional safety and security measures required in the AIIMS campus and submit its recommendations at the earliest for speedy implementa-

"The government of India is committed to the cause of healthcare professionals' safety unequivocally and the Supreme Court, while assuring affirmative action for ensuring safety of healthcare professionals, has requested all doctors to resume duties in the interest of patient care," he said.

"Requesting the resident doctors of AIIMS New Delhi to resume their duties immediately so that patient care services are normalised." he added.

The security staff has also expressed difficulty in identifying such frequent visitors as they are on shift duty and it is not possible for them to raise suspicion as many times it leads to inconvenience to genuine visitors and patients attendants.

There have been news reports of other important hospitals wherein such unauthorized personnel have even caused gross harm to patients and there have been reports of patients being sometimes misguided and fleeced in AHMS as well.

The body of the postgraduate trainee doctor was found in the seminar hall of state-run RG Kar Medical College and Hospital in Kolkata on August 9. A civic volunteer was arrested in connection with the crime the next day.

The Calcutta High Court later handed over the case to the CBI.
