

EEO meets representatives of political parties in Shopian

SHOPIAN: Election Expenditure Observer (EEO) for district Shopian, Nelapatla Ashok Babu on Thursday held a meeting with representatives of Political Parties at Shopian in order to sensitize them about the election matters related to the expenditure incurrence and monitoring of contesting candidates during the ensuing Elections to the Assembly Constituencies of Shopian and Zainapora of the district. He intimated them about various systemic measures taken to ensure peaceful and induce-ment free elections. He sought their cooperation towards the conduct of impactful and fair elections without engaging in any illegal financial transac-tions or inducements by them. In this context, he apprised them that multiple Flying Squads, Static Surveillance, Video Viewing Teams and Accounting teams for both the ACs of District have been con-stituted to keep check on expenditure incurrence by contesting candidates. The Political Parties were apprised of various IT election apps for complaint and griev-ance redressal, for flagging any violations in order to make the process more transparent. The meeting was also attended by Nodal Officer, Expenditure Monitoring, representatives and district heads of various national, recognised, regis-tered parties and other con-cerned staff.

SRINAGAR: The District Election Officer (DEO) Srinagar, Dr. Bilal Mohi-Ud-Din Bhat on Thursday inspected the designated Strong Room and Counting Centres being established at SKICC here for all 08 Assembly constituencies of Srinagar District. The inspection was under-taken to assess the pre-paredness regarding faci-lities and security measures for seamless conduct of upcoming General Election to Legislative Assembly-2024 in the District. During the visit, the DEO reviews the arrangements and facilities at Strong

Room and Counting Centres for all 08 Assembly Constituencies viz 19-Hazratbal, 20-Khanyar, 21-Habbakadal, 22-LalChowk, 23-Chanapora, 24-Zadibal, 25-Eidgah 26-Central Shalteng. During the inspection, the DEO stressed the con-

cerned Officers to take up necessary measures to ensure that all required arrangements are put in place well in advance to facilitate a smooth and efficient election related process. He also laid emphasis on placing adequate spaces for counters to be placed at

Counting Halls in order to avoid any cluttering during management of election related materials. The DEO also stressed strict adherence to pre-scribed standards of Election Commission of India to uphold the integri-ty and fairness of the elec-toral process.

He stressed on proper han-dling/management of elec-tion material besides ensur-ing efficient and secure mechanisms for its storage. Deputy District Election Officer, Mir Intiyaz Ul Aziz, Nodal Officers and other officials accompanied the DEO Srinagar during his visit.
