As per the report of Aww of AWC Hella and supervisor and as per the record of your attendance register you are unauthorized absent from duties since January 2024 and still.

Whereas this office has issued an explanation call vide no. CDPO/P/G/Estt/203-24/970-994 dated 10-02-2024 Where in you was directed to report at AWC with in three days positively and resume duties but you failed to resume duties.

Whereas on 14-03-2024 you was again served a show Cause notice vide No.CDPO/Poshan/G/2023-24/1070-73 dated 14-03-2024 regarding your unauthorized absence from duties since 01-01-2024 but did not bothered to respond the show cause notice and failed to resume duties since last 7months and you are continuously absent till date and still.

Whereas the supervisors visited your AWC on routine basis and found you unauthorized absence from duties every time. The concerned AWW of your AWC Mr khurshad Begum and the supervisor also reported that you have changed your residence and now you are residing at Gool block Gool some and you are not attending your AWC. The concerned supervisor recorded her visits on your attendance register and your attendance is blank as you have not marked your attendance during last seven months and you are continuously unauthorized absent from duties from last 7months due to which the beneficiaries of your AWC are suffering which is gross violation of ICDS norms.

In view of the above facts and in the best Interest of People and the beneficiaries of the area this final Show Cause notice is issued to you and you have been given a last and final opportunity to report in the office and submit the reasons of your prolonged absence (more than 7 months) from duties with in seven days failing which it shall be presumed that you are not interested to serve more in the department and this office is constrained to terminate you from the temporary services without issuing any further notice in accordance with ICDS norms in Vogue.

- The Internal Assessment awards (in case of 10th and 12th classes)/Internal and External Assessment awards (in case of 11th class) must be submitted in duplicate under proper signature of Subject/s Examiner/s duly attested by the Head of the concerned Institution.
- The entire internal assessment/External practical awards must be routed to the Divisional Office, Jammu through the concerned Sub/Branch Offices; no internal/external assessment will be accepted through the medium of email and by post.
- The assessment awards shall mention the complete examination Roll No. of the candidates.
