Four prominent actors face fresh sexual abuse allegations, Malayalam film industry in turmoil

THIRUVANANTHAPURA M : A female actor in Malayalam cinema levelled sexual abuse allegations against four prominent male actors, including M Mukesh, on Monday, causing further upheaval in the film industry already reeling from the Justice K Hema Committee's explosive findings of harassment and abuse of women professionals

Hours after the actress the allegations against Mukesh, a CPI(M) MLA, in interviews with channels, workers from Yuva Morcha and Mahila Congress organised separate marches towards his residence in Kollam, demanding that a case be registered against him and that he resign as a legislator.

The Kollam MLA has not responded to the allegations.

The female actor also levelled sexual abuse allegations against three other prominent actors in the Malavalam film industry.

actor Meanwhile. Maniyanpilla Raju has called for an investigation into the allegations surfacing in the Malayalam film industry. He told reporters that many more revelations will come out, and there will be multiple interests behind

"Some people will try to capitalise on the situation. Among those accused, there will be both innocent and guilty parties. Therefore, a comprehensive investigation is necessary," Raju said.

This development comes a day after director Ranjith and actor Siddique stepped down from their leadership roles in a state-run film academy and the Association of Malavalam Movie Artists (AMMA), respectively, following sexual abuse allegations against them.

Amid mounting pressure on the government to take action against alleged predators in the film industry, Chief Minister Pinarayi Vijayan held a high-level meeting with senior police officials on Sunday and announced the establishment of a seven-member special team to investigate the atrocities faced by women

The report by the Justice Hema Committee, constituted by the Kerala government post the 2017 actress assault case, has revealed instances of harassment and exploitation of women in the Malayalam cinema industry, prompting calls for action against the

Doctor's rape-murder: BJP announces series of protest programmes from Aug 28

KOLKATA: Stepping up the attack on the ruling Trinamool Congress in West Bengal, BJP state president Sukanta Majumdar has announced a series of programmes to protest the alleged rape and murder of a woman doctor at a state-run hospital here over two weeks

The programmes will be held across the state between August 28 and September 4, said Majumdar, also a Union minister.

Demanding Chief Minister Mamata Banerjee's resignation for her alleged failure to address the issue of women's safety, Majumdar said the

party will begin a sit-in in Esplanade area of Kolkata from August 28 while the party's women's wing will lock the gates of the state women's commission office.

"The state women's commission seems to have gone into a stupor," Majumdar told reporters on the sidelines of a demonstration by BJP in Shyambazar area of the city.

The BJP leader said that August 29, party activists will gherao the district magistrate's office in every district at noon while protests will be held outside the administrative offices in every block on September 2. On September 4, a 'chakka jam' will be observed everywhere in the state stalling the movement of traffic for one hour, he said.

Majumdar claimed the ongoing CBI probe into the alleged financial irregularities in R G Kar Medical College and Hospital showed the nexus between the state and the corrupt hospital lobby.

The chief minister is shielding "big fishes involved in the shady deals amounting to crores," he alleged. We demand the phone

conversation between the CM and a powerful official of the hospital be brought under the ambit of investigation by CBI," the Union Minister of State for Education said.

Responding to BJP's planned programmes, TMC state spokesperson Joy Prakash Majumdar said, "To divert the focus from the delay by CBI in tracking the perpetrators of the crime, the BJP is trying to foment trouble in the state and disrupt normal life."

"While the entire West Bengal is asking the CBI to ensure justice is done to the victim doctor, the BJP's only demand is resignation of the CM who has expressed solidarity with the victim's family and stood by them. She also reiterated her government and party's stance

about zero tolerance to incidents like rape," he added.

Another TMC leader Kunal Ghosh said the main demand of every citizen of the state centres around the punishment of all those involved in the rape and murder of the doctor, but the BJP is talking about socalled financial irregularities in the hospital.

"This shows the BJP is not serious about the main issue of women's safety, the issue flagged by lakhs of women of West Bengal. TMC shares the concern of the women of the state and demands justice for the victim. The CBI should speed up the probe on this," Ghosh said.

Nearly 16 years after acquittal, two men convicted by Delhi HC for injuring person

NEW DELHI: The Delhi High Court has reversed the acquittal of two men after around 16 years and convicted them for intentionally hurting a person on his head, resulting in 21 stitches.

The high court said the trial court had fallen into the error of disbelieving the testimony of the injured person and in observing that it was in contradiction with the statement of another prosecution witness. It set aside the trial court's October 2008 judgment acquitting Mohit Kumar and Sandeep Kumar of the offence under Section 308 (attempt to commit culpable homicide not amounting to murder) of the Indian Penal Code.

The trial court's acquittal order was challenged by the prosecution on the ground that the testimonies of the witnesses proved the incident beyond reasonable doubts. Overturning the acquittal, Justice Neena Bansal Krishna said, "To conclude, it is proved from the consistent testimony of the complainant, which is corroborated by independent circumstances, that the accused used a sharpedged weapon to attack the complainant, resulting in a deep wound on his head which required 21 stitches, though opined as simple."

"A person hitting a victim on his head with a sharp pointing weapon would do so with the knowledge and intention that such an attack or injury on the head of the victim is likely to result in death of a person," she said. According to the prosecution, an FIR was registered in 2006 on a complaint that the two accused went to complainant Maninder Gautam, abused and threatened him and then hit him with a sharp object resulting in a serious wound on his head.

He started bleeding and became unconscious and was taken to a hospital where he received 11 stitches on his head, the prosecution said.

Later the weapon of the offence a nail cutter was recovered at the instance of the accused, it added. The high court, however, said it has to be necessarily concluded that the prosecution has proved beyond reasonable doubt that the two men had intentionally inflicted injury on the head of the injured with an intent and knowledge that such injury could result in death. The high court listed the matter for August 30 for arguments on pronouncing sentence to the convicts.

A Superintendent of the Central Jail at Parappana Agrahara here has also been transferred following an inquiry after a photo of the actor smoking with a coffee mug in hand emerged on social media on Sunday sparking a row.

The picture shows Darshan sitting leisurely on a lawn on the jail premises along with three others, including two alleged rowdy-

sheeters. Those suspended are jailers Sharan Basappa Amingad and Prabhu S Khandelwal, assistant jailers L S Kuppeswamy, Srikanth Talwar, head warders Venkappa, Sampath Kumar and warder K Basappa, Karnataka Home Minister G Parameshwara told reporters here on Monday. The new jail superintendent will be asked to strictly deal with such incidents of "dereliction of duty," he said.

Parameshwara said soon after the matter came to his knowledge he directed the Director General of Police to conduct a probe following which a team of senior police officials visited the jail. Their inquiry confirmed the involvement of the suspended

officers in facilitating special treatment to Darshan, he added. Parameshwara said it is a matter of con-

cern that such incidents occur despite the presence CCTVs and jammers inside the prisons in the state.

A total of 17 people including Darshan along with his friend Pavithra Gowda are currently in judicial custody in connection with the murder case. According to police sources, 33-year-old Renukaswamy, a fan of the actor, had sent obscene messages to Gowda, which enraged Darshan, allegedly leading to his murder. His body was found near a stormwater drain next to an apartment in Sumanahalli here on June 9.

Ensure marriage witnesses are genuine: HC tells Arya Samaj Mandir

NEW DELHI: Taking note of a marriage solemnised between a girl and her 'phupha' (uncle) who falsely claimed to be unmarried, the Delhi High Court has asked an Arya Samaj temple to ensure that those who stand witness to such ceremonies are genuine and bonafide.

A bench headed by Justice Prathiba M Singh said the temple shall endeavour to have at least one witness from both the sides, who is either a relative or an acquaintance who has known them for a reasonable period of time. In the present case, the court

observed, the manner in which the girl's

own uncle falsely declared himself to be unmarried before the Arya Samaj Mandir was "clearly contrary to law" and the marriage was void. It noted that apart from the couple and the priest who solemnised the marriage, nobody was present at the wedding ceremony performed at the Arya

"validity and sanctity", the court said, was "completely suspect" The court was informed that the Arya Samaj temple takes affidavits of parties with respect to their marital status but no further verification is conduct-

riage, they are genuine and bonafide witnesses, whose status can be verified properly. The temple shall endeavour to call at least 1 witness who is a relative, from both the sides, i.e, the bride and the bridegroom and if there is no relative, some acquaintance who knows the parties concerned for a reasonable period of time shall be permitted to become a witness," said the bench, also comprising Justice Amit Sharma, in the

"A copy of the present order be sent to the Chief Secretary, GNCTD for necessary information and to take appropriate measures in this regard," it ordered.

The court was dealing with a petition by the girl's father who sought production of his daughter who was missing since July

The girl, who appeared in the court, claimed that the petitioner is not her biological father but the second husband of her mother, and that she was now living together with her "husband" after the marriage

The court observed that since the mar-

riage was solemnised on the basis of false

affidavits by both the parties with respect to the uncle's marital status, it has no standing in the eyes of the law. "It is unfortunate that Mr. S., (the uncle) has abandoned his wife/child and

claims to have got married to a girl who is This court holds that the alleged marriage ceremony which has been conducted by the Arya Samaj Mandir, on the face of it, is a void marriage as Mr. S has declared in the affidavit submitted for the marriage, that he is unmarried, when clearly his wife, Ms. K, is alive and they

also have a son," the court stated.

Since the girl is a major and has refused to accompany the petitioner, the court said no further orders can be passed. It, however, clarified that the wife of the uncle was free to proceed with her criminal complaint and take action against him as per law. Police, it said, can also investigate the matter in accordance with law
