Asked about the NC-Congress alliance and the announcement of a "friendly contest" on five seats between the alliance partners in J-K, Abdullah said those five seats were difficult for both the parties to leave for the alliance.

"Three seats are those which were difficult for us to leave and two seats are those which were difficult for Congress to take a decision on. So, we decided that both the parties will field their candidates on those five," he said.

The NC leader also said the alliance faced another problem during the negotiations as the CPI(M) wanted to fielded a candidate from Devsar constituen-

"We would have had problems in Kulgam (which the alliance has allotted to CPI(M)'s M Y Tarigami) and we thought we have to fight a friendly contest there as well. But, Farooq Abdullah talked to Tarigami and requested him that there shouldn't be any candidate from Devsar and he has accepted. So, we have left Kulgam seat for Tarigami," he added.

Asked if there was any issue between the alliance partners over the NC's manifesto, Abdullah said there was none.

"None whatsoever. Let me be categorical, at no point in time did the Congress party raise any objections to our manifesto," he said.

In the initial stages of the discussions, at the local level, the Congress had asked whether they should have a common minimum programme, he said.

"We told them very clearly that a CMP (common minimum programme) is always arrived at after you receive a verdict from the people, after you win election and, therefore, obviously we are fighting this election to win. If the NC and the Congress receive the support of the people, then we will form a CMP for the governance for next five years," Abdullah said.

He said the NC has neither discussed its manifesto with the Congress nor has it asked its alliance partner what they are going to include in their mani-

To a question about the BJP's criticism of the NC's manifesto, Abdullah said the BJP is expected to say such things.

"Do you think the BJP will put its stamp on our manifesto? The BJP should

### SC directs states...

have not vet filed their responses

The bench noted that states and UTs like Delhi, Himachal Pradesh, Madhya Pradesh and Punjab have not yet submitted the qualitative/quantitative charts despite circulation of a questionnaire seeking information in respect of the status and functioning of open correctional institutions and whether such institutions exist within their jurisdiction.

"We, therefore, direct that all the States/Union Territories, which have not yet filed their response, to file a complete response within a period of four weeks from today," the bench said in its order passed on August 20.

It said the states and UTs, which have not given complete information, shall also ensure compliance within four weeks.

"We further clarify that if any of the state governments or Union Territories do not respond in terms of the orders passed by this court, we will be compelled to direct the presence of the chief secretary of the states/Union Territories concerned before this court," the bench said and posted the matter for further consideration after four weeks.

The apex court noted that on July 15, it had directed the chief secretaries of

various states and UTs to submit their responses on the issue of open jails. The amicus told the bench that states and UTs of Gujarat, Haryana, Jammu and Kashmir, Maharashtra, Manipur, Nagaland, Telangana, Uttar Pradesh, Dadra and Nagar Haveli, Daman and Diu, Lakshadweep, Puducherry and Ladakh, have not filed their responses vet.

While hearing the matter on May 9, the apex court had observed that estabishing open jails can be one of the solutions to overcrowding and also addressng the issue of rehabilitation of prisoners.

In its May 17 order, the bench had noted the submission of the amicus that a model draft manual has been prepared by the Union of India where the nomenclature 'open correctional institutions' is used for such facilities

"This means that in no case grievance shall be closed by stating 'Does not pertain to this Ministry/Department/ Office' or its equivalent language Efforts shall be made to transfer the same to the right authority if the subject of the grievance does not pertain to the receiving Ministry," said the order issued by the Department of Administrative Reforms and Public Grievances (DARPG). In the ministries/departments where a large number of public grievances are received, it is advised to appoint a dedicated nodal officer with independent charge on sufficient rank so as to ensure timely and qualitative disposal of public grievances, it said.

The order mentioning revised guidelines was issued following the directions of Prime Minister Narendra Modi given during his interaction with the secretaries to the government of India on June 29.

Following the directives, DARPG undertook a review of existing processes to make Centralised Public Grievance Redress and Monitoring System or CPGRAMS -- an online portal that allows people to raise complaints against government departments -- "more sensitive, accessible and meaningful to the

"The 10 steps reforms initiated in CPGRAMS have significantly brought down the average resolution time. Keeping this in view, the maximum redressal time advised by DARPG for cases in CPGRAMS is further reduced to 21 days," said the order dated August 23, 2024.

In cases, where the redressal requires longer time, an interim reply may be given stating the reason for the same and expected timeline when the grievance could be resolved, it said.

"The focus of the guidelines has been to reduce timelines of grievance redres sal to 21 days and improve quality of grievance redressal by adopting technology improvements like integration of grievance portals, root cause analysis using AI enabled dashboards and assessment matrix like the Grievance Redressal Assessment Index," said V Srinivas, Secretary, DARPG.

He said capacity building of grievance redressal officers is envisaged through the state administrative training institutions.

Srinivas, a 1989-batch Indian Administrative Service (IAS) officer of Rajasthan cadre, said the policy guidelines were formulated after detailed consultations with Ministries/Departments, States/UT governments, knowledge partners and state administrative training institutes

"The policy guidelines also empower citizens by providing an escalatory appeal mechanism," he told PTI. Appeal workflow in CPGRAMS presently requires appointment of an officer of the Additional /Joint Secretary rank as the Nodal Appellate Authority (NAA).
