Notorious chain-snatcher wanted in 55 cases held from Thane district

Three more accused held in Amritsar NRI shooting case

THANE: Crime Branch officials arrested a notorious criminal out on bail from Thane district against whom a staggering 55 cases of chain snatching had been registered in various cities, a senior police officer said on

Police recovered stolen gold chains collectively valued at Rs 3.13 lakh from the accused, identified as Ghulam Ali alias Nadar Sartaj Jafri (40).

Crime Branch unit V officials from Wagle Estate in Thane city utilised a combination of intelligence and technical inputs to nab Jafri, a resident of Ambivili,

Kalyan, said Assistant Commissioner of Police (Crime) Shekar Bagde.

A senior police inspector said 45 cases of chain snatching had been pending investigation against Jafri at different police stations in Nashik, Pune, Ahmednagar, and Thane districts in Maharashtra and at some locations in Gujarat since 2015.

Jafri, who was out on bail when he was arrested, committed ten chain snatchings, he said.

Jafri operated alone. His modus operandi involved targeting victims on his motorbike and swiftly snatching

Chhattisgarh: 25 Naxalites, including 5 with total bounty of Rs 28 lakh, surrender in Bijapur

BIJAPUR : Twenty-five Naxalites, five of them carrying a cumulative bounty of Rs 28 lakh on their heads, surrendered in Bijapur district in Chhattisgarh on Monday, a senior police official said.

The 25 ultras, who were active in Gangloor and Bhairamgarh area commit- $_{
m the}$ outlawed Communist Party of India (Maoist), include two women, the official added.

"The two women, Shambati Madkam (23) and Jyoti Punem (27), and Mahesh Telam were active in company no. 2 of the Maoists and carried rewards of Rs 8 lakh each on their heads. Madkam was active in the movement since 2012 and was allegedly involved in the 2020 Minpa

Two others who surrendered, Guddu Kakem (20) and Sudru Punem (32), were carrying rewards of Rs 10,000 each on their heads, the official added.

They surrendered citing disappointment with the hollow Maoist ideology and atrocities on tribal by leaders of the outlawed movement, he said, adding those who laid down down arms were provided assistance of Rs 25,000 each and will be further rehabilitated as per the government's policy.

"With this surrender, 170 Naxalites have so far quit violence in the district this year. Besides, 346 Maoists have been arrested in the district during the same period," the SP said.

'Shiv Sena would have secured double-digit tally in LS polls if nominees not replaced in some seats'

MUMBAI: Maharashtra Chief Minister Eknath Shinde on Sunday said Shiv Sena led by him would have won seats in double digits in the Lok Sabha elections had the party candidates not been changed in 3 to 4 constituen-

"If we had not changed our candidates on 3-4 seats, our tally would have been in double digits. We indeed performed well in the Lok Sabha elections," he told a gathering of Shiv Sena workers.

In the maiden Lok Sabha election after the split in undivided Shiv Sena, the party led by Shinde won seven seats out of 15 constituencies it had contested.

The rival Shiv Sena (UBT) won nine constituencies out of 21 it had contested.

Shinde-led Sena replaced candidates in Yavatmal-Washim and Hingoli Lok Sabha seats. Additionally, the announcement of Nashik candidate Hemant Godse was delayed by weeks over the lack of consensus over his name in the constituents of the Shiv Sena-led Mahayuti alliance, comprising BJP and NCP.

However, sources in Shiv Sena claimed though the party was not willing to replace candidates, the party was pressured to do so in the names of some electoral

The poll outcome was not as per our expectations, they said, adding that Shiv Sena lost from some constituencies due to the extreme delay in finalising candidates.

Shinde claimed 80 ex-corporators in Mumbai have joined Shiv Sena, including 50 from rival Shiv Sena

compensation to kin of 2 cousins

killed in 2014 road accident

THANE: The Thane Motor Accident Claims Tribunal (MACT) has awarded a compensation of more than Rs 48 lakh to the families of two cousins who tragically lost their lives in a road accident in December 2014. The victims, Shyam Gopal Farde (40) and Gurunath Govind Farde (26), both residents of Farde Pada in Shahapur, were fatally injured when their scooter was struck by a vehicle in Shelavli village on December 5, 2014. The copy of the order dated August 9 was made available on Monday. MACT Chairman, SB Agrawal, directed the owner of the vehicle and the New India Assurance Company to pay the compensation to the victims' families. The family of Shyam Farde was awarded Rs 32,29,000, while Gurunath Farde's family received Rs. 16,00,000.

Additionally, both families are entitled to interest at the rate of 7.50% per annum from the date of filing the claim. However, the Tribunal clarified that no interest would be applicable to the compensation awarded on account of the future prospects. The MACT chairman rejected the arguments presented by the insurance company, finding them to be "palpably frivolous." The case was decided ex-parte against the vehicle's owner, who failed to appear before the tribunal, while the insurance company, represented by advocate AK Tiwari, contested the claim on multiple grounds. Advocate MA Pendse, representing the petitioners, argued that the accident was a result of negligent driving by the driver of the four-wheeler at an excessively high speed. The MACT chairman held the respondents liable for the accident and ordered them to pay the compensation. He also noted that the insurance company's attempts to evade liability were unfounded and without merit.

BJP disagrees with Kangana Ranaut's remarks on farmers' protests

NEW DELHI: The BJP on Monday expressed disagreement with its MP Kangana Ranaut's controversial remarks on the farmers' protest and said she has been directed to not make such remarks in future.

This came after Ranaut stoked a controversy by suggesting that the farmers' protests could have led to a Bangladesh-like situation in the country if the top leadership was not strong enough.

In a video shared by the Mandi MP on X, she alleged that "bodies were hanging and rapes were taking place" during the farmers' protest against the now-repealed three farm laws. "The statement made by BJP MP Kangana Ranaut in the context of the farmers' movement is not the opinion of the party. The Bharatiya Janata Party expresses its disagreement with the statement made by Kangana Ranaut, the BJP said in a statement.

On behalf of the BJP, Ranaut is neither permitted nor authorized to make statements on the party's policy issues,

"On behalf of the Bharatiya Janata Party, Kangana Ranaut has been directed not to make any such statements in future," the statement said.

"The Bharatiya Janata Party is committed to follow the principles of 'Sabka Saath, Sabka Vikas, Sabka Vishwas and Sabka Prayas' and social harmony," it added.

SHIMLA: The Himachal Pradesh government will allocate Rs 53.21 crore annually to the 'Mukhya Mantri Sukh Shiksha Yojana' aimed at providing financial assistance to widows, destitute women, divorced women and disabled parents to support the education and well-being of their chil-

The Himachal Pradesh cabinet had on Sunday announced the launch of 'Mukhya Mantri Sukh Shiksha Yojana'.

All eligible women, children and individuals with a family income not exceeding Rs 1 lakh per annum are covered under the scheme, a statement quoting Chief Minister Sukhvinder Singh Sukhu on Monday said.

"The state will allocate Rs 53.21 crore annually to fund this initiative," the chief minis-

The scheme is aimed to support two specific age groups. For children under the age of 18, eligible women and disabled parents will get a monthly grant of Rs 1,000 to cover their educational, health and nutritional expenses.

Additionally, children who secure admission to undergraduate, postgraduate, diploma or vocational courses will receive financial aid from the government to bear tuition and hostel

The state government's initiative aims to prevent issues such as child abuse, trafficking, teenage marriages and drug abuse by strengthening child protection at the family level and also addresses the needs of children with disabled parents, recognising the strong link between disability, unemploy-

The chief minister said women who are widowed, deserted or abandoned often face arduous challenges in supporting their children, largely due to a lack of educational and financial resources.

These women are particularly vulnerable, lacking the moral and financial support they need to sustain them and ensure their children's education," he

"It is important to foster a supportive environment for vulnerable families, ensuring that children receive the education and care they need to lead dignified lives," he added.

From day one, the current state government has prioritised giving a voice to the underprivileged sections and has launched numerous initiatives to support them, he said.

CBI names RG Kar Hospital ex-principal Sandip Ghosh in corruption FIR, slaps non-bailable sections

KOLKATA: The Central Bureau of Investigation (CBI) has named Sandip Ghosh, former principal of RG Kar Medical College and Hospital, in the FIR the agency has filed in connection with its probe into the alleged financial irregularities at the institution during his tenure.

The agency has slapped Section 120B of IPC (criminal conspiracy) read with Section 420 IPC (cheating and dishonesty) and Section 7 of Prevention of Corruption Act, 1988 (amended in 2018) which covers unlawful acceptance of gratification by a public servant.

The cases read together account for cognisable offences and are non-bailable in nature, a senior Calcutta High Court lawyer said.

Besides Ghosh, the CBI has also registered cases against one M/s Ma Tara Traders of Madhya Jorehat. Banipur. Howrah, M/s Eshan Cafe of 4/1, H/1, JK Ghosh Road, Belgachhia, Kolkata and one M/s Khama Louha.

The FIR was lodged on the basis of a written complaint lodged by Debal Kumar Ghosh, special secretary to the state health department.

PTI retains a copy of the FIR.

The FIR was lodged on Saturday after the CBI took over the probe from a state-constituted Special

Investigation Team (SIT) following directions of the Calcutta High Court which the West Bengal government had initially formed following the alleged rape and murder of a woman medic on August 9.

The order was issued on a petition by former deputy superintendent of RG Kar Hospital, Akhtar Ali, who requested a probe by the Enforcement Directorate (ED) into alleged financial misconduct at the institution.

Ali had moved the high court after fervent speculations in the public domain on whether the alleged rampant corruption at the institution was in any way connected to the medic's death with possibilities of the victim remaining privy to those and threatening exposure.

Ali had also alleged that his complaints before the state vigilance commission anti-corruption bureau filed a year ago against Ghosh yielded little results and, instead, led to his own transfer from

the institution. In his plea before the high court, Ali accused Ghosh of illegal sale of unclaimed corpses, trafficking of biomedical waste and passing tenders against the commission paid by medicine and medical equipment suppliers.

Ali also alleged that students were pressured to pay amounts ranging between Rs 5 and 8 lakh to pass exams.

Ghosh served as principal of RG Kar Hospital from February September 2023. He was transferred from the medical establishment in October that year but inexplicably returned to that position within a month. He held his position at the hospital till the day the doctor was found mur-

dered. Ghosh, who was removed from his chair at RG Kar Hospital after the crime came to light and reinstated in the same position at the Calcutta National Medical College and Hospital within hours by the Mamata Banerjee government, has subsequently been asked to go on an indefinite leave in the wake of massive resistance from CNMC students and pend-

ing the corruption inquiry. The CBI on Sunday conducted a day-long search operation at Ghosh's Beliaghata residence in Kolkata in connection with the corruption cases.

Ghosh has also been examined by the agency for 10 days at a stretch and it was conducting a polygraph test on him on Monday in connection with the rape and murder probe.

The CBI also summoned the hospital's former superintendent Vashisth and its forensic demonstrator Debasish Som at the agency's Nizam Palace office for questioning in connection with the corruption allegations.
