

The procedure involves injecting a fluorescent dye into the bloodstream, which then circulates through the blood vessels in the retina.

Specialized cameras capture detailed images of the dye as it passes through these vessels, allowing ophthalmologists to identify abnormalities or blockages. This procedure is critical for diagnosing and managing a wide range of retinal conditions, including diabetic retinopathy, age-related macular degeneration, retinal vein occlusion, and
