act of political opportunism, he has accepted his candidature from Ganderbal constituency. This is a blatant betrayal of the people who believed his words," the senior BJP functionary said and added that Omar's actions reveal his desperation to regain political power at any cost.

"His words do not hold value, they do not stay on his tongue. He is trying to manipulate public sentiments for personal gain, and this deceit must be exposed", he said while claiming that the BJP is the party which is committed to ensuring trans-

parency and accountability in the political process and will not allow opportunists like Omar Abdullah to mislead the people of Jammu and Kashmir for their political survival. He said that the unprincipled decision of Omar Abdullah of making a U-turn over his pledge has not only surprised the gullible electorate but it has also upset the NC's dedicated leadership which was expecting a seat from the constituency which the NC Vice President has now 'grabbed in an unprincipled manner' to satiate his hunger for power.

Consequent upon the declaration of NEET UG- 2024 re-revised result by the National Testing Agency (NTA), a tentative Roll No-wise list on the basis of NEET data received by the BOPEE from Department of Health & Family Welfare, Government of India, was notified vide Notification No.68-BOPEE of 2024 dated 09-08-2024 for information of the concerned candidates. Further, the candidates who have appeared in NEET UG-2024 under All India Quota & whose Roll Numbers were not figuring in Annexure-A to the said notification but actually belonged to UT of J&K/Ladakh, and were willing to participate in the counselling process for seats of UT of J&K were advised to submit their documents with the Board for inclusion of their details in the list framed by the Board.

For the purpose of preparation of Provisional Merit List, the Board vide Notification No. 78-BOPEE of 2024 dated 18.08.2024 notified schedule for online registration by the eligible candidates to them to register themselves and upload their documents on the BOPEE website viz. [www.jkbopee.gov.in](http://www.jkbopee.gov.in) for verification/update of their Category status, through the Online mode w.e.f.19.08.2024 to 23.08.2024

These Online Registration Forms and the documents uploaded by the candidates have been scrutinized by the Board and the following have been noticed:

- Some candidates who have made the registration but their application forms are deficient for want of one or more document(s) including Domicile Certificate, D.O.B., 12th Class Marks Card, Compulsory Service Bond for candidates belonging to UT of Ladakh etc., the application forms of such candidates have been provisionally approved and they shall be allowed to participate in the Online/offline Counselling process subject to the condition that they shall submit all the deficient documents along with other relevant documents as required by the Colleges/Institutions at the time of admission, if selected, otherwise, their selection shall be cancelled on their own risk and responsibility.
- All the eligible candidates figuring in the **Annexure-A** to this Notification are advised to check their Gender (Male/Female) and corrections, if any, be communicated to the Board through an application to be submitted by the concerned candidate(s) physically at the BOPEE office Jammu or Srinagar upto 27-08-2024 (upto 3:00 P.M.) positively without any fail.
- The Board has received the list of candidates who have applied under the Sports Category from Secretary, J&K Sports Council, Srinagar/Jammu vide Notification No. SC/491-NEET UG/4848-49 dated 12.08.2024 and accordingly the Board has prepared rank-wise list of such candidates which is annexed as **Annexure-B** to this Notification. However, mere figuring of the name of the candidate(s) in the sports list does not confer any right on the candidate(s) to claim the seat under the sports category. The sports ranking is only for determining the eligibility under the sports category and not for determination of merit of the candidates. The merit of the candidates shall be determined on the basis of 60% NEET merit plus 40% sports merit (60:40 as per Govt. Order no. 808-GAD of 2008 dated 17-06-2008 and as amended from time to time.
- The candidates who have filled CDP Category but have uploaded old certificate are provisionally included in the PML and have been allowed to participate in the online/offline counselling process subject to the condition that they shall submit fresh CDP Certificate with Priority as per the prescribed format issued by the competent authority on or before 23-08-2024, physically at BOPEE Office Jammu or Srinagar by or before 27-08-2024 failing which they shall be considered under Open Merit, if otherwise, found eligible under Open category.
- The candidates whose Reserved Category Certificate(s) is deficient shall submit a valid Category Certificate issued by the competent authority on or before 23-08-2024 physically at the BOPEE office Jammu/ Srinagar upto 27-08-2024 (03.00 P.M) failing which they shall be considered under Open merit by the Board without any further notice, if otherwise, found eligible under Open merit.
- The candidates, who have uploaded EWS Certificate as per the Central Format but not as per SRO 518 of 2019, the Board has included their names provisionally in the Provisional Merit List subject to the condition that they shall submit their valid EWS Category Certificate issued by the competent authority on or before 23-08-2024 physically upto 27-08-2024(03:00 P.M.), positively otherwise their candidature shall be automatically converted into Open category without any further notice.
- No document(s) shall be accepted through E-mail / WhatsApp.
- The candidates, who have uploaded PwD Certificates on their own, the Board has included their names provisionally in the Provisional Merit Lists and they shall be allotted the seats on the basis of their PwD Certificate, subject to the condition that the genuineness of their PwD certificate shall be ascertained (wherever required) by the respective College Authority as per MCI/ NMC/DCI guidelines/J&K Reservation Act/rules with benchmark disabilities vide Govt. Order 59-JK(SWD) of 2021 dated 15-04-2021 at the time of admission, if provisionally selected. In case any candidate is found ineligible under this category at any later stage, the admission of such candidate(s) shall be cancelled ab-initio.

In light of the above, the Provisional UT Merit List (PML) of the candidates, who have registered themselves with the Board through the online mode and have uploaded all the requisite documents/Category certificates upto the prescribed date is hereby notified as **Annexure-A** to this Notification. Further the list of candidates falling under sports category is notified as **Annexure-B** to this Notification.

It is further notified that any candidate who is desirous of making a representation, with regard to the position assigned to him/her in the PML annexed as in Annexure- A & B to this Notification, may do so up to 27-08-2024 (till 03:00 P.M.) and the Board shall dispose off the same under rules. No representation(s) / objection(s) shall be accepted after the last date i.e. 27-08-2024 (upto 3:00 P.M). In case no representation is received by the Board in this regard, the PML shall be deemed as final.
