

## 244 nominations found valid during scrutiny, 35 rejected

JAMMU: In accordance with the election schedule issued by Election Commission of India (ECI) for the conduct of Jammu and Kashmir Assembly Elections 2024, the scrutiny of nomination papers for 24 Assembly Constituencies which are going to polling in phase 1st was held on Wednesday, in the office of the respective Returning Officers across some districts

During the scrutiny of the nomination papers filed by 279 candidates, candidature of 244 candidates was found valid as per the guidelines of the Election Commission of India, while nomination papers of 35 candidates, which were found invalid, were rejected

A statement from the office of the Chief Electoral Officer detailed the scrutiny process held today.

Nomination papers of 67 candidates were found valid in Anantnag district, followed by 46 in Pulwama district, 34 in Doda district, 29 in Kishtwar district, 26 in Kulgam district, 21 in Shopian district, while

## Permissions for political parties, candidates simplified

JAMMU: In the spirit of facilitating smooth and transparent elections, the Office of Chief Electoral Officer J&K has issued a detailed communication to all concerned stakeholders on the flow of various permissions that would be required during the course of ongoing General Elections to Legislative Assembly UT of Jammu and Kashmir.

The permissions placed at the level of CEO Office include vehicle Permission for transport of campaigning material by political parties across UT, vehicle permission for star campaigners and party office bearers across districts/ UT and permissions for video Vans across districts at UT level.

Similarly the permissions placed at the level of District Election Officer include- Application for Air Balloons. Construction of Rostrums/ Barricades, Permit to take out procession with loud speaker, application for setting up of Temporary Party office, Application for rally, application for door to door canvassing, Application for permission of Video Van(within district), Vehicle permission for District Level office bearer of Political Party (within District), permission for helicopter and helipads and application for Load Carrier for transport of publicity material by political parties (within district).

The majority of permissions have been placed at the disposal of Returning Officers. These include permit for street corner meeting with Loud speaker, permission to hold meeting without loudspeaker, one vehicle for complete AC for the candidate, one vehicle for a complete AC area for the election agent of the candidate, one vehicle per AC for the party/ party

Similarly, in Pulwama district, nomination papers of 14 candidates were accepted in 32-Pampore AC; 10 candidates in 33-Tral AC; 12 candidates in 34-Pulwama AC; and 10 candidates in 35-Rajpora AC.

In Shopian district, a total of 10 nomination papers were found valid and accepted in 36-Zainapora AC; while nomination papers of 11 candidates have been accepted in 37-Shopian AC.

NEW DELHI: Prime Minister Narendra Modi on Wednesday chaired a meeting of the entire Council of Ministers where issues affecting women and timely delivery of various policy measures figured prominently, sources said.

The five-hour meeting, held at the Sushma Swaraj Bhawan here, also took stock of the progress made on the first 100 days agenda of the third term of the BJP-led NDA government.

Measures for the four castes -- women, poor, youth and farmers -- were stressed during the meeting that was also attended by secretaries of various government departments.

A key thrust of the meeting was on spreading awareness about new schemes and policy decisions made since the gov-

ernment assumed office in June, including the new infrastructure projects.

Initiatives taken by the government for the social sector also figured prominently in the meeting.

#### 'Nod for e-auction of 730 FM channels in 234 cities'

NEW DELHI: Seeking to expand the reach of FM radio, the government on Wednesday approved a proposal to hold a third batch of ascending e-auctions for 730 channels in 234 new cities with an estimated reserve price of Rs 784.87 crore under Private FM Radio Phase III Policy.

The Union Cabinet, at a meeting chaired by Prime Minister Narendra Modi, also approved a proposal to charge an annual license fee (ALF) of FM channel as four per cent of gross revenue excluding GST.

"The Cabinet decision on the rollout of Private FM Radio to 234 cities and towns will enhance access to diverse and local content, thus encouraging creativity and encouraging local languages as well as cultures," Prime Minister Modi said in a post on X. Union Information

The poll authority has also approved relieving of SSP Srinagar Ashish Mishra, an IPS officer who was transferred from Jammu and Kashmir to Delhi Police in June 2023 but could not be relieved due to administrative reasons.

The Commission has directed the Union territory administration to provide a panel of IPS officers for the post of SP/SSP Srinagar, Baramulla, Handwara and Kupwara by Thursday evening.

The EC has also cleared the appointment of IPS officer Nalin Prabhat as DG (Operations and Security) of J-K Police till September 30. He is currently on intercadre deputation and posted as Special DG, J-K till September 30.

It also gave its nod to the extension of inter-cadre deputation tenure of IAS officer Syeed Fakhruddin Hamid, the deputy commissioner of Anantnag, for a period of two years. He had completed his tenure on July 8 this year.

## 'Enough is enough': Prez Murmu asks nation to wake up, end crimes against women

NEW DELHI: Declaring that "enough is enough", President Droupadi Murmu on Wednesday said it is time for India to wake up to the "perversion" of crimes against women and counter the mindset that sees women as "less powerful, less capable, less intelligent".

"Those who share such views then go further and see the female as an object... We owe it to our daughters to remove the hurdles from their path of winning the freedom from fear," Murmu said in an exclusive signed article for PTI.

Referring to the August 9 rape and murder of a junior doctor in a Kolkata hospital, a "dismayed and horrified" president said what is even



more depressing is that it is part of a series of crimes against women.

against women.

Murmu said no civilised society can allow daughters and sisters to be subjected to such atrocities. "The nation is bound to be outraged, and so am I," she wrote.

The hard-hitting and per-

sonalised article, titled "Women's Safety: Enough is Enough", is the first time the president has articulated her views on the August 9 Kolkata incident that has once again shaken the conscience of the nation and led to widespread,

#### Asks media to be fearless, stand with truth

NEW DELHI: President Droupadi Murmu on Wednesday asked the media to do fearless reporting and stand with the truth as she saw the fourth estate playing a big role in shaping the country and society.

The president, who met PTI editors at Rashtrapati Bhavan on the occasion of the 77th anniversary of the founding of the news agency, said everyone has a responsibility in taking the country forward and it was important how the country is presented.

"Media ko nirbhikta se kam karna chaiye (media should

work fearlessly)," she commented. "Kabhi satya se hatna nahi chaiye (It should never deviate from the truth)."

Murmu has also penned an exclusive article for PTI on the

recent incidents of sexual and physical assaults on women, which have led to widespread agitations.

"You are a journalist but you are also a citizen. I too am a

citizen. What you are concerned about, I am equally concerned about," she remarked on writing the article.

"The media can play a crucial role in improving the country

and society," the president said.

RAMBAN/JAMMU: The body of a six-year-old girl was recovered in a village in Jammu and Kashmir's Ramban district on Wednesday, taking the death toll in the incident to three, even as the search operation to locate the remaining four people continues, officials said.

The cloudburst occurred in Panchayats Kumate, Dhraman and Halla in Rajgarh tehsil late Monday afternoon, causing flash floods in Tanger and Dadi streams, they said.

Seven people of three different families were reported missing in the flash floods, Tehsildar Rajgarh Major Singh told PTI.

Shazia Banoo's body was

recovered by rescuers three

kilometres downstream from her Dungar Dhandla village on Wednesday afternoon, the officials said.

Earlier, the bodies of two persons -- Yasir Ahmad (20) of Gadgram and Khalid Ahmed Parihar (12) of Suli-Kumate -- were retrieved on Monday and Tuesday.

Tehsildar Singh, who is supervising the rescue operation, said the rescue teams comprising police, State Disaster Response Force (SDRF) and local volunteers, are making all out efforts to locate four other missing persons -- Yasir's mother Naseema Begum (42) and six-year-old sister Shazia Banoo and Khalid's mother Gulshan Begum (42) and eight-year-old sister Seerat Banoo.
