BJP workers clash with police while trying to enforce West Bengal shutdown, many leaders held

KOLKATA: BJP workers clashed with the police at several places across West Bengal on Wednesday as they tried to enforce a 12-hour shutdown, which had a mixed impact in the state.

Several BJP leaders, including former MPs Roopa Ganguly and Locket Chatterjee, Rajya Sabha MP Samik Bhattacharya and MLA Agnimitra Paul, were detained for blocking roads since the morning.

The 'Bangla Bandh', which began at 6 am, was called by the BJP in protest against Tuesday's police action on participants of 'Nabanna Abhijan' or march to the secretariat, organised by the newly formed students' group Chitra Samaj over the rape and murder of the doctor at RG Kar hospital.

The shutdown partially affected daily life in the state with many people choosing to remain indoors apprehending trouble on the roads.

In state capital Kolkata, the usual weekday flurry was missing with a smaller number of buses, auto-rickshaws and taxis plying. Private vehicles were also significantly less, even as markets and shops remained open.

Schools and colleges were



open, though the number of students was fewer. Many English-medium schools in Kolkata suspended classes.

In many private offices, attendance was low with employees asked to work from home. However, attendance was as usual in government offices. Several BJP leaders were detained across the state for attempting to enforce the shutdown.

Ganguly and Paul were detained from south Kolkata's Gariahat area when they were urging traders to down their shutters and requesting people to support the bandh.

Chatterjee was detained from Shyanbazar when she was leading a demonstration, while Bhattacharya was detained from Wipro More in Salt Lake Sector 5.

Kolkata's Ward 50 councillor Sajal Ghosh was detained from his residence in Sealdah

BJP headquarters along with his supporters. He had heated arguments with senior police officers who swung into action to clear the arterial road.

At Alipurduar, BJP MP Manoj Tigga was arrested for allegedly enforcing the bandh.

An official of the Eastern Railway said bandh supporters blocked tracks at 49 places under its jurisdiction in the state.

While the blockades were lifted at most places, it was continuing in nine stations, mostly in the Sealdah South section, he said.

BJP workers demonstrated at the Bongaon station in North 24 Parganas, Gocharan station in South 24 Parganas, and the Murshidabad station in support of the bandh. Tension was palpable at the Barrackpore station in North 24 Parganas as BJP supporters and TMC workers came face to face.

At Bhatpara in North 24 Parganas district, BJP alleged that two of its workers were shot at.

Police, however, claimed that the two men were beaten up by some people outside Anglo India Jute Mill.

The injured persons were initially taken to the Bhatpara State General

Hospital, but were later shifted to a hospital in Kolkata for better treatment, they said.

Former BJP MP Arjun Singh and Jagaddal's TMC MLA Somnath Shyam along with their supporters reached the area after the incident, triggering tensions. Police intervened and brought the situation under control.

"Miscreants owing allegiance to the Trinamool Congress fired the shots, if police are not around we will show TMC the people's power," Singh said.

Shyam countered by saying that the BJP leader was trying to incite violence in the area.

Picketing by BJP supporters on the roads led to the disruption of public transport services in Cooch Behar, Alipurduar, Siliguri and Malda in northern West Bengal, and in Purulia, Bankura and some other places in the southern part of the state.

Leader of the Opposition Suvendu Adhikari led a protest march in Nandigram in Purba Medinipur, his home district.

In Malda, activists of the TMC and BJP engaged in a brawl over the blocking of a road. Police intervened to disperse the two groups.

Criminals do not fear police in Maharashtra under Fadnavis: Anil Deshmukh

MUMBAI: Senior NCP (SP) leader Anil Deshmukh on Wednesday alleged that the law and order situation has worsened in Maharashtra under the watch of home minister Devendra Fadnavis, claiming that criminals do not fear the police anymore.

Deshmukh's comments came amid outrage over the alleged sexual assault of two four-year-old girls at a school in Badlapur and an attack on a police officer in Pune with a sickle. "Under Home Minister Devendra Fadnavis, there is no fear of police in the state. Police are being beaten up openly. There needs to be fear of police among criminals," Deshmukh told PTI Video in an interview. The former state home minister demanded that the Centre approve the Maharashtra government's Shakti Law, which prescribes the death penalty for heinous crimes against women, at the earliest. Had this law been in place, crime against women would not have taken place, he claimed.

"They (BJP) have a government at the Centre. The Shakti law has been pending approval



(Presidential assent) for the past three years. The law prescribes the strictest punishment, including death penalty, for perpetrators of crimes such as rape. The government, however, doesn't seem to be serious on women's issues at all," Deshmukh alleged.

Both the House of Maharashtra legislature had passed the Shakti Criminal Laws (Maharashtra Amendment) Bill, 2020, and the Special Court & Machinery for Implementation of Maharashtra Shakti Criminal Law, 2020, three years ago when the Maha Vikas Aghadi (MVA) was in power. The former state home minister alleged the state government was using the flagship Mukhyamantri Mazi Ladki Bahin Yojana, which provides a

monthly stipend of Rs 1,500 to eligible women, for political mileage to win the upcoming assembly elections, predicting that the scheme would be discontinued. If the Maha Vikas Aghadi (MVA) coalition is voted to power, they would continue this scheme, he said.

Deshmukh, who served as home minister when the MVA government was in power, had last month alleged he was pressured by the then opposition leader Devendra Fadnavis to prepare an affidavit implicating the then CM Uddhav Thackeray, deputy CM Ajit Pawar, and ministers Aaditya Thackeray and Anil Parab.

He had blamed Fadnavis for his arrest on charges of corruption and money laundering in the past. Deshmukh is currently out on bail.

Centre to provide Rs 4,136 cr for 15 GW hydropower projects in northeast region

NEW DELHI: The Union Cabinet on Wednesday approved equity support of Rs 4,136 crore to northeast states for developing hydropower projects, totalling 15,000 MW capacity over the next eight years.

The Cabinet, chaired by Prime Minister Narendra Modi, has approved the proposal of the Ministry of Power for providing central financial assistance (CFA) to the state governments of NER (North East Region) towards their equity participation in the development of hydroelectric projects through Joint Venture (JV) collaboration between state entities and Central Public Sector Undertakings, an official

statement said.

This scheme has an outlay of Rs 4,136 crore to be implemented from 2024-25 to 2031-32, Information and Broadcasting Minister Ashwini Vaishnav said in a briefing on the Cabinet decisions.

A cumulative hydro capacity of about 15,000 MW would be supported under the scheme, the statement said.

The scheme will be funded through 10 per cent gross budgetary support (GBS) for the northeastern region from the total outlay of the Ministry of Power.

The grant towards the equity portion of the state government of NER would be capped at 24 per cent of the total project equity, subject to a maximum of Rs 750 crore per project. The

cap of Rs 750 crore for each project would be revisited, if required, on a case-to-case basis.

The equity ratio of the CPSU and state government in the JV will be maintained at the time of disbursing of the grant.

Central financial assistance would be limited to only viable hydroelectric projects. States would be required to waive or stagger free power and reimburse SGGST to make the project viable.

With the introduction of this scheme, participation of state governments in hydro development will be encouraged and risk and responsibilities will be shared in a more equitable manner, the statement said.

5 sugar mills linked to leaders of ruling parties to get Rs 487 cr funds from Maharashtra govt

MUMBAI: The Maharashtra cooperation department has dropped from its list of margin fund beneficiaries five cooperative sugar mills associated with the opposition leaders and added in their place those linked to the politicians of the ruling BJP and NCP for an award of Rs 487 crore funds.

This decision was made during a cabinet meeting held soon after the Lok Sabha election results.

The ruling alliance of Shiv Sena, BJP and NCP managed to win only 17 Lok Sabha seats in Maharashtra out of the total 48, while the opposition Maha Vikas Aghadi (MVA) performed better by bagging 31 seats.

The government revised the list by removing the names of the sugar mills controlled by opposition leaders who did not support the ruling alliance during the elections, and replaced them with five other units which have association with the Mahayuti.

The new additions in the list are: Shetkari Sahakari Sakhar Karkhana in Ausa tehsil of Latur district, Vishwasrao Naik Cooperative Sugar Mill in Sangli district, Padmabhushan Krantiveer Dr Nagnath Nayakawadi Hutatma Kisan Ahir Cooperative Sugar Mill in Sangli, Ashok Cooperative Sugar Mill in Shirampur tehsil of Ahmednagar dis-



trict and Shri Vitthal Cooperative Sugar Mill in Pandharpur tehsil of Solapur district.

The margin money funds will be disbursed by the National Cooperative Development Corporation (NCDC) through the Maharashtra government.

Ahead of the Lok Sabha elections, the state government offered its guarantee to several cooperative sugar mills to make margin funds worth Rs 2,265 crore available. Some of these sugar mills were controlled by the MLAs and leaders belonging to the opposition parties. The opposition parties criticised the decision, calling it an attempt to lure their leaders into aligning with the ruling dispensation.

As per the revised list, Latur-based sugar mill controlled by BJP MLA Abhimanyu Pawar is expected to receive Rs 18.84 crore, while a mill in Sangli, con-

trolled by Deputy Chief Minister and senior BJP leader Devendra Fadnavis, is set to receive Rs 121 crore. The support received by the state government indicates that Vaibhav Nayakawadi, who controls a mill in Sangli, may choose to support the BJP or the Ajit Pawar-led NCP.

Abhijeet Patil, who already controls four sugar mills, recently gained control of the Shri Vitthal Cooperative Sugar Mill in Pandharpur tehsil of Solapur district and has shown political ambitions. He plans to contest from the Pandharpur assembly constituency, but it's unclear whether he will run on the BJP or NCP ticket. His mill will receive Rs 219 crore, the highest among the five sugar mills. The Vishwasrao Naik Cooperative Sugar Mill in Walva tehsil of Sangli is controlled by Shirala MLA Mansing Naik, who has been close to

NCP (SP) state president Jayant Patil.

However, in recent years, Naik has maintained a low profile and distanced himself from Patil.

According to political observers, "Naik must have given clear signals of his allegiance with the NDA and earned Rs 53 crore in the form of margin amount."

The case of Ashok Cooperative Sugar Mill case from Shirampur tehsil is more interesting. Although the mill is in Shirampur, most of the sugarcane cultivators attached to it are from the neighbouring Nevasa assembly constituency. According to the government order, the mill will receive Rs 75 crore.

Former cabinet minister and MLA Shankarrao Gadakh currently represents it and has already declared their association with Shiv Sena (UBT).

Sources close to Bhanudas Murkute, former MLA and chairman of Ashok cooperative sugar mill, said, "Murkute buys sugarcane from farmers in Nevasa, which is a very effective tool to influence the voters. Having control over a sugar mill is considered to be more powerful than winning the assembly election. There is a chance of the Mahayuti government offering Murkute margin amount and in return, expecting his support to the NDA candidate against Gadakh."
