exercise, the number of Assembly seats has gone up from 83 to 90, excludng those allocated to Pakistan-occupied Kashmir.

Last December, the Supreme Court directed the poll panel to hold Assembly elections in Jammu and Kashmir by September 30.

In a fresh indication that the Assembly polls in Jammu and Kashmir are mminent, the Election Commission last week asked the Union Territory administration to transfer officers posted in their home districts, an exercise it

holds ahead of conducting elections. The commission has been following a consistent policy that officers directly connected with the conduct of elections in a poll-bound state or Union Territory are not posted in their home districts or places where they have erved for a considerably long period.

It is usual for the poll panel to issue instructions related to transfers of offieers ahead of Lok Sabha and Assembly elections.

In June, it decided to accept applications seeking allotment of 'common symbols' from registered unrecognised parties in the Union Territory.

2014 and July 31, 2024, it witnessed 2,263 terror incidents, in which 944 civilians and security forces lost their lives -- which is a 69 per cent drop in teror incidents and 67 per cent dip in deaths due to them, it said.

During the UPA era, 1,060 security personnel had died in terror attacks while under the BJP government, there has been a 44 per cent decrease with 591 deaths, the data said.

Bringing improvement in the security and quality of life of people in Jammu and Kashmir is the top priority of the government, officials said and added that the government has taken a number of steps for the demolition of the terror ecosystem -- de-radicalisation efforts, crackdown on terror finance by seizure, attachment freezing of assets and banning of anti-national organisa-

The officials said multi-pronged strategy to prevent infiltration, multi-layered deployment, fencing, technology, monitoring of UAPA Cases through qualitative disposal efforts, and enhancement of counter-insurgency grid by giving importance to Jammu and Kashmir Police in all operations has bore fruits in cracking down on the terror apparatus in J&K.

The entire terror eco-system is now targeted by the security agencies with a special focus on modernisation and strengthening of security equipment, they said.

The s rnment has acted to restrict terror glorification, implemented curl on public funerals, removed terror supporters from government jobs, taken action against alleged terrorists in the bar council and barred terrorist supporters from government contracts, they said.

The crackdown on terror has resulted in a "marked improvement" in the lives of citizens with functional schools, a surge in tourists to a record (2.11 crore) figure and an increase in income generation for people, they said.

The steps by the government have enabled a successful G-20 tourism group meeting in Srinagar, 4.5 lakh pilgrims successfully undertaking the Amaranth Yatra in 2023 and after 34 years, the Muharram procession was allowed on the traditional route in Srinagar where nearly 40,000 people took part, they said. Elections in all the five parliamentary constituencies in J&K were also held peacefully with record voting, they said.

In a video posted on social media early Tuesday, Nahid Islam, one of the key coordinators of the movement, proposed Nobel laureate Mohammad Yunus as the head of interim government. He said they have already talked with 84-year-old Yunus, who has agreed to

take the responsibility to save Bangladesh.

"No government other than the one proposed by the students will be accepted. As we have said, no military government, or one backed by the military, or a government of fascists, will be accepted," said Nahid, flanked by two other coordinators.

Yunus is currently out of the country but welcomed the ouster of Hasina's

regime, describing the development as the "second liberation" of the country He won the Nobel Peace Prize in 2006 for his anti-poverty campaign through the Grameen Bank, a mode; which was replicated across continents.

He has agreed to lead the interim government as its chief adviser, the Daily Star reported, citing a source.

"If the students can sacrifice so much, if the people of the country can sacrifice so much, then I also have some responsibility. Then I told the students that I can take the responsibility," Yunus said.

He had been in a protracted row with Hasina's government due to obscure reasons while authorities initiated a series of investigations against him after she came to power in 2008. He was charged under dozens of cases. In January Yunus was sentenced to six months in jail by a court on charges of labour law

Meanwhile, the death toll in the anti-government protests on Tuesday climbed to 440, with 100 more deaths reported after Hasina's departure, according to local media, even as efforts were on by the army to bring the situation under control in the violence-hit nation.

Despite the high death toll, there were signs of a return to normalcy on Tuesday, with police and army patrolling the streets, BDNews24.com news portal said.

The situation in Dhaka was largely calm on Tuesday after a day of unrest and a night of tension. Buses and other public transport were on the streets and traders were opening shops. Government vehicles were heading to offices Many battery-run rickshaws plied the roads, it added.

The bench also clarified its earlier order directing the Bihar government to ensure that no further illegal construction or unauthorised encroachment takes place adjacent to the river Ganga, particularly in and around Patna City.

The top court was hearing a plea filed by Patna resident Ashok Kumar Sinha against a June 30, 2020 order of NGT dismissing his plea against illegal con structions and permanent encroachments on the eco-fragile floodplains.

The plea contended that the tribunal passed the order without examining the detailed particulars of the violators encroaching upon the Ganga floodplains in Patna submitted by the appellant. "The illegal and unauthorized constructions and permanent encroachments on the floodplain of Ganga are creating tremendous amounts of waste, noise and generating vast quantum of sewage

The plea stated that the tribunal failed to note the fact that a clean Ganga iver was vital and essential to meet the drinking and domestic water needs of 5.5 lakh population of the city as the groundwater in the district was contaminated with Arsenic. "A massive 520 acres of ecologically sensitive Ganga floodplain, stretching from Nauzer Ghat to Nurpur Ghat, in Patna, have been usurped. This stretch is prone to recurrent floods every year.

Drug menace in Kashmir, Married couple spends around Rs 1 crore on drugs Sell ornaments, land, and other belongings to purchase drugs

SRINAGAR: As the younger generation in Kashmir valley suffers from menace of drugs and the administration is trying to control it by destroying the ecosystem of drug mafias and police is seizing the properties of drug peddlers and handlers ,the situation is still not as encouraging as it should be.

There are many stories that are shocking for the society but the most shock ng story is from south Kashmir where there is amarried couple who spent nearly one crore rupees on drug addiction, but they are now seeking to overcome their dependence and are undergoing treatment.

Initially, the man was a drug addict, and later his wife became involved due to his influence.

Sameer (name changed) recounted that he started as a smoker but later pefriended a drug addict, which led him into addiction.

"Once I became fully involved, I started selling my belongings to purchase drugs. At the same time, I got married," he said.

"At first, I hid my addiction from my wife, but eventually, she found out and began asking me about it. I used to tell her that it was just a medicine that kept me tension-free.'

Sameer said his wife unknowingly began using the same drug to alleviate her own stress, and soon both were deeply entrenched in addiction.

His wife Sumaiya (name changed), said, "Once I got fully involved, I sold verything, including my ornaments, land, and other belongings, just to manige my drug use.

She added, "I would sell things, and my husband would manage drugs for oth of us.

After exhausting their resources and spending around Rs 80 lakh to one grore on addiction, they began to regain clarity after being counselled by their parents and relatives. This made them visit an Addiction Treatment Facility ATF) for help

Both expressed initial scepticism about their ability to overcome their addiction, but with proper guidance, counselling and treatment at the ATF, they have successfully begun to recover.

A doctor at ATF treating the couple told that while the woman has almost fully recovered and is under observation, the man is still undergoing treatment out is adhering to it rigorously.

He said anyone can break free from addiction with the right treatment and support from family and society. "Many individuals do not seek treatment due to social stigma," the doctor said. He urged society to eliminate these stigmas and support those in need.

12 operation of medical store suspended for unethical practices

ANANTNAG: The Drug Control Officer Anantnag has closed down the operation of a medical store at Sirhama Bijbehara till further orders for violating the conditions of licenses and for overwriting the prescription of a medical officer PHC Sirhama.

On receiving complaint from PHC Sirhama regarding the unethical practices by Rather medicate Sirhama, Drug Control authority Anantnag acted promptly and raided the medical store of Naseer Ahmad Rather at opp PHC Sirhama. During investigation and after checking the CCTV surveillance system of the medical store, it has been established that the licensee has violated the prescription norms. Records of various medicines which are prone to addiction and those which have been prescribed/injected unethically to the patient have been demanded for further course of action under Law. The Drug Control officer also inspected the Drug Store of PHC Sirhama and requested the health care professionals posted in the facility to share such incidents, if any, with the drug control authority mainly in the interest of patient care.
