The date for onset and withdrawal of south-west monsoon in respect of Jammu and Kashmir (UT) has been notified as 1st July to 15th September respectively. Any violation of the afore mentioned guidelines would invite penal action and penalty as provided under Rules and shall be imposed upon the violators. Further, this is to inform the general public, executing agencies engaged in various developmental works and various Mineral Based Units to refrain from any illegal extraction and transportation of minerals without proper authorization including Form-A. Strict legal action will be taken against those found violating these directions.
