The above said work was allotted to you vide allotment no:- PWD/M/2021-22/2644-46 dated : 06-10-2021 for an amount of Rs. 4.899 Lacs with a completion period of 2 months which is already over long time back. You have been time and again asked to complete the work but unfortunately so far nothing has been done at site inspite of repeated assurances from your side that the work shall be complete soon. This has been viewed very seriously by the higher authorities as this vital link road leads to Ramkund which is an important tourist destination.

The District Development Commissioner Reasi during his tour to Ramkund on 24-07-2024 took a very serious note of the riding surface of the road which has deteriorated over the years there by making the travel on this road very uncomfortable.

Through media of this letter you are once again requested to restart the work within 07 days from issuing of this notice by deploying sufficient men & machinery at site so that the work can be completed within shortest possible time so that the people travelling this road does not suffer anymore on account of bad riding surface. If you are unable to start the work within stipulated time it shall be presumed that you are not interested in the said work and your contract shall be termination under different clauses of SBD and the work shall there after be put to tenders at your risk and cost for which you shall be solely responsible.
