Whereas, the requisite qualification for selection against these posts, as per the Indent, is given as under:

**"Graduate on the basis of test in stenography and type writing with minimum speed of 65 and 25 words per minute respectively"**

Whereas, J&K Services Selection Board, conducted the Type Test and Short Hand Test for these posts for which the result was declared on 19.10.2024 and 25.10.2024, and accordingly, the Written Examination (OMR based) of the successful candidates for the posts of Steno Typist was conducted on 31.12.2024. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/56/2023-03(7245177) dated 02.04.2025 published the Result/Score-sheet of the candidates; and

Whereas, after the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification both at Jammu and Srinagar on 16.04.2025, followed by supplementary Document Verification on 25.04.2025; and

Whereas, the JKSSB, vide Order No.162-SSB of 2025 dated 28.05.2025, a Selection Committee was constituted for preparing the Selection List for 10 posts of Steno Typist, of Health & Medical Education Department; and

Whereas, the said Selection Committee, upon careful scrutiny of the Indents/advertisements, prepared the Provisional Selection List for 10 Posts in accordance with the Merit/ Eligibility and preference of the candidates as per the extant rules and same was placed in the board in its 307<sup>th</sup> meeting, held on 01.07.2025, which after due deliberations and consideration of the matter, approved its notification.

Whereas, the provisional Selection List for the aforesaid 10 posts of Steno Typist was accordingly, notified vide No. JKSSB-Scry/11/2025-06 (E-7704003) dated 02.07.2025, seeking objections from the candidates within a period of 10 days from the date of issuance of the notification; and

Whereas, pursuant to the above, two representations were received in the Board, pertaining broadly to submission of documents w.r.t. withheld case, correction in particulars etc., which were examined as per the available record/ extant guidelines, for necessary action; and

Whereas, the proposal for notifying the Final Selection List, for the aforesaid 10 post of Steno Typist of Health & Medical Education Department advertised vide Notification No. 02 of 2021 dated 26.03.2021, as prepared by the concerned Selection Committee, was placed in the Board in its 310<sup>th</sup> meeting held on 24.07.2025, which after due deliberation on various aspects related to the instant selection, approved its notification.
