SHOW CAUSE NOTICE Whereas, the registration of an Association/Body of individual citizens of India as a political party is governed by the provisions of Section 29A of the

Representation of the People Act, 1951; and Whereas, the purpose of registration of an association as a political party with the Election Commission under the aforesaid Section 29A is stated in tha Section itself, i.e. to avail of the provisions of that part for the purposes of the Representation of the People Act, 1951, which inter alia means participatio n elections conducted by the Commission under the said Act; and

Whereas, "Social Movement Party" was registered as a political party under the said Section 29A, on an application made by the party under the said Section: and

Whereas, the current address of the said Political Party is not known; and

Whereas, as per the records of the Commission, the said party did not set up any candidate at any of the elections held, either to the House of the People or to any State Legislative Assembly or bye-elections for the last 06 years since 2019; and

Whereas, in view of the above, it is self-evident that the said party has ceased to function as a political party for the purposes of the aforesaid Section 29A

Whereas, in the above circumstances, the Commission, in exercise of its powers under Article 324 of the Constitution of India and Section 29A of the Representation of the People Act, 1951, proposes to delist the Political Party "Social Movement Party" from the list of registered parties and Whereas, before taking action as proposed above, the Commission has decided to provide to the said party an opportunity of representation/showing cause, if any, as to why the proposed action may not be taken;

Now, therefore, the Political Party "Social Movement Party" is called upon to make a written representation to the undersigned in this behalf if it so desires The representation, if any, should be duly accompanied by an affidavit from the President or General Secretary of the party, and all supporting document on which the party proposes to rely, and should reach the undersigned latest by 22nd of August, 2025 It is also stated that the date of hearing for the party has been scheduled on 27th August, at 12:30 PM (Wednesday) in the office of Chief Electoral Officer

Ephemeral Fever

(ATTENTION DAIRY FARMERS)

Ephemeral Fever, also known as three-day sickness, is a viral disease of cattle and buffalo which is transmitted by biting insects and usually persists for 3 days only. The disease is characterized by very high morbidity (80%) but mortality is very low (1%-2%) however mortality rates have exceeded 10% in few reported outbreaks. It causes losses due to reduction in milk yield, recumbency in affected animals and sometimes death also.

Clinical Signs:

Ephemeral Fever is characterized by high fever (104-107° F), inappetence, shivering, serous nasal discharge, drooling, difficult breathing, muscular stiffness/lameness and drop in milk yield in affected animals







Transmission and Spread:

- Most prevalent in the wet season in tropical countries like India.
- Through biting and flying insects like mosquitos.
- . Through animal movement.

To reduce the incidence of this disease in dairy animals and minimize the impact on dairy farmers the following DO's and DONT's are advised:-

- 1. Remove stagnant water from and around dairy farm/shed.
- Proper disposal of manure/slurry in and around sheds.
- 3. Control of fly, mosquitos and other insects using repellents/nets/pour-on or backline rubs.
- Restrict movement of cattle from and to affected herd/area.
- Adopt strict quarantine measures for newly purchased animals.
- 6. Consult local veterinary doctor for symptomatic treatment which mainly consists of NSAIDs and supportive care for recumbent animals.
- Supplementation with immunity booster vitamins and mineral supplements to support recovery.

DONT's

- Allow water to get collected in and around sheds.
- 2. Allow movement of animals freely from and to affected herd/area.
- Introduce newly purchased animals directly into the herd/farm without quarantine.
- Let sick and healthy animals to mix with each other.
- 5. Put to work recovered animal for few days as there are chances of relapse.
