HC allows manual filing of chargesheets in J&K, Ladakh amid ICJS glitches operational across criminal

JAMMU: In a significant order aimed at ensuring smooth functioning of the criminal justice system, the High Court of Jammu & Kashmir and Ladakh has permitted manual acceptance of chargesheets and challans in exceptional cases where technical glitches hinder online filing through the Inter-Operable Criminal Justice System (ICJS). The ICJS application, which is courts in both Union Territories, is the designated platform for electronic filing of chargesheets and challans. However, frequent technical issues have been hampering the process, preventing police from filing challans or courts from retrieving them. To prevent any undue advantage being taken due to such disruptions, the High Court has directed that challans may be filed manually before criminal courts. This. however, will be allowed only after certification from a technical team consisting of the Senior System Officer of the concerned High Court wing and the Nodal Officer of the Police Department, confirming that the case could not be filed online. The order, issued by the Registrar General, will remain in force for three months during which technical teams from the High Court and Police

IGNOU extends last date of admission & re-registration till 31st August, 2025 on surging student demand

JAMMU: Taking into account the surging demand from the student community expressing their inability to submit their admission and/or re-registration forms online owing to havoc caused by the ongoing monsoon affecting roads, infrastructure, internet, etc, the Vice Chancellor has again extended the last date for fresh admission as well as re-registration for the July 2025 session till 31st August, 2025. However, the extension of last date is not applicable for admission to six months certificate and semester based programmes and stands closed.

To enroll in the next year or semester. learners need to register on the Portal and click "New Registration" button to proceed and provide the correct mobile number and e-mail ID so that the University is able to send confirmation and other important updates only if the correct mobile number and e-mail ID are entered. In case the

learners face difficulty in registering on the portal (not getting OTP/ forgot Username/Password or any other difficulty), they need to approach Regional Centre for re-setting of their account/updating email ID or mobile number at rejammu@ignou.ac.in.

They can apply for IGNOU re-registration July 2025 by visiting the official website of the IGNOU www.ignou.ac.in. The direct link for online re-registration is https://onlinerrignou.ac.in/ which can be accessed under the drop-down menu option "Register Online" on IGNOU website. "The desirous candidates who wish to seek fresh admission or re-register themselves for next year/semester can avail this opportunity of date extension and apply for any of the programmes of their choice well before the last date". said Dr. Sandeep Gupta, Regional Director: For filling the admission form online, candidates need to create a User ID and Password on the SAMARTH portal

and be ready with a Mobile No., Email ID, properly scanned academic documents, photograph and Bank Debit /Credit/Net Banking for payment of fee. Applicants can access the IGNOU admission portal 2025 at IGNOU website www.ignou.ac.in or by directly following the link https://ignouadmission.samarth.edu.in.

The UGC mandates every student enrolling into online and distance education courses to register for DEB ID. Students who are planning to apply for any of the IGNOU programmes are now required to create a DEB ID at the time of admission. JAMMU: The High Court of Jammu & Kashmir and Ladakh at Srinagar has ruled that engagement under a temporary scheme does not confer any vested right for permanent continuance, while dismissing an appeal filed by two instruc-Government of $_{
m tors}$ Women's College, Baramulla.

A Division Bench comprising Chief Justice Arun Palli and Justice Rajnesh Oswal upheld the order of the Writ Court which had directed the release of legitdeclined the prayer for continuation of service.

The appellants, Mushtag Ahmad Bhat and Saleema Bano, were engaged as instructors in the Boutique Technology Centre of the college in 2015. They argued that since they had served for nearly a decade, their engagement should continue until the scheme lasted, and they also sought minimum wages under law.

The respondents, however, contended $_{
m that}$ Boutique Centre was initiated on the directions of the run on self-sustaining lines without burdening the college. Payments were made from student fees and later from NSS funds. From 2021, the course was formally added to the curriculum with modern machinery, requiring appointment of certified trainers through open recruitment.

The Court noted that the appellants were never part of the college staff and their engagement was outside the sanctioned framework. It held that once the course was included in the official certified instructors selected through a transparent process could be engaged. "The appellants, if eligible, can apply and compete

along with other aspirants. Their earlier engagement under the scheme does not entitle them to automatic continuation," the Bench observed.

Finding no merit in the appeal, the Court dismissed the case, reiterating that temporary or scheme-based engagements cannot be converted into permanent service rights.

Enforcement team inspects medical shops in Banihal

STATE TIMES NEWS RAMBAN: On the directions of the District Administration, a joint inspection was conducted by the Drug Control Officer, Ramban and Police Authorities in various areas of Banihal to check the misuse of psychotropic drugs and identify any unregistered $_{
m chemist}$ shops.

During the inspection, the team verified licenses and records of chemist shops, scrutinized sales registers and reviewed CCTV installations to ensure proper dispensing of medicines. The drive also aimed to detect and take action against any medical establishments operating without requisite permissions.

The inspection revealed that all chemist shops checked were operating with valid licenses and proper documentation. No unlicensed medical establishments were found and the sales records showed no evidence of diversion of psychotropic drugs.

The joint exercise by the Drug Control Department and Police authorities was focused on preventing drug abuse and illicit trafficking. Officials reaffirmed that such inspections will continue as part of ongoing efforts to enforce compliance with drug regulations and to safeguard the health and wellbeing of the public. Mere recovery of drugs not proof of financing illicit traffic: HC

JAMMU: The High Court of Jammu and Kashmir and Ladakh has ruled that mere recovery of contraband from an accused cannot establish the offence of financing illicit traffic under Section 27-A of the NDPS Act, while granting bail to a Samba resident arrested in a narcotics case.

Justice Rajesh Sekhri delivered the judgment while hearing three connected petitions arising from FIR No. 99/2024 of Police Station Vijaypur, in which police had intercepted a Swift car and recovered 16.82 grams of heroin, cash of Rs 6.13 lakh and a weighing machine from its driver, Mohd. Aslam. The trial court had earlier framed charges under Sections 22 and 27-A of the NDPS Act and declined bail to the accused.

Observing that Section 27-A prescribes stringent punishment of 10-20 years for financing illicit trafficking and harbouring offenders, the Court said that such a charge could not be invoked unless there was clear evidence of continuity, regularity or financial support in drug trafficking. "A solitary transaction or mere possession of narcotics does not amount to financing trafficking. Mere recovery of drugs cannot automatically qualify as proof of financing illicit traffic," the

Court observed. Since the heroin recovered fell in the intermediate quantity category, the Court also held that Section 37 NDPS Act, which applies to commercial quantity, was not attracted. Accordingly, the accused was

directed to be released on bail on furnishing

a surety bond of ?1 lakh and subject to strict conditions, including regular attendance before trial court. In a related petition, the Court also directed release of the seized vehicle (Swift car JK09P/1912) to its registered owner Hassan Din, noting that he was not involved in the offence and that the trial court had wrongly refused interim custody. The car has been ordered to be released on superdnama with

the trial. The Court emphasized that while drug trafficking remains a grave menace, courts must distinguish between mere possession and financial backing of illicit trade, and Section 27-A should be invoked only where substan-
