HC transfers Constable Recruitment petition to CAT Jammu Bench

JAMMU: In a significant development concerning the much-debated constable recruitment in the Jammu and Kashmir Police, Justice Moksha Khajuria Kazmi of Jammu & Kashmir and Ladakh High Court at Jammu has ordered the transfer of a writ petition (WP(C) No. 2159/2024) concerning age relaxation in the ongoing constable recruitment process to the Central Administrative Tribunal (CAT), Jammu Bench.

The petition, filed by Deepak Sharma and others,

challenged Advertisement Notice No. 01 of 2024 dated July 16, 2024, issued by the Jammu and Kashmir Services Selection Board (JKSSB), which invited applications for 4002 posts of constables in J&K Police.

Petitioners argued that the notice failed to provide age relaxation despite an eight-year gap in recruitment, rendering many otherwise eligible candidates ineligible due to age.

Justice Moksha Khajuria Kazmi observed that the matter pertains to service conditions and therefore falls within

Bail denied to Anantnag man accused under UAPA in Terror-Related Case

JAMMU: The Division Bench of Jammu & Kashmir and Ladakh High Court at Srinagar Comprising Justice Sanjeev Kumar and Justice Sanjay Parihar has dismissed the bail appeal of Zahoor Ahmad Mir, a 37-year-old resident of Sallar, Anantnag, who is facing trial under the Unlawful Activities (Prevention) Act (UAPA) for allegedly aiding and abetting terrorists affiliated with the Hizbul Mujahideen.

DB upheld the Special Judge's decision dated November 8, 2024, denying Mir bail in connection with FIR No. 30/2022 regis-

tered at Police Station Pahalgam.

Mir is accused of providing logistics and shelter to militants and facilitating their movements. According to the prosecution, his disclosures led security forces to a militant hideout in the Hokard Forest, where three Hizbul Mujahideen operatives were killed during a search operation.

While the defense argued that Mir was falsely implicated and had been arrested a day before the encounter, the court found no credible evidence to support this claim. The bench noted that Mir's alleged connections to other designated terrorists, including his cousin, further strengthened the

prosecution's case.

The court emphasized that under Section 43-D of the UAPA, bail can be denied if a prima facie case exists. Citing Supreme Court precedents, the judges reiterated that in UAPA cases, the principle of "bail is the rule, jail is the exception" does not apply.

The court concluded that given the serious nature of the allegations and the fact that most witnesses are yet to be examined, Mir had not made out a case for bail. However, it left the door open for him to reapply should there be a change in circumstances during the course of the trial.

Court grants six days police remand in Thar Road-Rage

JAMMU: 3rd Additional Munsiff Jammu has remanded Manan Anand, a resident of Nanak Nagar Extension, main accused in Thar Road Rage, to six days of police custody in connection with an FIR registered at Police Station Gandhi Nagar under sections 281, 125(a), and 109

of the Bharatiya Nyaya Sanhita (BNS). The order was issued by the 3rd Additional Munsiff/Judicial Magistrate 1st Class, Arvind Manhas, after the accused was produced before the court by the police on Wednesday morning. The Investigating Officer, PSI Mohd. Ilyas, submitted an application

seeking nine days' police remand, citing the seriousness of the allegations and the need for further investigation. The court noted that the investigation is at a preliminary stage and acknowledged that one of the charges - Section 109 BNS - is of a serious and non-bailable nature. After reviewing

the case diary and the medical fitness certificate of the accused, the court granted six days of police custody, from July 31 to August 5. Court directed the police to produce the accused before a competent court before the expiry of the remand period and instructed that he be medically examined every 24 hours.
