minister, chief minister or minister of the central or state government.

"When the Constitution was framed, our Constitution-makers could not have imagned that in the future, there would be political figures who would not resign on moral grounds before being arrested," he said.

The home minister said that in recent years, an astonishing situation has arisen in the country where chief ministers or ministers have continued to run the government mmorally from jail without resigning.

He said the Bill also includes a provision that allows an accused politician to seek oail from the court within 30 days of arrest.

If they fail to obtain bail within 30 days, on the 31st day, either the prime minister or chief ministers in the states will be removed them from their posts, or they will automatically become legally ineligible to perform their duties, he said, adding if such a eader is granted bail after the legal process, they can resume their position.

Shah said the country also remembers the time when "in this very great House (Parliament), the then prime minister Indira Gandhi, through Constitutional Amendment No. 39, granted such a privilege to the prime minister that no legal action ould be taken against them.

"On one side, this is the work culture and policy of the Congress, that they place the orime minister above the law through constitutional amendments. On the other side, the policy of the Bharatiya Janata Party is that we are bringing our government's prime minister, ministers and chief ministers within the ambit of law," he said.

The Home Minister said a Congress leader in the House also made a personal remark against him, saying that when the Congress "falsely implicated him in a fabricated case" and had him arrested, he (Shah) did not resign.

"I want to remind the Congress that I had already resigned before being arrested, and even after being released on bail, I did not take any constitutional position until I was fully proven innocent by the court.

"The court dismissed the false case against me, stating that it was motivated by politcal vendetta," he said.

Shah said the BJP and the NDA have always stood for ethical values and party veteran Lal Krishna Advani also resigned from his post as soon as allegations were made against him. On the other hand, he said, the Congress party continues to carry forvard the "unethical tradition" started by Indira Gandhi.

The Home Minister claimed the same Congress party that brought an Ordinance to protect RJD supremo Lalu Prasad Yadav, which Rahul Gandhi opposed, is now seeng the same Rahul Gandhi embracing Yadav at Gandhi Maidan in Patna.

He said the public fully understands this duplicity of the Opposition. Shah said it was clear from the beginning that this Bill would be placed before the Joint Committee of Parliament, where it would be thoroughly discussed.

"Yet, abandoning all shame and decency, the entire INDI alliance, led by the Congress, gathered to oppose it with crude behaviour to protect the corrupt. Today, the Opposition has been completely exposed in front of the public," he said.

"These Bills are not being introduced as per the procedures of the House. What is the undue haste in bringing such important Bills that they have not even been circulated to the members," he said.

According to the Bill, there is no provision under the Government of Union erritories Act. 1963 (20 of 1963) for the removal of the chief min arrested and detained in custody on account of serious criminal charges.

Hence, there is a need to amend section 45 of the Government of Union Territories Act, 1963, to provide a legal framework for the removal of a chief minister or a minister in such cases.

Online money game is one played by a user by depositing money in expectation of winning monetary and other enrichment.

Union Minister Vaishnaw introduced the bill in the Lok Sabha amid sloganeering by MPs belonging to opposition parties against alleged irregularities in the electoral roll revision in Bihar.

The bill outlaws all online betting and gambling (satta and jua) activities -- from online fantasy sports to online gambling (like Poker, Rummy and other Card games) and online lotteries.

Advertising of money games can attract imprisonment up to two years and/or a fine up to Rs 50 lakh. Facilitating financial transactions related to money games can lead to imprisonment of up to three years and/or a fine of up to Rs 1 crore.

Repeat offences attract enhanced penalties, including 3-5 years' imprisonment and fines up to  $\operatorname{Rs} 2$  crore.

Importantly, offences under key sections are sought to be made cognisable and non-

Each department will receive specific communication from the Finance Department flagging their areas of concern and giving a six-month revenue target breakdown. They should start working on improving revenue realization today, with a clear monthly plan." the Chief Minister stressed.

Similarly, in respect of welfare schemes administered by Building & Other Construction Workers Board, the meeting was informed that ?166.90 crore was disbursed to 2.5 lakh beneficiaries in 2024-25, yet active worker registration remains low,

Day address, Prime Minister Narendra Modi described Operation Sindoor as "a new normal", making it clear that "India will respond with full force whenever terrorism threatens its citizens," the synopsis says

Beyond immediate responses, the Modi government is preparing for "long-term threats," the government said.

In his Independence Day speech, Modi had announced the Sudarshan Chakra Mission, a futuristic defence programme.

"Its goals are threefold -- to ensure the entire system is researched, developed, and manufactured in India; to anticipate future warfare scenarios through predictive technologies; and to create precise, targeted systems for counter-action. By 2035, the aim is to provide a comprehensive national security shield for both strategic and civilian assets," it says.

In the last eleven years, India's defence and internal security posture under the government of PM Modi has undergone a "profound transformation", it says.

The shift has been marked by "greater clarity of purpose, stronger deterrence, and a sustained drive for self-reliance," the synopsis says.

This government has consistently underlined that "national security is non-negotiable", and to ensure this security, India will build its own capacity and preparedness. This has resulted in a "more confident, modern, and proactive approach to challenges, both external and internal". it adds.

Firm responses to terrorism, the clear articulation of new normal with Pakistan and futuristic initiatives like the Sudarshan Chakra Mission underscore a "forward-looking security doctrine," the government asserted.

The case was registered following a discrete verification conducted into the allegations that the aforesaid employee had accumulated wealth far exceeding his legitimate earnings, the official said.

Subsequent to the registration of the case, searches are being conducted at three residential premises of the accused in presence of Executive Magistrates after obtaining proper Search Warrant from competent Court, the official said, adding that further investigation is under process

his plea for mercy and requesting a change in his place of custody.

# Unmarried, widowed or divorced daughter of deceased Govt employees entitled to family pension: Centre

NEW DELHI: Unmarried, widowed or divorced daughters of deceased government employees are entitled to family pension provided they meet certain prescribed con ditions, the Lok Sabha was informed on Wednesday.

Various provisions have been incorporated in the Central Civil Service (Pension Rules, 2021, notified by the Department of Pension and Pensioners' Welfare (DoPPW), and in the office memorandum dated October 26, 2022 issued subse quently to ensure that a divorced/widowed daughter of a deceased government employee or pensioner gets family pension on her turn, Union Minister of State for Personnel Jitendra Singh said in a written reply.

The same provisions are provided under separate rules for railway and defence employees and pensioners, he said.

In terms of these rules, where a deceased government employee or pensioner is no survived by a spouse or son eligible for family pension or if they die or cease to fulfil the eligibility conditions for family pension, the family pension shall be granted or continued to be payable to an unmarried or widowed or divorced daughter, the minister said, and mentioned other conditions for such pensions.

The pension will be continued until "she gets married or is remarried or until she starts earning her livelihood, whichever is the earliest, subject to the conditions like the unmarried or widowed or divorced daughter was dependent on her parent or parents when he or she or they were alive", the ministet said.

"Further, in the case of a widowed daughter, the death of her husband and in the case of a divorced daughter, her divorce took place or the divorce proceedings filed in a competent court during the lifetime of the government servant or pensioner or his or her spouse," Singh said.
