Vide Order Dated 22.05.2025 this court directed SHO Katra to publish proclamation against accused with the procedural mandate provided in Para No. 3 of order dated 22.05.2025. However, on the next date of hearing i.e 23.07.2025 was fixed for the await of compliance from SHO concerned regarding publication of proclamation and also for appearance of accused no.1,2 and 3. SHO filed partially compliance report to the extent of said proclamation of clause (i) (ii) and (iii) of Para 3 of order dated 22.05.2025, however he failed to follow the mandate of Para (iv) of Para (3) of the said order and due to his failure to adhere the proceedings provided in para no.3 of the said order. The whole process of section 82 gets vitiated. Since this trail already gets delayed on account of non-appearance of the accused persons and accordingly proceedings u/s 82 Cr.PC adopted vide order dated 22.05.2025 but that too gets vitiated on account of failure of SHO Katra and trail gets further delayed.

Before proceeding further it comes to fore that accused no. 1 namely Sher Ali is lodged in jail under PSA by the order of District Magistrate Udhampur vide order no. 07/PSA/2025 dated 19.06.2025. Office is directed to issue production

warrant in this regard against ther accused no. 1. 3. From above, it transpries that accused no.2 and 3 are absconding themselves so as to Prevent execution of waraant and I am satisfied that proceedings for compellingappearance of accused persons including the proclamation is required to be invoked against accused person. In order to expedite the trail SHO Katra is again directed to Published the proclamation containing in Para no.3 comprising (i) to (iv) by or before 28.08.2025 and then file is kept for appearance of accused on 30.09.2025,10 AM sharp.
