PRELIMINARY NOTIFICATION

This notification is made under the provisions of section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act no. 30/2013) to all whom it may concern.

A Plan of the land may be inspected in the office of the Collector on any working days during the working hours. The Government authorizes Tehsildar Drabshalla and his staff and officials of indenting department to enter upon and survey land, take levels of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in section 12 of the Act.

Under Sub section (4) of section 11 of this Act, no person shall make any transaction or cause any transaction of land i.e, sale/purchase, etc., or create any encumbrances on such land from the date of publication of this notification without prior approval of the Collector.

Objections to the acquisition, if any, may be filed by the person interested within **60 (Sixty days)** from the date of publication of this notification as provided under section 15 of the Act before the Collector
