CEOs and HOIs shall consult the local administration before opening the Schools.

He said just two days of rain brought Kashmir to the brink of floods.

"What will happen if it rains for four days? We will face a situation like 2014. We had then (2014) endured it (rainfall) for seven days and drowned on the eighth day. But now, we endured two days of rains with difficulty," he said.

Abdullah said the government needs to take corrective measures as people cannot live in the fear of floods every year. "After some days, I will sit with the officers and try to understand what we did after 2014. Where was the money spent? How much carrying capacity of the flood channel was increased? How much did we succeed in increasing the carrying capacity by undertaking dredging in the Jhelum? "We have to take corrective measares wherever we are lagging...," he said.

On security arrangements, Omar Abdullah called for visible police presence, both male and female, to instill a sense of safety and prevent incidents of theft or disorder. He direct ed that sufficient deployment of lady police should be ensured in sensitive zones.

On sanitation, the CM stressed the use of newly procured mobile toilet units, regular deployment of sanitation workers, and proper waste management in and around shrine. He also directed to maintain availability of dewatering pumps, ambulances, fire tenders, health clinics, and standby hospitals to meet any contingency.

The Chief Minister further underscored the need to regulate the activities of NGOs and voluntary groups providing food, water, and other services. He directed that such camps should be set up in designated areas to avoid congestion and obstruction in movement.

Omar Abdullah also instructed all officers to ensure similar arrangements at other major shrines across Srinagar, including Aasar-i-Sharief Hazratbal, Jenab Sahib Soura, Aasar-i-Sharief Kalashpora, and other prominent religious locations, so that uniform facilities and safety measures are available to devotees everywhere.

The Chief Minister also stressed on making adequate availability of safe and clean drinking water which must be ensured throughout the religious occasion, along with sufficient deployment of public transport. He also directed the Food Safety Department to carry out regular checks to maintain quality and hygiene of food items being distributed and sold during the occasion.

Earlier, Deputy Commissioner Srinagar, SSP Srinagar and heads of departments oriefed the Chief Minister about the preparations, including arrangements for electricity, nealth services, medicines, paramedics, mobile sanitation units, and parking facilities.

This step has been taken by railway authorities following multiple requests to ensure greater convenience for passengers. Passengers are stranded at various railway stations, particularly Jammu, waiting for the Railways to resume train traffic.

Heavy rainfall in Jammu-Pathankot has affected the rail services in the Jammu division as railway tracks and bridges bore the brunt of the floods. Train services remain badly hit, leaving hundreds of passengers stranded at Jammu railway station. A majority of them are pilgrims returning from the Mata Vaishno Devi shrine in Katra, which was hit by a landslide on Tuesday, killing 34 people and injuring 20 others, officials said. Katra, the base camp for the pilgrims visiting Mata Vaishno Devi Shrine, also recorded a 24-hour rainfall of 284 mm on Wednesday.

Babita Jaiswal, a resident of Kanpur, said, "We were in Katra for two days, but were asked to leave and told that trains were operating from Jammu. We reached Jammu somehow by bus. There is no train or bus available from here... How will we go home now?

There is no place to stay, no provision for washrooms... Where will we go?" She said the stranded passengers want train services to be restored as soon as possible. Rail traffic, which was briefly restored on Wednesday morning with six trains departing from Jammu after a day-long suspension, has again been halted due to flash floods and heavy soil erosion in the Chakki river area, officials said.

Providing details, the PRO said 58 trains were cancelled, three partially cancelled, one partially restored, five fully restored, and three diverted. Additionally, 18 trains had short origins and 46 short terminations. In a humanitarian step, the Railways reached out to stranded passengers at several railway stations and took measures to provide food and lodging facilities in the prevailing bad weather conditions in the Jammu region. Food items and water were arranged in coordination with local NGOs and civil society for passengers of stranded trains at Manwal, Sangar and Gaghwal, with the help of station staff, Railway Protection Force and Government Railway Police.

The talks are paused as the US is pressing for greater market access in politically sensitive areas such as agri and dairy sectors, which India cannot accept as it affects the livelihood of small and marginal farmers.

When asked whether India will impose retaliatory duties on the US, the official said: "Retaliation and negotiations cannot go hand-in-hand. Right now, the talks are only postponed, it has not been taken off the table. So, why should we be worried? Retaliation is something which we can do at any point of time.

India has reserved its rights under the WTO (World Trade Organisation) norms to impose retaliatory duties on the US against Washington's taxes on steel and aluminium and auto and auto components.

The men and machines of the Border Roads Organisation (BRO) are working to clear the highway of blockades, which occurred on Tuesday following heavy rains and flash floods, they said. According to the traffic advisory, the Kishtwar-Sinthan-Anantnag highway is closed for vehicular movement. It said subject to fair weather and good road condition, and after getting a green signal from the BRO, traffic movement shall be allowed in a regulated manner on the Srinagar-Sonamarg-Gumari road. LMVs followed by HMVs shall be allowed from Sonamarg towards Kargil between 1130 hours and 1730 hours. "No vehicle shall be allowed after the cut-off timing. Security forces convoys plying from Srinagar to Kargil and vice versa shall plan their movement in such a manner so that civil traffic is not disturbed," the advisory said. According to the advisory, movement of LMVs shall be allowed on Mughal Road between Shopian district of Kashmir and Poonch district of Jammu region, subject to fair weather and good road condition, after getting a green signal from road maintenance agencies. "LMVs and private cars shall be allowed from both sides on Mughal Road, i.e., from Jammu towards Srinagar and vice versa via Poonch. These vehicles shall be allowed from Behramgala in Poonch and Herpora in Shopian between 0700 hours and 1800 hours," it said.

'Unprecedented cloudburst-triggered landslide on Shri Mata Vaishno Devi Track'

KATRA: A few media reports have been circulating since yesterday alleging that Shri Mata Vaishno Devi Yatra was allowed to proceed in complete disre gard to weather advisories and at the expense of pilgrim safety. Shri Mata Vaishno Devi Shrine Board (SMVDSB) expressed deep sorrow and pain at the unfortunate loss of lives of pilgrims in the natural disaster on 26th August, and places on record the correct factual position to dispel the impression being created by the insinuating media reports. The Board categorically denies the allegations as false and baseless.

A Board spokesperson said that "The weather conditions had remained clear and conducive for pilgrimage on 26th August morning until around 10:00 AM, during which time the yatra proceeded normally, so much so that even the helicopter services were operating seamlessly during that time. In fact, the Board had made elaborate arrangements of positioning its enforcement staff and Disaster Management Task Force along the entire track as per its established standard operating procedure. The Board monitored weather updates closely and as soon as the forecast for moderate rains was received, registrations were immediately suspended. Majority of the Yatris were moving down the track after completing darshan at the Holy Cave Shrine. Thousands of yatris en-route had smoothly completed their pilgrim age back to Katra by then.

"However, many pilgrims stayed on in the shelter sheds en-route at design nated halt points on the old track. These are those points/ stretches which have never been susceptible to landslides in the past. These halt points have been specifically created in the safest zones of the track, for pilgrim safety Spokesperson said .

It was further informed that the new track between Katra and Adhkwar (through Tarakote), which is susceptible to landslides and weather-related disruptions, had already been closed since 24th August in the interest of pilgrim safety. The old track, which is generally secure and not prone to slides, shooting stones (having stabilized over the last many decades), was kept open for pilgrim movement with a close watch on weather conditions. Even yatra on this track was suspended by 12:00 noon on 26th August upon issuance of the specific weather advisory.

The location where this unfortunate disaster happened was near Inderprastha Bhojanalaya on the old track. This is one of the safest locations on the track. However, nature's fury struck in the form of sudden severe cloudburst in this stretch of around 50 meters only, which triggered the mas sive landslide at 2:40 PM. It was unpredictable and unforeseen from any count. No such event of land slide has ever been recorded in this area in the past. The event was a force majeure.

The Shrine Board's Disaster Management Task Force which was spread along the track immediately responded in close coordination with District Administration, Reasi, J&K Police, CRPF, Army, NDRF, SDRF, and volun teers, launching swift evacuation and relief operations. 18 pilgrims who had sustained injuries were safely evacuated and shifted for superspecialty care in Shrine Board's Hospital at Kakryal after giving them first aid along the track. Stranded pilgrims were safely evacuated to Katra through Tarakot Marg by the evening of 26th August. Simultaneously debris clearance, slope inspection, and stabilization were undertaken on a war footing. The Board has, over the years, taken concerted steps to undertake slope stabilization and mountain binding activities. Robust shelter sheds to guard against stray shooting stones have been laid along almost the entire track.

The Board reiterates that every reasonable precaution was taken keeping in view weather forecasts. The unfortunate cloudburst resulting in loss of pre cious lives was not humanly foreseeable and was thus, beyond anyone's antic ipation or control. The Board has at all times acted strictly in line with offi cial weather forecasts and advisories, with pilgrim safety and well-being as its foremost priority. "The Shrine Board stands firmly with the bereaved families in this hour of grief and every possible assistance will be provided to the NoKs of the deceased devotees. Injured are being provided with the best possible medical treatment and the Shrine Board prays to Mata Vaishno Dev for their quick recovery" Spokesperson said.

Magistrate acted as 'Post Office' of Police: HC slams PSA detention

JAMMU: The High Court of Jammu and Kashmir and Ladakh quashed the pre ventive detention of a Kulgam resident under the Public Safety Act (PSA), remarking that the District Magistrate had acted as a "post office" of the police dossier without applying his independent mind.

Justice Rahul Bharti, while allowing petition, set aside detention order No 20/DMK/PSA/2024 dated September 10, 2024, passed by the District Magistrate Kulgam against Rayees Ahmad Thoker of Shounch, Kulgam.

Thoker, represented by Advocate Wajid Mohammad Haseeb, was booked in two FIRs of 2019 and 2020 but had already been granted bail. Despite this, the Superintendent of Police, Kulgam, recommended his detention, projecting him as an active Over Ground Worker (OGW). Acting on the dossier, the District Magistrate ordered custody under PSA. The Court observed that the detention order's wording on the basis of grounds placed before me by the Superintendent of Police, Kulgam" made it clear that the Magistrate had abdicated his duty of independent application of mind. Justice Bharti said such practice was "antithetical to law" and declared the detention "illegal from inception." The Court directed that Thoker, presently in Central Jail, Srinagar, be released forthwith unless required in any other case.

Fast-Track Court convicts man for raping 6-year-old minor

JAMMU: In a landmark judgment delivered today, the Presiding Officer Fas Track Court Jammu Amarjeet Singh Langeh convicted Sohan Lal alias Sonu for raping a 6-year-old girl in 2015. Presiding Officer Amarjeet Singh Langeh held the accused guilty under Section 376 of the Ranbir Penal Code (RPC), observing that the prosecution had "proved complicity of the accused beyond reasonable

The gruesome crime occurred on May 2, 2015, when the minor was returning home after buying onions from a nearby shop. According to the prosecution, the accused lured her into a wheat field, gagged her mouth, and sexually assaulted her. The child's father, on hearing her screams, rushed to the spot and saw the accused fleeing, leaving his daughter bleeding and injured.

The victim required emergency medical treatment and remained admitted in hospital for nearly a month due to severe injuries. Medical and forensic report confirmed sexual assault, with human spermatozoa found on the victim's clothes and the underwear of the accused.

Eve-witnesses, including the victim's father and owner of a nearby poultry farm, corroborated the prosecution case. The accused, however, claimed innocence, alleging false implication, but the court found his defence unreliable. "The testimony of the minor victim, supported by medical, forensic and ocular evidence, is coherent and wholly trustworthy," the court observed, declaring Sohan Lal guilty. The court will now hear arguments on the quantum of sentence or August 30, 2025.

Unidentified Nepali national found dead under suspicious circumstances

JAMMU: An unidentified dead body, suspected to be that of a Nepali national, was found under mysterious circumstances in the Chak Dena area of Marh on Wednesday.

According to official sources, the body was found early in the morning by locals, who immediately informed the police. Responding promptly, personnel from Police Station Domana arrived at the scene and took charge of the situation.

Inquest proceedings under Section 194 of the Bharatiya Nagarik Suraksha Sanhita (BNSS)

have been initiated to determine the cause and circumstances surrounding the death. The deceased, whose identity remains unknown, has been shifted to the mor tuary at Government Medical College (GMC), Jammu. Authorities are currently awaiting identification and further leads. Police have appealed to the public to come forward with any information that may

help identify the deceased. "We request citizens to have a close look at the deceased at the mortuary and report to Police Station Domana if any identification is possi ble," a police spokesperson stated.

Further investigation is ongoing, and forensic and medical examinations will assis in establishing both the identity and cause of death
