A. For Assistant Professor:

- Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- Notwithstanding anything contained in sub-clauses (i) and (ii) above, candidates who have been awarded Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. degree) Regulations 2009 / 2016 shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET.

B. For Assistant Professor in various disciplines of Engineering:

M.Tech./ M.E. in relevant subject from a recognized University with Minimum 60% marks or equivalent grade in a seven point scale where grading system is practiced from a recognized Indian University.

Note:

- Candidates holding Ph. D. in the relevant subject in accordance with UGC Regulations shall be preferred.
- Candidates who do not possess Ph.D., M.Tech. / M.E. or NET / SLET / GATE may be considered for academic arrangement as Teaching Assistant in case eligible candidates are not available or if circumstances so warrant.

Special Condition :-

- Security deposit shall be deposited by the contractor within 10 days of issuance of LOA, failing which the concerned tender issuing authority shall forfeit the EMD and recommended contractor for blacklisting and issue a fresh tender forthwith, besides debarring the defaulter for participating in future tendering with this Division.
- The contractor shall initiate the work within 07 days of entering into the agreement, failing which the concerned Executive Engineer shall terminate the contract and issue a fresh tender after imposing penalties viz. forfeiting of security deposits as per T&C of the BID document and recommended contractor for blacklisting.
- The work shall be completed by the concerned contractor as per the timeline stipulated in BID document / agreement, failing which action shall be initiated against contractor by forfeiting EMD and shall be recommended for blacklisting.

1. **Cost of Tender Documents:** Bids must be accompanied with cost of Tender document (dated between the bid start date and the Bid Submission End date) deposited in M.H. 0059 (Revenue) mentioning therein the name of work / e-Nit No. pledged to Executive Engineer PWD (R&B) Division Khour (Tender Inviting Authority) as the cost of the tender document. Any deviation in the specified amount, the bid shall be rejected outrightly. The cost of Tender Document is non-refundable.

NOTE:- In case of consecutive calls for same work due to poor response/any reason thereof, the Treasury Challan (TC) used by bidder in preceding E-NIT invited for same work shall be accepted Provided there is mention of Preceding calls in the TC.

1.1 **Earnest Money Deposit / Bids Security:-** At the time of tendering, all bidders must upload Earnest Money / bid security equal to 2% of the Advertised cost in the shape of CDR/FDR (dated between the bid start date and the Bid Submission End date) pledged to the tender receiving authority, i.e., Executive Engineer PWD (R&B) Division Khour.

1.2 Bid securities of the unsuccessful bidders shall be released only after the submission of Treasury Challan Bid securities of the unsuccessful bidders should be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract.

1.3 The Earnest Money/Bid Security of 2% will be released to the successful bidder only after the submission of a performance Security.

2. The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder needs not to make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential- submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. No bid shall be modified or withdrawn after the deadline of submission of bids.
