Yasin Malik acquitted in 1996 Protest Case after nearly three-decade

JAMMU: A local court in Srinagar has acquitted separatist leader Mohammad Yasin Malik in a 29-year-old case related to a protest held in 1996, citing lack of evidence and violation of the constitutional right to a speedy trial.

The 1st Additional Munsiff and Judicial Magistrate First Class Srinagar, presided by Judge Zirgham Hamid, delivered the verdict on July 16, 2025, dismissing the charges under Sections 147 (rioting) and 341 (wrongful restraint) of the Ranbir Penal Code (RPC). The case, registered at Police Station Budgam (FIR No. 208/1996), involved a protest led by Hurriyat leaders including the late Syed Ali Shah Geelani, Abdul Gani Lone, and Yasin Malik. The trio had reportedly led a demonstration near Hyderpora, Srinagar, and attempted to march toward the Airport Road while raising slogans. Following standard procedure, a case was filed and an investigation initiated. However, only Malik remained alive by the time the case reached trial, with the other two accused having passed away. Malik, currently lodged in Tihar Jail, was charged formally in June 2024 and pleaded not guilty.

Despite court directives, the prosecution failed to produce any witnesses over the span of the trial. Citing landmark Supreme Court judgments, including Hussainara Khatoon v. State of Bihar and Abdul Rehman Antulay v. R.S. Nayak, the court reaffirmed that the right to a speedy trial is a fundamental right under Article 21 of the Indian Constitution.

'There has been an inordinate delay in prosecution. No evidence was present-

ed, and the accused cannot be denied justice indefinitely," the order read. The court therefore acquitted Malik of all charges, discharged his bail and surety bonds, and ordered the release of any seized property to its rightful

Teenage girl injured in bear attack in Poonch

JAMMU: A 19-year-old girl was critically injured in a bear attack in Poonch district on Saturday, officials said.

The girl was attacked by the wild bear when she ventured out of her house in remote Louran Top village, the officials said.

They said the girl's cries attracted the attention of the villagers, who chased the pear back into the nearby forest and shifted the girl to the hospital.

The girl suffered injuries in her face and legs, and is being referred to Jammu for pecialised treatment, the officials said.

DODA: Continuing its efforts against bovine smuggling, Doda Police has rescued 11 bovine from the clutches of smugglers in Nalthi and Bhalla area falling under the jurisdiction of PS Bhaderwah.

Official sources has said that on 01-08-2025 during early hours in the morning during Naka checking at Nalthi Naka, three individuals were found transporting/carrying eight Bovine animals towards Bhaderwah on foot. They were doing so without arranging fodder and water for them and they were ruthlessly beat ing these bovines. The police party deployed at Naka became suspicious and appre hended one individual, namely Asif Ali, S/O Mohd Shafi, resident of Botla Bhaderwah. The other two individuals Raj Mohd, S/O Mohd Shareef, and Mohd Rafiq, S/O Roshan Din, both resident of Thanalla Bhaderwah fled the scene upon seeing the police party. The police party managed to rescue the bovines. The appre hended individual during questioning failed to produce any lawful authorization for
