Traditionally there were two routes for moving into Ladakh, that is through Zojila Srinagar-Leh Highway) and Rohtang Passes (Manali-Leh). Recently India commissioned a third road from Darcha to Leh which is much shorter distance-wise and less prone to closure, he said.

The spokesperson said completion of Atal tunnel on the Rohtang route has force multiplied the logistic capacities.

In addition, we have a large number of airbases with the help of which we can maintain the Army well. Modern snow clearing equipment has also been placed on these routes to keep them open beyond November, thus giving us more time for daily maintenance of the troops, he said.

The spokesperson said special fuel and lubricants for tanks and armoured personnel carriers have also been stocked adequately, including spares for their maintenance. Water points and tube wells have been established for the troops and animals like mules and yaks.

The living barracks have also been prepared which are comfortable and warm, he said. He said facilities such as the central heating system are some of the high points of these facilities. Ammunition of various types including small arms, missiles and tank and artillery ammunition have also been adequately stocked. The medical system is also in place for any

The spokesperson said China's concept has always been to win the wars without fighting, hence if they create conditions for war, they will come across better trained, better prepared, fully rested and psychologically hardened Indian troops.

A total of 45 civilians and 49 security personnel were killed due to terrorist incidents from August 5, 2019 to September 10, 2020 in Jammu and Kashmir and 26 civilians and 25 security personnel were killed due to ceasefire violation by Pakistani forces along the border in the same period.

Prior to the abrogation of Article 370 -- from June 29, 2018 to August 4, 2019, (total 402 days), there were 455 terror incidents in Jammu and Kashmir while from August 5, 2019 to September 9, 2020 (402 days), there were 211 terror incidents in the Union Territory.

Declare lockdown for...

the Administration. Taking note of total confirmed cases of COVID-19 infected persons surging to 55,325 in UT of J&K, with more than 900 deaths, the deadly disease has taken a turn for the worst and it is feared that cases have spiked due to community transmission and particularly in Jammu Division of J&K UT, which has during the last few days/weeks noticed exponential rise in the positive cases and more deaths per day than in the valley of Kashmir.

The Association is seriously concerned about the insufficient infrastructure, medical officers, paramedical staff and sanitization in the so called premier medical institutes, i.e. Govt. Medical College, Jammu, Govt. Medical College, Srinagar and hospitals associates with these two Medical Colleges, Chest Disease Hospital Jammu, District Hospital Gandhi Nagar, Psychiatric Hospital Jammu and few other COVID-19 designated institutions which are not able to cope up with the rush of rising positive cases, and most of time, the suspected positive cases enter the Govt. Medical Institutions, they are not being attended to properly due to aforesaid insufficiencies.

The Association has taken it very seriously that even the lives of medicos, para medicos and health workers are not safe in the medical institutions which are available in UT of J&K, therefore, U.T Administration is required to immediately and forthwith upgrade the existing COVID-19 designated institutions and to create more such institutions in order to save the lives of doctors, para medicos and health workers and in particular the poor strata of the society, who have no say in the corridors of the power and are left at the mercy of almighty.

The Association, a representative body of responsible and educated citizens and legal fraternity, is concerned about the worsening Covid-19 condition and demanded that in order to contain the disease, all the private hospitals existing in the U.T of J&K, specially in Jammu Division and in particular the Narayana Hospital Katra be declared as Administrative Quarantine Centre/designate COVID-19 hospital and be opened and available to the general public as well, instead of accommodating only the VVIPs, inasmuch as, even poor citizen has a fundamental right to life which is enshrined under Article 21 of the Constitution of India, which does not create a distinction between a poor and a rich/

The impression gathered by the general public that the Narayana Hospital is meant to accommodate only rich and VVIPs is required to be dispelled with by the Administration, by opening up this Institution to the public at large at this critical hour of history

The Association considered the predictions by some health experts and organizations that things will worsen in the coming days and weeks, therefore, J&KHCBA, Jammu demands that the Administration of J&K UT should seriously think of imposing yet another lockdown for the purpose of regulating the existing quarantine centres which are at present totally unregulated; enabling the administration / management of existing medical institutions to regulate those institutions within the available strength of medical officers, paramedical staff and health workers and in the meanwhile, during that lockdown, more quarantine centres in the form of Administrative Quarantine Centres are required to be created by way of an official order declaring maximum private hospitals, nursing homes and clinics as Administrative Quarantine Centres to accommodate Covid-19 positive cases and in particular those who belong to poor strata of the

'Bleeding Heart' was to replace Hurriyat Conference in Kashmir: accused tell NIA

SRINAGAR: After tightening of terror funds by the National Investigation Agency NIA), Pakistan had approved a proposal by Irfan Shafi Mir, who was arrested along with Deputy SP Davender Singh, to set up a new outfit called 'Bleeding Heart' as it had realised in 2018 that Hurriyat Conference, the separatist conglomerate created y ISI, won't be able to deliver any more.

Mir, who has emerged as a 'double agent', made frequent visits to Pakistan during which he came in contact with ISI officials as well as top terror leadership that had omplained that separatist groups in the Kashmir valley had become defunct after the NIA cracked its whip on their anti-national activities in 2017 following registering of terror funding case.

During a visit to Pakistan in 2018, Mir held an extensive discussion with ISI offiials as well as terrorist top brass to set up a non-governmental organisation (NGO) by the name 'Bleeding Heart' which would replace the role of Hurriyat Conference, ays the NIA chargesheet filed in a designated court of Jammu.

Mir was arrested along with Jammu and Kashmir Deputy Superintendent of Police Devender Singh and Hizbul Mujahideen terrorist Syed Naveed Mushtaq alias Naveed Babu and accomplice Rafi Ahmad Rather. The details of the 3,064-page chargesheet, accessed by PTI, show that Mir alias

Advocate' made this proposal of the NGO and had started working for it after receivng a go ahead from his mentors across the border. The NIA filed the chargesheet under the Unlawful Activities (Prevention) Act and

various sections of the Indian Penal Code against Mir, Singh, Naveed, his brother Syed Irfan Ahmad, Rather and businessman Tanveer Ahmad Wani, former president of the Line of Control Traders Association. According to the National Investigation Agency, the accused were part of a deepcooted conspiracy hatched by the Pakistan-based terrorist organisation Hizbul

against the Union of India". During his extensive questioning, the NIA said Mir had met banned terror group Hizbul Mujahideen chief Syed Salauddin, his deputy Amir Khan, the so-called operational chief Khursheed Alam and the terror group's financial head Nazar Mehmood

Mujahideen and Pakistani State agencies "to commit violent acts and to wage war

where the broad concept of 'Bleeding Heart' was discussed. Later during his stay in Pakistan, Mir had a meeting with ISI officers like Umar Cheema, Ahshan Chaudhary and Sohail Abbas who also tasked him to work on a new Hawala (non-banking) channel for transfer of money for sustaining terrorist activities in the Kashmir valley.

The investigation into the case led by Inspector General Anil Shukla and his team nas listed 3,017 oral and documentary evidences along with the chargesheet.

The chargesheet also gives instances of his connection with officials of Pakistan High Commission in India with whom he was in constant touch and also received monetary assistance

Visa applications from Kashmir recommended by Mir were also given top most priority at the Pakistan High Commission, the chargesheet said.

Mir was sitting in the car driven by Singh on January 11 this year along with aveed and Rather when their car was intercepted by Jammu and Kashmir near Qazigund on the national highway connecting the Valley with the rest of the country. A search of the vehicle led to the recovery of an AK-47 rifle, three pistols and a cache of ammunition and explosives. The NIA took over the case on January 17 this year. Pakistan's ISI and terror groups were rattled by the case of May 2017 registered by the NIA against members of Jamaat-ud-Dawa, Dukhtaran-e-Millat, Lashkar-e-Taiba, Hizbul Mujahideen and other separatist groups and leaders in the state for allegedly raising, receiving and collecting funds to fuel separatist and terrorist activities, conspiracy to cause disruption in the Valley, and waging war against India.

After thorough investigation into the case, the NIA arrested many people including nfluential businessman Zahoor Ahemd Watali and prominent politician Sheikh Abdul Rashid alias 'Rashid Engineer'. Two chargesheets were filed in the case which also included Altaf Ahmad Shah alias Altaf Fantoosh, the son-in-law of firebrand separatist Sved Ali Shah Geelani: spokesman of moderate Hurrivat Conference led by Mirwaiz Umer Farooq, Shahid-ul-Islam; spokesman of the Geelani-led faction of Hurriyat Ayaz Akbar; and separatists Nayeem Khan, Bashir Bhat alias Peer Saifullah and Raja Mehrajuddin Kalwal. The NIA has also recorded confessional statements on the flow of money, especially from Pakistan, from four people accused in a case related to the funding of "terror activities" in Kashmir. The case led to a decrease in stone pelting incidents in the Valley.

"Neither India nor others deserve this unsolicited lecture on human rights from a country that has consistently persecuted its ethnic and religious minorities, is an epicenter of terrorism, has the distinction of providing pensions to individuals on UN Sanctions list and has a Prime Minister who proudly admits training tens of thousands of terrorists to fight in Jammu and Kashmir,? the Indian diplomat said

It was not surprising that other relevant multilateral institutions have been raising serious concerns on Pakistan's failure to stop terror financing and lack of effective actions against all terror entities in Pakistan, India said

Highlighting the nefarious designs of Pakistan in Pakistan-occupied Kashmir (PoK), it said, "the mass influx of outsiders has whittled down the number of Kashmiris to an insignificant number in Pakistan occupied parts of Indian Union Territories of Jammu and Kashmir and Ladakh?
