In India, the virus has infected nearly 6 million people and killed more than 93,000.

Modi told the 193-member UN General Assembly that in India and the neighbourhood, we are moving ahead with phase 3 clinical trials in India.

He further assured that India will also help all the countries in enhancing their cold chain and storage capacities for the delivery of the vaccines.

In his address, the prime minister also noted that India with more than 18 per cent of the world population and a leading global economy for centuries has also endured hundreds of years of foreign rule. "When we were strong, we were never a threat to the world, when we were weak, we never became a burden on the world, he said.

An objective assessment of the performance of the United Nations over the last 75 years would yield several stellar achievements but at the same time, there are also several instances that point to the need for a "serious introspection of the work of the United Nations," he said. "With the changing times, if we don't change, then the drive needed to bring change will also get weakened, he said. "Several terrorist attacks shook the world and rivers of blood have continued to flow by, he said. "During those times and even today, can

ve suggest that efforts of the United Nations to tackle these issues were sufficient, he said. Modi said India will not hesitate to raise its voice against the enemies of humanity, includng terrorism, smuggling of illegal weapons, drugs and money-laundering, and will always speak in support of peace, security and prosperity. He pointed out that India has sent its brave soldiers to about 50 peacekeeping missions the world over to keep peace and in the course of maintaining peace, has lost the maximum number of its brave soldiers. "India's experiences, and India's developmental journey marked with its ups and downs will only add to strengthening the path to global welfare," he said.

CAG flags deficiencies...

of Rs 24,299 crore incurred on power purchase during 2012-17, revenue realisation from sale of power was only Rs 9,428 crore, the Comptroller and Auditor General of India (CAG) said in its report on 'Social, General, Economic (Non-PSUs) Sectors' for the year ended 31 March 2017. "The department (PDD) failed to meet its power requirement and the gap between unrestricted demand and self-generation available to the state ranged between 77 per cent and 84 per cent.

"Around 73 per cent to 76 per cent of the power requirement of the state was met through purchase from Central Generating Stations," the report, tabled in the Parliament this week, said. It said JKPDD incurred an extra expenditure of Rs 840 crore on power purchased during 2012-17 due to deficiencies in planning and non-optimisation of power purchase

"The JKPDD made an avoidable payment of Rs 1,420.26 crore towards late payment surcharge and lost the opportunity to avail rebate of Rs 297.92 crore due to deficient financial management. It also had to shell out Rs 33.67 crore towards fixed charges without availing power due to imposition of regulation for delayed payments," the report said.

Due to non-completion of transmission infrastructure for evacuation of power, the report said, the department made an avoidable payment of Rs 543.47 crore towards idle capacity charges and energy charges on deemed generation to two power projects.

"Poor collection efficiency resulted in recoverable revenue of Rs 2,508.23 crore ending March 2017." it said. JKPDD failed to recover its power purchase cost due to operational inefficiencies like increasing gap between average cost of supply and average billing rate, high aggregate technical and commercial losses, which were at 62.56 per cent in 2015-16 and increased to 67.63 per cent in 2016-17, which resulted in foregone revenue of Rs 10,176 crore. The report said the department failed to implement revised tariff order approved by the Jammu and Kashmir State Electricity Regulatory Commission, resulting in loss of Rs 10.06 crore to the state exchaquer.

"The department had not devised any mechanism for filing objections on petitions filed by the generators," it said. Meanwhile, the consolidated position of water usage charges assessed, collected and the balance outstanding against all the 29 power projects in J&K was not available with the department responsible for assessment and collection, CAG said.

"Only Rs 3,971.63 crore, 67 per cent of the assessed amount of Rs 5,950.55 crore in respect of 17 power projects had been recovered. Out of the total expenses of Rs 4,159.85 crore from the water usage charges fund, 2.40 per cent were allocated for creation of assets, 80.25 per cent were used for purchase of power. "Purpose for which Rs 721.56 crore (17.35 percent) had been transferred to the Common Pool Account, could not be ascertained," the report said. It said the revenue from water usage charges had proved to be only an additional resource mobilisation by J&K Government, especially for power purchase, and has not served the purpose of establishment and buying back of hydro electric projects and for capital investments in transmission and distribution network

Pulls up JKPCC... value of works from Rs 364.19 crore in 2012-13 to Rs 250.65 crore during 2016-17. The public sector undertaking (PSU) firm was dependent on the state government departments or agencies for works on nomination basis and had failed to secure any work on competitive tender basis, the CAG said in its report on revenue sector and PSU (social, general and economic sectors) on the government of J&K for the year ending March 31, 2017, which was tabled in Parliament this week

JKPCC was incorporated with the objective of execution of construction works for the state and central governments and PSUs, carry on the business of builders, contractors, engineers, architects, surveyors, estimators and designers in J&K and curb monopoly of private contractors and provide healthy competition between private and public sectors.

"The company had finalised its accounts up to 2010-11 only. The value of works done decreased from Rs 364.19 crore during 2012-13 to Rs 250.65 crore during 2016-17. It suffered loss of Rs 3.95 crore and Rs 11.69 crore during 2014-15 and 2015-16, respectively, the report said. It said the shortfall in achievement of targets of value of works done remained between 29 and 50 per cent. "Funds ranging between 58.52 per cent and 75.55 per cent only were utilised on works during 2012-17".

The report said the service tax of Rs 5.14 crore paid in excess had neither been reconciled nor refund thereof received. "The company had not submitted revised cost offers, to the extent of Rs 22.66 crore, to reflect enhanced rate of service tax and made payment of service tax at the enhanced rate without actual recovery of Rs 3.45 crore from the project authorities," the report said. It said the company was dependent on the state departments and agencies for works on nomination basis and had failed to secure any work on competitive tender basis. "The quantum of new works obtained declined during 2012-16 from Rs 349.48 erore to Rs 236.03 erore, but increased during 2016-17 to Rs 696.64 erore. Execution of works in excess of the funds released by the project authorities led to accumulation of outstanding balance of Rs 188 crore as of March 2017 and loss of interest of Rs 26.56 crore," it said.

The delay in completion of works led to increase in cost to the extent of Rs 360.87 crore which was mainly due to poor monitoring by company and slow progress.

It said the company had not framed any recruitment and promotion policy and staff had been deployed at different units in an ad hoc manner. The report said JKPCC did not devise any mechanism for ensuring continuous monitoring and internal control

Weak quality control, inadequacy of internal audit and variations amongst performance reports were observed." the report said.

Jammu and Kashmir had 30 working PSUs (27 companies and three statutory corporations) and three non-working PSUs. The working PSUs recorded a turnover of Rs 8,357.91 crore as per their finalised accounts as of September 30, 2017. As on March 31, 2017, the investment (paid-up capital, free reserves and long-term loans) in 33 state PSUs and statutory corporations was Rs 7,426.67 errore, the report said adding the power sector accounted for 43.47 per cent (Rs 3,228.68 erore) of the total investment as on March 31, 2017. The total investment consisted of 21.70 per cent towards paid-up capital and 78.30 per cent as long-term loans, it said. It said the investment has grown by 45.08 per cent from s 5 119 04 crore in 2012-13 to Rs 7 426 67 crore in 2016-17

The two new COVID-related fatalities were reported from Kargil, raising the death toll in the district to 33. The rest of 23 patients died in Leh district since the outbreak of the disease in March. Out of total active cases, 601 are in Leh district and 397 in Kargil district, the officials said, adding that so far, 2971 patients have recovered from the infection in the Union Territory. Fifty-six more people tested positive for coronavirus. These includ ed 48 in Leh and eight in Kargil.

conducting a preliminary verification including spot inspection etc. into the matter prima facie found that the allegations are substantiated," it said, adding that during the verification, it has been revealed that M/S National Infra Construction Company Gutlipora Hyhama, a partnership firm, had sought registration with the DIC Kupwara for establish ing Stone Crusher/Hot Mix Plant. The registration of the plant was to be governed by the Government Order (No. 104/Ind of 2015 dated 14.07.2015), where under the Plant Holder was required to seek the NOCs from the Deputy Commissioner, Kupwara regarding ownership of land, etc, State Pollution Control Board (SPCB) regarding Pollution Control, Geology and Mining regarding location, feasibility and availability of raw material, Forest Department, I&FC and Fisheries Department. The then Office of the Deputy Commissioner, Kupwara had "illegally" issued NOC in favour of the Plant on March 27 2017 in violation of the standing laws and rules regulating the establishment of such plants it said. "The Plant was registered in the name of a partnership firm, which was not having the required title over the land. During the verification, it also surfaced that the land on which the alleged illegal plant was set up was Abi-Awal, but the District revenue officers/officials manipulated the nature and the character of the land by showing same as Gair Mumkin Shart in violation of section 133A Land Revenue Act Syt. 1996 read with the Government Policy regarding change of land use issued vide Govt. Order No. 138-Re (S) of 2016 dated 07.10.2016 to extend undue favor to the beneficiaries," it read.

The verification also revealed that General Manager, DIC, Kupwara provided registra tion to the Plant without the required NOCs from Fisheries and Forest Department.

"The Officers/Officials of SPCB, Geology & Mining, Forest, I&FC were also found to have illegally issued NOCs in violation of Government orders, rules and regulations framed thereunder for the purpose," it added.

The then Deputy Commissioner Kupwara, the crime branch said, also failed to take any further action against the illegal operation of the plant as was mandated under Government Order No. 104/Ind of 2015 dated 14.07.2015, when the complainants and residents brought the issue to his notice.

"FIR has been registered against the then Deputy Commissioner, Kupwara; the then Additional Deputy Commissioner Kupwara; District revenue Officers/Officials; the then General Manager District Industries Centre (DIC) Kupwara; then Officers/Officials of State Pollution Control Board (SPCB); the then District Officers/Officials of Geology and Mining Department, then Officers/Officials of Forest Department; the then Agriculture Officer, Kupwara and beneficiaries including Haji Mohabbat Ali Khan son of Rehmatullah Khan resident Shortpora Hyhama, Kupwara and others for setting up a Stone Crusher/Hot Mix Plant illegally at Gutlipora, Hyhama Kupwara," the statement added.

There have been cases where even PRO holder woman have been denied Domicile since their husband has been a non PR of J&K and it has been after 10 September that may be in view of gender discrimination issue was raised in State Times one such woman has been issued Domicile Certificate but her son has not been yet issued.

It was hoped that atleast after 10th September 2020 seniors in the administration would have brought the deficiencies in S. O. 166 of 18-05-2020 to the notice of Lt Governor who has been every second day expressing his priorities resting in prompt and good governance but since the clarifications / amendments have not yet been put in the public domain it appears that Hon'ble Manoj Sinha LG is not being provided needed inputs. Instead as per the information received Ms Ahana's mother is said to have received a call from concerned Competent Authority (Tehsildar) on 25th September informing her that since her husband is not a PRC holder the her children / girl child is not yet entitled for Domicile Certificate.
