

# Era of working in Silos is over: Dr Jitendra

NEW DELHI: Union Minister of State (Independent Charge) Science & Technology; Minister of State (Independent Charge) Earth Sciences; MoS PMO, Personnel, Public Grievances, Pensions, Atomic Energy and Space, Dr Jitendra Singh on Sunday emphatically said that the era of working in Silos is over. He stressed the need for integrated theme based projects instead of a particular Ministry based or Department based projects.

In an exclusive media interview about his vision for the Ministry of Science & Technology which he took over two months back, the Minister informed that he has started holding regular joint meetings of all the Science Ministries as well as Departments and before the end of this month he will also hold a joint meeting of the Ministers of Science & Technology

from all the States and UTs. This integrated approach will be further extended to include Start-Ups, industry and other stakeholders, he said.

In a novel initiative last week, Dr Jitendra Singh said, representatives

from all the Science Ministries including Science & Technology, Earth Sciences, Atomic Energy, Space/ISRO, CSIR, Biotechnology etc separately engaged in extensive brain storming with each of the different Ministries in Govt of India to work out what scientific applications could be utilised in which sector, ranging from agriculture, railways, roads, Jal Shakti etc. This is keeping in mind that every sector today has become largely dependent on scientific technology, he said.

Dr Jitendra Singh said, our greatest asset is Prime Minister Narendra Modi who not only has a natural predilection for science but is also forthcoming in supporting and promoting science and technology based initiatives and projects. He said, India's scientific prowess is going to have a major role in the making of "Atma Nirbhar Bharat".

Referring to some of India's recent path breaking initiatives which have been universally hailed, the Minister predicted that following the recent Space sector reforms, Indian Private Space Industry is slated to contribute to the core elements of global space economy - space-based services, launch services, manufacturing of launch vehicles and satellites, establishment of ground segment and launch infrastructure - to a considerable extent.

"I can say with all the confidence in my command that the quality of our scientific human resource is far superior to most other developed countries of the world", Dr Jitendra Singh said. Citing the example of Space technology, he said, India is at present a front-line nation and the fact that even NASA procures data obtained by ISRO speaks volumes about our scientific progress.

Elaborate arrangements were made on the occasion by Dr Gopal Parthasarathi Sharma, Secretary and Varinder Singh Jamwal, Additional Secretary of J&K Dharmarth Trust to make the programme successful.

Meanwhile, Advocate Ajay Gandotra, President Jammu and Kashmir Dharmarth Trust, in a handout issued to media, highlighted the lifetime contributions of Maharaja Ranbir Singh for the people of his kingdom. He said that Maharaja Ranbir Singh has made a significant contribution in our history.

Gandotra said that



Maharaja Ranbir Singh was a Persian Scholar and he tried his best to eradicate the illiteracy from the state and during his tenure promotion of education received due attention.

Moreover, he encouraged religious education through the study of classical languages such as Persian, Arabic and Sanskrit.

Believing in providing education for all classes of these subjects he funded a few state institutions like Raghunath Temple

Pathshala; other schools; a library and Ranbir Press in 1882, he added.

The Dharmarth Trust President, while highlighting the warrior qualities of Late Maharaja Ranbir Singh, said that it was he who went on to annex Gilgit which had previously witnessed a rebellion against the state and the princely states of Hunza and Nagar started paying tributes to Jammu and Kashmir during his reign. Even in the field of justice Maharaja Ranbir Singh established a modern judicial system compiling civil laws and compiling criminal laws in the form of Ranbir Penal Code during his reign, Gandotra asserted.

It is pertinent to mention here that Ranbir Singh was the third son of Maharaja Gulab Singh and ascended to the throne in August 1854 and continued to rule till his death on 12th September 1885.

## Will not tolerate any laxity in cruelty against cows: Chandel

JAMMU: Akhil Bharatiya Gurukul & Gausshala Research Foundation (ABG-GRF) National Youth Executive Member, Sunil Sharma on Sunday appointed Adv P S Chandel as the J&K In-charge of Foundation's J&K unit during a programme held here.

On the occasion, Sham Lal Langar, former senior Vice President CCI Jammu was the Chief Guest.

Addressing the gathering, Sunil Sharma said that the Foundation is presently working in 16 states including UP, Rajasthan, Maharashtra, Assam, Kerala and J&K, and soon it will become a pan India organization with its branches spread over the entire country. He said that the Foundation is aimed at promoting a culture in the country which is based on traditional values where cows have special significance in the life of people and the same were respected like mothers.

He said that the Foundation's target is to spread awareness across the country to connect people to

their roots and tell them the difference between rich Indian Sanskriti and modern day world culture which is steering people towards suffering and misery.

Advocate PS Chandel, in his address, expressed gratitude to the National Executive Member for giving him the opportunity to serve the society and work in the direction to educate people about the rich Indian culture and values which no other society practices in the world.

He demanded implementation of Article 48 of the Indian Constitution in letter and spirit in the Jammu and Kashmir Union Territory, which prohibits cow slaugh-

tering.

Citing the recent ruling by the Allahabad High Court wherein it was said that the cow should be declared the national animal and that Gau Raksha (cow protection) should be included as a fundamental right of the Hindus, Advocate Chandel said that government should immediately implement this verdict across the country and especially in J&K.

He also sought full imple-

mentation of the Municipal Act in which strict action should be taken against people who after milking the bovines leave them on roads for feeding which becomes a cause of road accidents.

Advocate Chandel appealed to the Lt Governor Manoj Sinha and Commissioner JMC to ensure that no bovine animal is subjected to cruelty of any sort.

Chandel said that he will not tolerate any sort of laxity

in this matter as cows are sacred animals and cruelty against them will not be tolerated come what may. He also asked the youth to visit Gausshalas on a regular basis to preserve the traditional values and also set an example for the coming generations.

Sham Lal Langar said that the need of the hour is to connect the people with the rich cultural background of the country especially with regard to religious, historical, economic, cultural and sociological significance of the sacred cows as the same promote eco-friendly living in India.

Among others who were present included State President Rajinder Kakkar; Vice President Sham Lal; Vice President Narendra Singh; State General Secretary Dr Bhardwaj and Treasurer Dr Ohja.

## Refraining Govt employees to get engaged in part-time jobs at DDK, AIR

SRINAGAR: In another significant initiative, the Directorate General of Accounts & Treasuries has issued an advisory for such Government employees who are engaged or working in any other department on a casual or part-time basis.

The advisory reads, "Every Government servant is required to maintain absolute integrity, devotion to duty and do nothing which is unbecoming of a government servant. A Government employee is bound by Jammu and Kashmir Government Employees (Conduct) Rules, 1971 all the time during his service. These rules contain provisions covering a wide range of topics governing employees' conduct from public to private life. Rule 13 of these rules is related to 'connection with press or Radio' which among other things prohibits a government employee from participating in a radio broadcast or contribute an article or write a letter to a newspaper or periodical either in his own name or anonymously, pseudonymous or in the name of any other person except with previous sanction of Government/prescribed authority. However, despite explicit rules in position, some employees have been reportedly participating in Radio/ Doordarshan programmes in different capacities like script writers, casual readers, anchors, interviewers etc, as alleged grievances logged by (Syed Riyaz) on grievance portal. Notably, the Advisory was issued soon after a serious note was taken by Div Com Kashmir in the matter and details of Government employees of all departments working on part-time basis with Doordarshan Kendra Kashmir and All India Radio (AIR) Kashmir; were sought by the divisional administration Kashmir. In an official communication issued to Director School Education, Information,

Horticulture, Social Welfare and Handicrafts Departments of Kashmir; the Additional Commissioner Kashmir; who is also the Divisional Vigilance Officer; said that some employees are working as artists in AIR Kashmir and Doordarshan Kendra without having proper sanction of the government which is mandatory under Jammu and Kashmir Government Employees (Conduct) Rules 1971.

The Heads of all Departments and Directors were directed to furnish details of all those employees, in a prescribed format devised by the divisional administration containing name of employee, department, designation, details of postings, name of programme in which employee is participating and whether the employee has got government sanction under rules or not.

Meanwhile, sources told the STATE TIMES that on September 7, 2021; the Head of Regional News Unit (RNU), Doordarshan Kendra Srinagar also issued an official note for casual staff, who are Government employees. The note reads, "All those Government employees who are empanelled at this RNU in any category like casual News Editors, News Readers, Copy writers, Translators, Computer operators and Anchors etc, and are being booked at the RNU for News Bulletins on monthly basis, are required to submit an NoC from their respective Departments. NoC should be submitted to the RNU latest by the end of this month failing which it will not be possible for the RNU to continue their casual assignments." Despite clear-cut rules in place, the officials said that some employees have been reportedly participating in Radio/Doordarshan programmes in different capacities which compelled the Department to issue an advisory.

## BJP failed to honour commitment of declaring holiday on Maharaja Hari Singh birthday: Congress

JAMMU: Bharatiya Janata Party (BJP) has failed to honour its commitment to declare holiday on the birthday of Maharaja Hari Singh in seven years of their rule in Jammu and Kashmir and it proved to be "Bahut Jhoothi Party", said Chief Spokesperson Ravinder Sharma.

## Bar license holders discuss grievances with Div Com Assured for expeditious issuance of NOCs by all concerned departments

JAMMU: Divisional Commissioner, Dr Raghav Langer on Sunday discussed issues related to issuance of NOCs for renewal of license of liquor Bars with concerned officers and stakeholders. Among others, Excise Commissioner, Rahul Sharma; Assistant Commissioner General, Rakesh Dubey; ACR JMC, Superintendent of Police, Jammu South; besides President Chamber of Commerce Jammu, Arun Gupta; President Bar & Trade association and other members were present.

The Bar Licence holders sought intervention of the Divisional Commissioner for resolving the problems they are facing in getting timely NOCs from various departments which are mandatory for renewal of their licenses.

Pertinently, as per the new excise policy the bar owners had to take fresh permission for renewal of their licenses. The Excise Department has sought renewal of licenses and No Objection Certificate from the 21 departments to be obtained by the owners/operators.

The Excise commissioner who was also present in the meeting apprised that necessary instructions have been issued to concerned departments for receiving applications and issue NOCs.

It was informed that before renewal of the license by the excise department, the police



authorities have to submit a report to the district administration about the credentials of the owner/operator, status of land on which the bar is constructed by the revenue department and other clearances from the Jammu Municipal Corporation.

The final report of each and every bar operator will be handed over to the Excise Department by the district administration for further action. The Assistant Commissioner General informed that they have received 37 applications and all have been cleared. SP South assured that all the 95 NOCs would be sent to the District Magistrate within 3 days. Similarly the ACR JMC apprised the Div Com about the number of applications received and cleared so far. A total of 206 Bar Licenses (JKEL-3/4/4C) for the whole Jammu Division are under renewal with the Excise Department. The Divisional Commissioner also discussed in length the recent order of the Hon'ble High Court in this regard and its implications.

The Div Com instructed the concerned officers to expedite the process and facilitate the issuance of NOCs by their respective departments. He also assured the delegations that all their NOCs would be expedited for timely renewal of their license and all possible help shall be rendered by the Department.
