## Div Com invokes Imams, Khateeb for CAB enforcement in Srinagar

SRINAGAR: The Divisional Commissioner (Div Com), Kashmir, Pandurang K. Pole on Saturday held a meeting with prominent religious personalities of district Srinagar including Imams and Khateeb of shrines and mosques regarding the strict enforcement of Covid Appropriate Behaviour among the people in view of possible third wave of Covid-19.

Chief Executive Officers, Waqf Board, Mufti Farid ud din and other waqf board officers were also present in the meeting. At the outset, Div Com appreciated religious scholars for their role and cooperation since the last one and half year of pandemic for educating and sermonizing people, which helped to the large extent to save people from the deadly pandemic.

He called them as social influencers and appealed to them to continue sensitizing people about adopting CAB and not to lower their guard to save themselves. He informed them that even the developed countries including UK, USA and Italy, where healthcare system is sophisticated, suffered due to third wave where virus created havoc and emphasized on them that it is their religious as well as social obligation to educated people and help in the implementation of CAB as per the guidelines issued by the government from time and time. He sensitized that it is highly imperative that CAB is observed in letter and spirit in the mosques and shrines where people assemble to offer prayers. He stressed on them to ensure wearing of masks and maintenance of physical distance.

On the occasion, Imam & Khateeb of Dargah Hazratbal, Dr Kamal din Farooqi, presented the measures taken by the imams and responsible committee members of shrines and mosques regarding the observance of covid guidelines and ensured that they will continue to lend support to government in containment of viral infection.

SRINAGAR: Directorate of Handicrafts & Handloom Kashmir and SKUAST on Saturday signed an MOU at SKUAST, Kashmir to test the Pashmina fibre at Shuhama, Ganderbal now onwards. The testing of the fibre was done by the PTQCC lab of the Handicrafts & Handloom Department. In view of the overwhelming response of getting the GI Mark at PTQCC Lab and to concentrate only on GI Marking, the Department has found that the Pashmina testing lab of SKUAST at Shuhama is fit for doing the tests and henceforth all the testing of Pashmina fibre will be done at Shuhama. As an additional facility the Pashmina Lab of SKUAST at Shuhama will furnish the results through email, thus helping in increasing the overall efficiency and expeditious delivery of results. The PTQCC Lab at Baghi-Ali Mardan, Nowshara Srinagar hence forth will do only GI Certification. The rates charged by the SKUAST shall be Rs 500/-per sample. Rates have been reduced keeping in view of the demand projected by various organizations dealing in the concerned trade. This arrangement shall be beneficial for both the organization.
