Three arrested with heroin, sharp-edged weapon

JAMMU: Continuing its drive against drug menace, Akhnoor Police arrested three drug peddlers and recovered 12 gm heroin and a sharp-edged weapon from their possession.

As per details, at a Naka established by a team from Police Station Akhnoor led by SHO Akhnoor Inspr Hilal Azhar, three different suspects, who were coming in a vehicle bearing temporary No. JK/TMP/2019/51935, were intercepted. On search, 12 gm heroin, a sharp-edged weapon (Kirch) and a Baseball bat was recovered from possession of suspects identified as Anil Singh, son of Madan Singh, resident of Hamirpur Sidhar, Tehsil Khour; Rahil Bhagat, son of Kasturi Lal, resident of Bhagwati Nagar and Abhi Sharma, son of Vijay Kumar, resident of Talab Tillo, Jammu. The trio was arrested and FIR No 248/2021 under sections 8/21/29 of NDPS, 4/25 of Indian Arms Act, 184 of MV Act was registered against them at Police Station Akhnoor. The arrests and recoveries were made under supervision of SDPO Akhnoor Varun Jandial.

Three absconders nabbed

JAMMU: Police on Thursday nabbed three absconder, who were evading arrest for many years.

As per details, Mendhar police arrested an absconder, who was evading arrest from last 16 years. Accused, identified as Mohd Sageer, son of Yaar Mohammad, resident of Gohlad vilage of Mendhar, was booked under FIR No 73/2005 under sections 454, 380 of RPC at police station Mendhar. A warrant against him was also issued by the Court.

In another action, Nowshera police arrested an absconder who was evading arrest in a case of kidnapping and rape registered in 2015.

The accused, identified as Mohd Azam, son of Mohd Shafi, resident of Rajal Thathi village Nowshera, was absconding since 2015 in FIR No 30/2015 under sections 363/376/109 of RPC at Police Station Nowshera. A police team headed by SHO Nowshera Pankaj Sharma arrested the absconder, who was produced before the court of law.

Meanwhile, a man booked for culpable homicide and absconding for last seven years was arrested in Samba. Madan Lal was booked for rash driving and culpable homicide at Samba Police Station. He was evading arrest since 2014 but acting on specific information, a police team arrested him from Rahyian village in Samba.

AM from reliable sources that a pregnant woman namely Zubaida Begum, wife of Mohd Saleem Kumar, resident of Darshipura Banihal was found lying in a pool of blood with a slit throat at her home at Darshipora.

SSP Ramban P D Nitya, in press statement, said that after getting information, a police team from Police Station Banihal was immediately rushed to the spot along with SDPO Banihal. SSP Nitya added that sensing some mischief, Police Station Banihal has taken cognizance of the matter and FIR No. 171/2021 under section 302 of IPC has been registered.

SSP Ramban informed that nothing can be ruled out at this stage, as we are investigating the case from all possible angles and if any foul play found would be found, culprit/culprits would be taken to task.

While addressing media, SHO Banihal Nayeem Mattoo said that a board of doctors had conducted post-mortem and report is awaited.

Rs 24,450 fine recovered from SoPs violators in Ramban

JAMMU: RAMBAN: Continuing enforcement drive to implement COVID protocols across the district Ramban, the Enforcement teams on Thursday fined scores of violators for roaming without wearing face masks and not maintaining physical distance.

The enforcement teams, during the inspection in their respective jurisdictions, recovered a fine of Rs 24,450 taking the total amount fined since April 1, 2021 to Rs 54,11,300. The Enforcement officers urged people to wear face masks and maintain physical distance besides taking COIVID vaccination doses at their nearest CVC.

District Immunization Officer, Ramban, Dr Suresh informed that as many as 3572 persons were administered first and second COVID vaccine doses across Ramban district. As per daily bulletin issued by the Chief Medical Officer, Ramban, Dr Mohammad Fareed Bhat, the Health Department has collected 1,481 samples including 348 RT-PCR and 1,133 RAT samples besides administering COVID vaccine to 3572 persons at dedicated Vaccination Centres in the district.

Drug peddler arrested, contraband recovered

KULGAM: Continuing its efforts to eradicate menace of drugs from the society, Police on Thursday arrested a drug peddler in Kulgam and recovered contraband substance from his possession.

Officers from Police Station Qazigund at a checkpoint established at Check Wangund Crossing near NHW intercepted a suspect, who was identified as Mushtaq Ahmad Katoch, son of Mohammad Katoch, resident of Ukhral Banihal. During checking, officers recovered 2 gm Brown Sugar from his possession.

He was arrested and shifted to police station where he remained in custody. Accordingly, FIR No. 231/2021 under relevant sections of law has been registered in Police Station Qazigund and investigation has been initiated.

Army Jawan shoots self in Keran

Lokinder Singh of Army's 6 Rashtriya Rifles allegedly shot himself with his service rifle at a camp in Keran sector near the Line of Control at around 10.30 PM on Wednesday, the officials said. Singh was rushed to the nearest military health facility where he was declared dead on arrival. It was not immediately clear as to why the soldier took such an extreme step.
