on Thursday and the one foiled in the Uri sector on September 18-19. Asked about the identity and nationality of the slain infiltrators, the Army officer said according to the documents recovered from their person, "one of them was a Pakistani while we are not sure about the other two yet". Giving details of the five-day combing operation in Gohalan and adjacent areas in Uri, he said the operation, as of now, has ceased. "There were six terrorists, four on the other side of the LoC and two had managed to enter our side of the territory. They were challenged and after a brief gunfight, they went back. The combing operation of the rugged terrain and dense vegetation took time but as of now, there are no remnants of that group here," he added. Asked about the necessity to shut down the telecommunication facilities in Uri, Inspector General of Police, Kashmir zone, Vijay Kumar said it was done in order to ensure that the infiltrators could not stay in touch with their handlers in Pakistan. Kumar said the recoveries indicate that there is a new trend of Pakistan sending more pistols to Kashmir so that the "hybrid terrorists" can easily carry out their tasks and slip back into normal life. "We have seized 97 pistols this year...pistols are easy to transport and hide. The hybrid terrorists carry out the one or two tasks given to them and go back to their normal life. If you see, in 85 per cent of the attacks, pistols were used and all policemen targeted were unarmed," he added.

Later on, during encounter the said newly active terrorist got neutralised. One pistol and ammunition were also recovered from his possession," the police added.

In the current instance, the accused Asadullah enlisted the help and was actively abetted in running the module by his nephew Naseer Ahmed Parray resident of Hajin, Haseena resident of Sheeri, Khurshid Ahmad resident of Naidkhai and others. The group was in continuous contact across the border and would receive detailed instructions for their day to day activities. Apart from recruiting individuals and arranging arms and ammunition for them, the group was also involved in motivating youth to carry out petrol bomb attacks on government buildings and protected persons and carrying out reeceve of potential targets. A huge quantity of incendiary materials was also recovered from them which were to be used for making Petrol Bombs. On the disclosures made by the accused, two individuals identified as Rafeeq Ahmad resident of Naidkhai and Hilal Ahmed Shah resident of Shah Mohalla Hajin who were about to join terrorist ranks at the instance of this group have been detained and are being questioned. In this regard, a case has been registered and further investigation is in progress.

active cases in the UT, while the number of recovered patients was 3,22,554, the officials said. The death toll in the UT due to the pandemic was 4,419 as no fresh death was reported in the past 48 hours. The officials said there were 46 confirmed cases of mucormycosis (black fungus) in the UT as no fresh case was reported since Wednesday evening. Meanwhile, Ladakh recorded seven fresh COVID-19 cases, taking the infection tally to 20,750 while the active cases in the union territory climbed to 148, officials said. Ladakh has registered 207 Covid-related deaths -- 149 in Leh and 58 in Kargil -- since the outbreak of the pandemic last year. All the fresh cases were reported in Leh, they said. A total of 1,927 samples in Ladakh, including 925 from Leh and 995 from Kargil, were found negative, they said. There was no death reported due to Covid in Ladakh on Wednesday. With this, the total number of COVID-19 active cases in Ladakh has gone up to 148 including 144 in Leh and four in Kargil district.

continue to diligently follow the five pillars of COVID-19 Management -- "Test-Track-Treat-vaccinate and adherence to Covid-appropriate behaviour". The Centre said there should be strict adherence to limits on gatherings linked with availability of space to ensure effective physical distancing and use of volunteers to aid thermal screenings, to enforce use of masks and physical distancing. "Closed circuit cameras may also be utilized to monitor compliance to physical distancing and use of masks," the Centre told states in the letter issued on Tuesday. As an abundant caution, the Centre said states can continue with night curfews, weekend curfews and other restrictions to highlight that COVID-19 is still not over and to influence adherence to Covid-appropriate behaviour. "States shall closely monitor the case trajectories across all districts on a daily basis to identify any early warning signals and shall ensure imposition of restrictions and adherence to COVID Appropriate Behaviour as a non-pharmaceutical intervention to control the spread of infection," the Centre said. The government also announced that differently-abled people and those with restricted mobility and special needs will be given COVID-19 vaccine doses at their homes. The relevant orders and advisory have already been issued to states and union territories, officials said, adding authorities concerned have been asked to initiate the "process of line-listing" these beneficiaries and their vaccination "at the earliest". NITI Aayog member (Health) Dr V K Paul said, "I am pleased to inform that we have made a provision for those people who are disabled, have restricted mobility or have some special needs and are not able to reach the vaccination centre, they can get vaccinated at home in a supervised manner following SOPs (standard operating procedures)."

State governments, district administrations and municipal corporations will be engaged in this exercise, he said. "We request the prime minister and the home minister to intervene in the matter, he said.

Before touching Katra town in Reasi district, it will pass through 26 villages, and once completed, the national capital will be directly connected to the holy town, the base camp of Shri Mata Vaishno Devi. The National Highways Authority of India (NHAI) has already floated two separate tenders for works under the Delhi-Amritsar-Katra Expressway project on the hybrid annuity model (HAM). The Authority has also invited bids for construction of a four-six-lane access-controlled expressway from a junction with Hiranagar road near Gurha Baildaran village to Junction with Jammu Ring Road (NH-244A) near Jakh village of Delhi-Amritsar-Katra expressway in Jammu & Kashmir. Project Director NHAI informed that the DPR for the project is under progress and work is targeted to commence in the current financial year. The bids have been invited for Pathankot to Jammu stretch. The tender documents for the remaining Brownfield stretch from Kunjwani to Domel upto Katra via existing NH-44 & NH-144 will also be finalized by mid of Oct 21. The work for Forest and other statutory clearances is also under progress. It was informed that work will be started from December 2021 and is expected to be completed in December 2023. The Div Com discussed in detail the status of land acquisition. It was informed that 93 percent land for main carriage and 74 percent for expressway has been acquired in district Samba. It was further informed that the land has been identified for Wayside amenities, Toll plaza and interchange in district Samba. The Div Com directed the Deputy Commissioner Samba to expedite the process of land acquisition for smooth execution of work on the prestigious project. The NHAI officials apprised the Div Com about the alignment of the Expressway through presentation. The Div Com also discussed in detail all the packages and asked the NHAI officials to establish contact with Airport authorities and Metro lite for resolving the alignment issues, if any due to Jammu metro light and Jammu Airport Expansion project. The meeting was attended by Deputy Commissioner Samba, Anuradha Gupta; Project Director NHAI, Assistant Commissioner Central, SDM Vijaypur; Deputy Manager NHAI, ACR Samba and other concerned officers.

system, the bench, also comprising Justices L Nageswara Rao and Surya Kant, said. The top court directed the Director-General of the National Informatics Centre, Home Secretaries of all states and UTs, and their DGP or IGPs to ensure smooth and

successful implementation of the FASTER system and coordinate with its Registry.

FASTER comes into being after the bench had taken suo motu cognizance of delay in the release of convicts even after granting of bails on the grounds such as non-receipt or non-verification of the judicial orders.

We are concerned about the plight of the jail- inmates who are not released despite the bail orders passed by this court due to delay in communication of such orders. It is high time to utilize the Information and Communication Technology tools for efficient transmission of Court's orders, the order said.

Taking note of the suggestion made earlier in the day by amicus curiae and senior advocate Dushyant Dave, the bench said the issue of requisite amendment in the Rules and Procedure for the Supreme Court of India will be taken up on the administrative side.

It further directed all the duty-holders (lower courts, jails) to amend their Rules /Procedure/Practice/directions forthwith to recognize the e-authenticated copy of the order of this court communicated to them through the FASTER system and shall comply with the directions contained therein.

The bench took note of the proposals prepared by the Secretary General of the top court and said they contained the pre-requisites and the timelines to work out the implementation of the FASTER system.

It took note of the fact that only 19 states have submitted their compliance report concerning the availability of internet facilities in prisons and directed the other states and UTs to do the needful.

The order noted the issue of non-availability or partial availability of internet connectivity in the state of Arunachal Pradesh, Nagaland, Assam, and Mizoram and ordered that remedial measures be taken.

The bench will now take up the matter after two weeks.

Earlier in the day, the top court reserved its order after taking note of the report of its secretary general Sanjeev S Kalgaonkar and the submissions of Dave.

Referring to Supreme Court Rules, the report said they enable the Registry to transmit a certified copy of the judgment or order either in physical or electronic form.

It is proposed that the e-authenticated copies of the Record of Proceedings/orders, digitally signed by the officer authorized in this respect may be transmitted through the FASTER system to the duty-holders of the justice system, Kalgaonkar said in his report.

The report said the system proposes to provide a secure communication channel between the duty-holders and two-factor authentication will further ensure authorized user access on the email domain.

In order to create an authentication mechanism, a unique QR Code is proposed to be appended on each of the pages of judicial record which will lead the user to the website of the Supreme Court where the relevant Record of Proceedings/orders are uploaded, for the purpose of verification, the report said.

Tourism bodies for revoking ban on ‘Darbar Move’ tradition

JAMMU: The Jammu Paryatan Vikas Mandal (JPVM), Jammu Katra Tourism Welfare Organization (JKTWO) and All Jammu Tourist Trade Federation (AJTTF) have expressed remorse over the statement of Lt Governor Manoj Shlnha in which he has justified his decision of doing away the 'Darbar Move' old age tradition leaving the Jammu in a distress in concern of tourism trade industry.

In a joint press statement, the chairman JPVM Inderjeet Khajuria, President JKTWO Raman Sharma and Chairman AJJTF Mahesh Padha said that the Darbar Move tradition was initiated by the then Hindu Raja and it is more than 150 years old, which has no concern with the petty politics of present era.

They said that Jammu did not have any tourism spots for which the tourists are supposed to visit the Jammu to fulfill the loss incurred by the stopping of Darbar Move.

They said that more than 5 lakh souls were dependent on the tourism and were wholly dependent on these six months of Darbar Move. They said that the Darbar Move tradition must be continued so that the Jammu may not be pushed back to 1947 era as it was without tourists and with very poor economy.

It is pertinent to mention that the Jammu tourism has been pushed behind due to discriminatory attitude of the previous governments, second the rail line extension of Jammu to Katra and now due to stoppage of Darbar Move tradition.

They said that before developing the tourism related projects supposed for Jammu in past, the stoppage of Darbar Move is one of the greatest discrimination with Jammu, which should not be done atleast on the hands of Lt Governor. The tourist projects which are still incomplete included Wild Life Manda Zoo, developing of Suchetgarh Border, Artificial Lake, beautification of Tawi Banks on the pattern of Sabarmati, development of project Shri Amarnath Yatra Base Camp Bhagwati Nagar, opening of Mubarak Mandi for tourists, development of Shri Raghunath Mandir on the pattern of Golden Temple Amritsar and other projects proposed and in pipeline then such step of stopping the Darbar Move be taken.

They alleged that the wrong notions has been spread that with the Darbar Move there could be a loss of Rs 200 crore, which is factually not correct and the money is not wasted otherwise it is properly used in the welfare of small tourism traders including vendors, besides good portion goes employees of government and it is not a scam or scandal.

They said that some part of the money goes to JK Road Transport Corporation, some part of the money goes to middle class hotels and some part of the money goes to small carriages. They further said that it seems that this has been done to with a sole aim to damage the economy of Jammu.
