CRIME REPORT

Bootlegger held with 20 ltrs of illicit liquor

AKHNOOR: Police on Saturday arrested a bootlegger and recovered 20 litres of illicit liquor from his pos-session.

As per details, in an act of alertness and prompt action, Police Station Akhnoor swung into action on receiving an information regarding manufacturing of illicit liquor by one Kuldeep Sharma, son of Mangi Ram, resident of village Jamotian Tehsil Akhnoor at his home. On this, a special party from Police Station Akhnoor led by SHO Akhnoor Insp Hilal Azhar raided aforesaid location and arrested the accused. During search, 20 lts of illicit liquor



along with utensils were recovered from his possession. He was arrested and FIR No. 250/2021 under sections 48 (b) (d) (e) of Excise Act was registered at Police Station Akhnoor. The overall arrest and recoveries were made under supervision of SDPO Akhnoor Varun Jandial.

Theft cases solved; stolen items recovered, 2 arrested

KATHUA: Kathua Police under overall supervision of SSP Kathua on Saturday solved a theft case by arresting 2 thieves and recovered stolen items from their pos-session.

As per the details, a case was registered at Police Station Kathua in connection with theft vide FIR No. 370/2021 under sections 454/380 of IPC. Acting on the same, a party of Police Post Industrial Estates Kathua led by Insp Yash Paul Sharma Incharge Police Post Hatli under the supervision of DySP Headquarters Shammi Kumar succeeded in arresting two suspects. During sustained questioning, both suspects confessed their involvement in theft and on their disclosure stolen items viz. 1. one golden ring (approx. 4 grams); One Samsung Camera; one Canon Camera; one Yashica Camera; one pair of Silver Anklets along with 3 silver coins were recovered. The accused were identified as Mehboob Akhter, son of Shamas Din and Irshad Ahmed, son of Suleman, both residents of Dodla, Tehsil Basohli District Kathua. Further investigation of the case is going on and their involvement in

any other case cannot be ruled out.

Trucker arrested with over 13 Kg poppy straw

JAMMU: Police on Saturday arrested a trucker and recovered over 13 Kg poppy straw from his possession.

As per details, a party of Police Post Narwal apprehended a truck driver namely Kirpal Singh, son of Chatar Singh, resident of Gundah, Tehsil Khwass, District Rajouri, at present Mishriwala, Jammu, while driving a vehicle (Jk02AR/3044) near Sabzi Mandi and recovered 13 Kg 450 gm of poppy straw like substance from his possession.

He was arrested and FIR No. 314/21 under sections 8/15 of NDPS Act was reg-istered against him at Police Station Bahu Fort.

Videos of verbal spat between two BJP leaders go viral

SRINAGAR: A verbal duel broke out between two BJP leaders at a party meeting here shortly before Union Civil Aviation Minister Jyotiraditya Scindia's arrival on Saturday.

Videos of the verbal spat, some recorded by reporters present at the BJP's office in Jawahar Nagar, went viral on social media.

Minutes before the Union minister's arrival, an argument broke out between BJP leaders Ali Mohammad and Mohammad Ashraf.

The argument became intense and two leaders were stopped by others present there from getting into a fistfight, according to the videos.

Media personnel present at the venue filmed the duel on their smartphones and the videos of the incident were posted on several social media platforms.

A party leader said there was an argument over a non-issue which turned into an altercation, but the other party leaders promptly resolved the matter before the Union minister's arrival.
