

Bootlegger arrested with 28 bottles of illicit liquor

3 drug peddlers arrested, contraband recovered

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, Police on Monday arrested 3 drug peddlers in Bandipora & Handwara and recovered contraband substances from their possession.

In Bandipora, acting on specific information, a Police party from Police Station Sumbal under the supervision of SDPO Sumbal Surinder Mohan at a checkpoint established at Bapipora Ajas intercepted a vehicle bearing registration number JK15A-8320 driven by Manzoor Ahmad Rather, son of Mohammad Maqbool Rather, resident of Bapipora Ajas Sumbal. During checking, officers were able to recover 600 Capsules of Tramadol Hydrochloride from his possession. He was arrested and shifted to Police Station where he remained in custody. Vehicle used in the commission of crime has also been seized.

In Handwara, officers from Police Station Vilgam at a checkpoint established at Dolipora junction intercepted a vehicle bearing registration number JK09C-1530 with two persons onboard.
