Subject: Advertisement for Establishment of Mini Sheep/ Goat Farms under the scheme "Infrastructure for welfare of Tribals" for the year 2022-23.

Applications on the prescribed formats are hereby invited from the interested individual/ Group of Individuals/Self help Groups/Cooperative Societies/FPO/un-employed youth of either gender of Schedule Tribe (ST) community of District Udhampur for the Establishment of Mini Sheep / Goat farms (10 Ewes/Does + 01 Ram/Buck) on Participatory mode under the " Infrastructure for welfare of Tribals" during the year 2022-23. The application forms along with other details of scheme are available with this office as well as the office of the SDO Ramnagar and all Veterinary Assistant Surgeons of Sheep Husbandry Department Udhampur.

Scheme :

- Establishment of Mini Sheep/ Goat Farm (10 Ewes /Does + 01 Ram/ Buck) on Participatory mode.
- Unit Comprising of 10 Sheep/ Goat + 01 Ram / Buck to be supplied initially free of cost by the department only to the beneficiaries having Scheduled Tribe category certificate after executing an agreement as per the prescribed format for retrieval of animals .
- Retrieval of equivalent no. of animals of female progeny shall be in a phased manner from the 3rd year of establishment @ 02 Ewes/ Does per year.
- The progeny to be retrieved should be 1.5 to 2 years of age with a minimum body weight of 25 - 30 kgs.
- Retrieved livestock shall be utilized for establishment of fresh units.
- Insurance of livestock for 1st year shall be borne by the Department and from 2nd year onwards insurance premium to be borne by the beneficiary for next five years which is compulsory.
- Efforts will be made to cover minimum of 10% Women beneficiaries.
