ORDER
1. Whereas, as per the provisions of the Arms (Amendment) Act, 2019 notified on 13th December, 2019 and as per the amended provisions under section 3(2) of the Arms Act, 1959, a licensee in possession of more than two firearms is permitted to retain with him/her any two of such firearms and must deposit his remaining firearms with the Officer in-Charge of the nearest Police Station or with a licensed dealer or in a unit armoury if he is a member of the armed forces so the Union.
2. Whereas, office of the undersigned had issued order no. 902/DMJ/22 dated 28.06.2022 directing the 77 persons holding more than 2 weapons to submit the fire arms and the same was also published on 29.06.2022. A second Order was issued by this office vide no. 1176-81/DMJ/22 dated 18.07.2022 following which individual notices were served to the defaulters via SHOs concerned.
3. Whereas, on perusal of record, it has been found that 48 numbers of defaulters have not deposited the extra arms as required.
4. Now, therefore the below mentioned persons are hereby directed to showcause within 7 days why their individual arms license should not be revoked for failure to comply with section 17 (B) of the Arms Act. 1959 despite repeated notices, orders and reminders.
