## Two missing girls traced, reunited with families

As per details, a complaint was registered at Police Station Bishnah by a person stating that his sister went missing from her home. In this regard, a missing report was registered at Police Station Bishnah on September 10, 2022 and investigation started. As per details, a team of Police Station Lakhampur led by Insp Vijay Kotwal SHO Lakhampur under supervision of DySP DAR Kathua Sukhdev Singh during Naka checking duty near Maggar Khad area, noticed movement of a suspicious truck (JK02BT-6357) and signaled it to stop for check-ing. During checking of vehicle, 12 bovines were found laden in vehicle and rescued on the spot while vehicle was also seized. FIR No. 80/2022 under section 188 of IPC, 11 of PCA was registered at Police Station Lakhampur and further investigation started.

While in another instance, team of Police Station Hiranagar led by Insp Sunil Kumar SHO Hiranagar under supervision of SDPO Border Pankaj Soodan during Naka checking duty near Londi Morh noticed a truck (JK02AP/8887) and signaled it to stop for checking. Sensing danger, driver of vehicle managed to flee leaving behind the vehicle. On thorough, 13 bovines were recovered from the vehicle and rescued on the occasion and vehicle was seized. FIR No 127/2022 under section 188 of IPC, 11 of PCA Act was registered at Police Station Hiranagar and investigation started.

## Bootlegger arrested, illicit liquor seized

## Tanker driver arrested with 17 Kg poppy straw

RAMBAN: Police on Monday nabbed driver of a tanker and recovered 17 Kg poppy straw from vehicle.

As per details, a Party of Police Station Chanderkote headed by SHO Chanderkote while on Naka checking intercepted a Gas Tanker (PB03AT 3234) driven by one Mushtaq Ahmed, son of Gh Rasool Koka, resident of Chiveli Senabhatti, Tehsil Pogal Paristan, Ramban. During checking of tanker, police recovered 17 Kg poppy straw like substance from a plastic bag. On questioning, the driver disclosed that he was carrying contraband for selling purpose. He was arrested and FIR No. 140/2022 under section 8/15 of NDPS Act was registered against him at Police Station Chanderkote. Investigation of the case has been entrusted to PSI Meenakshi. The overall recovery was carried out by police party headed by Insp Padam Dev Singh SHO Chanderkote under the supervision of Pardeep Singh Sen DySP Hqrs Ramban with overall supervision of SSP Ramban, Mohita Shama.





# SHRADHANJALI


**Swami Swaroopanand Saraswati** was born as Pothiram Supadhyay on September 2, 1924 at Dighori village in Seoni district of Madhya Pradesh.

He was a disciple of Shankaracharya Brahmananda Saraswati, Jyotir Math (1941-1953) and of Shankaracharya (disputed) Krishnabodha Ashrama, Jyotir Math (1953-1973). In 1950, his revered Guru Swami Brahmananda Saraswati made him a Dandi Sanyasi. Swami Swaroopanand also became President of Akhil Bharatiya Ram Rajya Parishad, established by Swami Karpatri Maharaj at a very younger age. After Swami Krishnabodha Ashrama's demise in 1973, the title of Shankaracharya Jyotir Math Badrinath was passed on to Swami Swaroopanand Saraswati. Later, he was also christened as Shankaracharya, Dwarka Peeth in 1982.


He was at forefront of many independence struggles during his early life. At a meager age of 19 years, he had to spend over a year in jail, however, he continued with his Tapasya and Sadhana even in those tough circumstances. He served wholeheartedly as President of Ram Rajya Parishad. Later, he was jailed three times between 1954 and 1970 because he was a part of movement that intended to ban cow slaughter.

He ran Ashrams efficiently in various parts of India. His Ashram in Singhbhum district of Bihar made successful efforts in re-conversion of Christians to Hinduism, which were unethically converted to Christians in past during colonial rule.

Swami Swaroopananda Saraswati is followed by lakhs of people from across the world. He was internationally revered and respected by people from all ethnicities. Speaking about his relationship with all other contemporaries, he held high regards for all of them. Swami Swaroopananda Saraswati left his mortal coil in Narsinghpur on September 11, 2022, at an age of 98 years.
