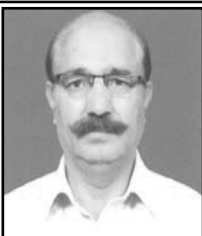

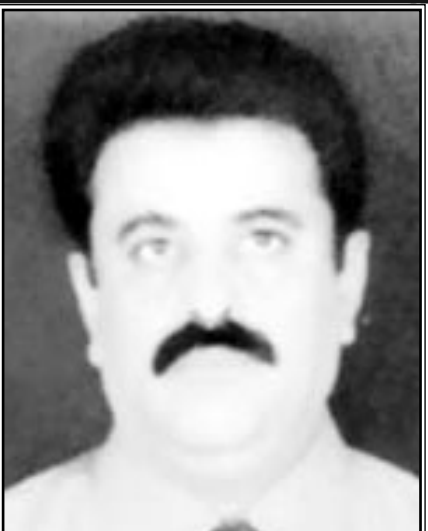

# CRIME REPORT

## 2 drug-peddlers arrested, contraband recovered

HANDWARA: Continuing its efforts to eradicate menace of drugs, police on Saturday arrested two drug peddlers in Handwara and recovered contraband substance from their possession.
