## Committee on Coordination for Justice Delivery System meets at District Court Samba

SAMBA: On the directions of the High Court of Jammu & Kashmir and Ladakh, a meeting of the Coordination Committee for Justice Delivery System was today held for the quarter July-September 2022 here in the District Court Complex, Samba.

The meeting was chaired by Sonia Gupta, Principal District & Sessions Judge, Samba and attended by Arvind Sharma, Chief Judicial Magistrate Samba, besides the officers from Police and Civil Administration.

Discussion on the issues concerning ways and means for effective, efficient and timely rendering of justice to the litigants, the infra-structural and security issues faced by the Judicial Institutions in Samba District; and ways and means for developing and improving the system as a whole were held.

The Principal District & Sessions Judge, Samba called upon all the stakeholders to work in tandem to strengthen the justice delivery system and to maximize the judicial output.
