8 vehicles seized for illegal mining

JAMMU: In a quest to stern menace of illegal mining, a multi-pronged strategy was

devised by Jammu Police in which police team of Police Station Domana, Police

Posts Jourian, Chinore and Pargwal acted stringently on the specific inputs and

raided at different locations in their respective areas and seized 8 vehicles involved

in illegal mining. The seized vehicles included a tractor-trolley without registration

number seized by Domana Police; two JCBs, four tractor trolleys without registration

number seized by Jourian Police and a tipper (JK02CM 3790) seized by Chinore Police. The recoveries were made by SHO Domana Insp. Tilak Raj,

Incharge Police Posts Jourian PSI Karnail Singh and Chinore PSI Rajesh Kumar

in their respective jurisdictions.

Two missing persons traced, reunited with families

JAMMU: Police on Wednesday traced missing persons and reunited them with their

families. As per details, a complaint was registered at Police Station Bishnah

regarding a boy who went missing from his house. In this regard, missing report was

registered at Police Station Bishnah and investigation started. A team formed under

the supervision of SDPO R S Pura Surinder Singh led by SHO Bishnah Insp

Vikram Sharma, which after putting in strenuous efforts, traced the missing boy

namely Rakesh Kumar, son of Charan Dass, resident of Dalhain, Bishnah.

Similarly, another complaint was lodged at Police Post Chowki Choura regarding

missing of a woman who also went missing from her house. Acting on complaint,

special police teams were formed under supervision of SDPO Akhmoor Mohan Lal

and a team led by Incharge Police Post Chowki Choura PSI Pankaj Katoch traced

the missing woman. Subsequently, families of missing persons were informed and

both were handed over to their respective family members after completing all legal

formalities.

SHRADHANJALI

Miss Harnam Kour Anand, 26 years old, was born to Sardar Harpinder Singh Anand and Sardarni Meenu Anand in Jammu. She was the only daughter of her parents with a brother Manvir Anand.

After completing her schooling from Jodhamal Public School Jammu, Miss Harnam Kour Anand started working on a project on 'Drug de-addiction' in Jammu schools and conducted several workshops. Thereafter, she moved to Delhi and completed her graduation in Life Sciences from Delhi University.

In her spare time, she used to work on juvenile delinquency in Tihar Jail. After that, she moved to UK to pursue post-graduation in Public Policy from University College, London.

But due to outbreak of COVID-19, she came back and started a Charitable NGO- 'Anjana' along with other like-minded people. Anjana adopted a small village namely 'Chilla' near Sanasar and during entire COVID-19 period, the NGO worked on overall development and upliftment of the small hamlet.

Anjana was also in process of establishing a 'Sewa Niketan'- an old-aged home at Batote, which was allotted to them by Social Welfare Department, J&K UT.

A staunch devotee of Guru Granth Sahib, Miss Harnam Kour Anand was a social, polite and helpful person always ready to help poor and needy people. She breathed her last on September 19, 2022 in a tragic road accident at Ramban. Her untimely passing away has left an insurmountable void in lives of her family-members, friends and residents of village Chilla and Ramban, who will never forget her and her noble deeds.
