



CRIME REPORT

14 vehicles involved in illegal mining seized

JAMMU: In a quest to stem the menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which police teams of Police Stations Miran Sahib, Bishnah, Police Posts Chinore and Belicharana acted stringently on the specific inputs and raided at a location in their respective area and seized 06 vehicles involved in illegal mining.

The seized vehicles include One Tractor bearing Registration No JK02CX-7922 by Miran Sahib Police; One Tractor trolley bearing Chasis No. QATE30405005628 by Bishnah Police; 3 vehicles i.e Two tractor trolleys bearing Registration Nos. JK02BE 5097, JK02DB 3988 and one tractor trolley without Registration No by Chinore Police and One tipper bearing Registration No JK02CU8378 by Belicharana police.

The recoveries were made by SHO Miran Sahib Insp.ropinder Singh, SHO Bishnah Insp Vikram Sharma, In-Charge Police Posts Chinore PSI Rajesh Kumar and Belicharana-SI Sugreev Kumar in their respective jurisdictions.

Samba Police also seized 8 more vehicles which were being used for illegal mining in district Samba.

Police teams comprising of SHO Police Station Bari Brahmana Sumit Sharma, SHO Police Station Vijaypur Sandeep Charak, SHO Police Station Samba Daljit Singh, Incharge Police Post RakhAmb/Talli ASI Ramesh Chander and Incharge Police Post Supwal ASI Balbir Kumar under the supervision of DySPGaru Ram, SDPO Vijaypur Rohit Kumar, SDPO Bari Brahmana Rahul Nagar and Additional SP Samba Surinder Choudhary have seized eight (08) more vehicles being used for illegal mining at different locations in Samba district.

The seized vehicles are 4 dumpers bearing registration Nos. JK02CK-0835, JK21G-8766, JK21D-4532, JK14F-1957 and three 3 tractor trolleys bearing registration Nos. JK11C-6310, JK21F-1024, JK21J-5198 and one tractor trolley without registration No.

Vehicle theft case solved, two brothers arrested, 3 scooties recovered

JAMMU: Police on Monday nabbed to brothers and recovered three stolen scooties from their possession.

As per details, On September 5, 2023 a complaint was lodged at Police Post Chinore by one person namely Pyare Lal, son of Chura Ram, resident of Rajinder Nagar Bantalab stating that some unknown person had stolen his Scooty (JK02BC 2194) from Rajinder Nagar Bantalab. On this information a case FIR No. 282/2023 U/S 379 IPC was registered at Police



Post Chinore and investigation started. On this, a team of Police Post Chinore led by SDPO Domana Vishal Shoor assisted by SHO Domana Insp. Kunal Singh Jamwal and In-Charge Police Post Chinore PSI Rajesh Kumar did strenuous efforts and with the help of CCTV footages of the area and rounded up two suspects namely Nikhil Goswami and Rohan Goswami, both sons of Mohinder Pal, resident of Bari Brahmana Samba. During questioning the accused persons confessed their involvement in above case and on their disclosure stolen Scooty bearing Registration no JK02BC 2194 was recovered from their possession.

It is pertinent to mention that two more scooties bearing registration no JK02BT0704 and JK02BW 5771 were also recovered from their possession.

Three nabbed with 1.2 Kgs Ganja

AKHNOOR/BISHNAH: Continuing its drive against drug trafficking and substance abuse, Police on Monday nabbed two drug peddlers and recovered Ganja from their possession.

As per details, a police team of Police Station Akhnoor led by SDPO Akhnoor Mohan Sharma assisted by SHO Akhnoor Insp. Zaheer Mushtaq while on patrolling duty at Karangi Akhnoor area rounded up a suspected person. During search 200 grams of ganja was recovered from the possession of accused later identified as Pinku Kumar, son of Gulam Parshad, resident of Bhapur Tehsil Rajan Gram District Anupur M.P at present Karangi Akhnoor. He was arrested and FIR No. 257/2023 under sections 8/20 NDPS Act was registered against him at Police Station Akhnoor.



Meanwhile, a party of police station Bishnah in coordination with DSB officials during a surprise Naka at Tara Chowk Bishnah apprehended two pedestrian persons who were coming from Bari Brahmana side and going towards Bishnah. During the search of persons who later disclosed their identity respectively as Dinesh Kumar Chandra, son of Jai Lal Chandra, resident of Chhattisgarh at present W.no.13 Bishnah and Manmohan Chandra, son of Niranjan Chandra, resident of Chhattisgarh A/P Guddu Pandit Mahavir Medical Hall Bishnah, police recovered 500 grams each total 1 Kg Ganja like substances from their possession respectively. They were arrested on the spot and FIR No. 214/2023 under section 8/20 NDPS Act was registered against them.

Absconder evading his arrest since arrested
