Taking a dig over the proponents of one nation, one constitution, he said why BJP is silent when elections the rural panchayat bodies are held under SEC while it

The entire exercise of elections including preparation of Electoral rolls, is violative of the constitution and unconstitutional, more particularly after abrogation of special status & J&K becoming UT, whereby the entire constitution is applicable to J&K. Taking strong exception to the fact that the exercise for the upcoming elections to the ULBs is being conducted by the Chief Electoral Officer and not by the existing State Election Commission which has jurisdiction over Panchavats only, so far, as per 73rd amendment whereas in view of 74th amendment, the ULBs elec-

tions are also to be conducted by an independent commission, said JKPCC Chief Spokesperson.

How is it justified that the elections to the rural panchayats etc are conducted under superintendence & control of state election Commission, while as Urban bodies are being conducted by another election authority- office of CEO, he asked.

It is totally illegal, unconstitutional and against the provisions of 74th amendment, which is fully applicable to the J&K but not implemented in this regard by the dispensation claiming one nation, one constitution.

ed in the state Panchayat Raj Act, by an amendment on the insistence Congress in coalition with NC, after the elections to BDCs, were aborted over the issue of full implementation/ incorporation of all relevant provisions of 73rd amendment. It was later done in March 2014 by amendment in the state legislature whereby entire jurisdiction over the electoral exercise including delimitation of wards was given to the commission

After the coming into power, the BJP tried to weaken & dilute the 73rd amdt by incorporating indirect elections to sarpanch, which was later undone by then Governor N N Vohra during Governor rule.

Referring to the process of delimitation and rotation etc, he said that 73rd & 74th amendment provided the same to be done under supervision of independent institution of election Commission in the absence which it is violative of the provisions of 74th amdt. Congress in coalition with NC had incorporated all left out provisions of 73rd including state election Commission but same was not extended to ULBs by BJP controlled government post 2015, till date. Terming the exercise of

elections to ULBs and all related matters as illegal and unconstitutional, particularly after the whole constitution is directly extended and applicable to J&K, post 5th Aug 2019, Congress questioned the exercise already initiated, as without jurisdiction and demanded immediate extension of the jurisdiction of election Commission over the whole exercise of elections & related matters .to the Commission, as provided by Article 243ZA of the Constitution of India which reads as under " Art 243ZA - Elections to the Municipalities -(1) -The Superintendence, direction & Control of the preparation of electoral rolls for, and the conduct of all elections to the municipalities shall vest in state election Commission as referred in the art,243K.

DB sets-aside writ Court judgment, draws a distinction between Donation and Acquisition

JAMMU: A Division Bench of Jammu & Kashmir and Ladakh High Court comprising Justice Sanjeev Kumar and Justice Rahul Bharti, allowed the appeal filed by Govt and set-aside the judgment of writ Court and drew a distinction between Donation and Acquisition

Division Bench while setting-aside the judgment of writ court, whereby Writ Court allowed the writ petition, directed to offer employment to the writ petitioner within a period of eight weeks from the date of impugned judgment in terms of SRO 181 of 1988. After hearing AAG Amit Gupta observed that SRO 181 of 1988 was not appli-

cable to the donation of land made voluntarily by the citizens and that SRO 181 of 1988 was prospective in operation, we cannot accede to the contention of the writ petitioner that right to employment had accrued to him with the promulgation of SRO 181 of 1988. That apart, it is not the case of the writ petitioner that he had acquired eligibility to seek employment or that he had staked his claim for such employment at any time between issuance of SRO 181 of 1988 and issuance of SRO 214 of 1991. DB further observed that this Court cannot also miss to notice that vide SRO 214 of 1991 the notification issued vide SRO 181 of 1988 was rescinded with a

clear stipulation that no such appointments shall be made in cases which were under process at the time of

issuance of the notification. DB further observed that though, in the instant case, the case of the writ petitioner was not even pending consideration as the petitioner had not even acquired the eligibility to seek employment and might have been minor at the relevant point of time, yet, we find that even if his case was pending and was still under process, the same was not to be considered in view of the provisions of SRO 214 of 1991. It needs to be noted that SRO 214 of 1991, or for that matter, SRO 181 of 1988 were not the subject matter of challenge in the writ peti-

tion. In view of the aforesaid discussion, Division Bench refrained from going into the contention of counsel for the appellants that father of the petitioner was not even holding title to the property donated by him to the Department of Health for construction of PHC. We also need not to go into the other aspects highlighted by leaned counsel for the appellants that father of the petitioner had sufficient agricultural land which he had sold to one Yousaf and therefore, it was not even a case where the father of the writ petitioner was left with 50% or less of agricultural land after donating 1 kanal for construction of PHC.

With these observations Division Bench find enough

STATE TIMES NEWS JAMMU: Dissatisfying with the government's response to their demands, which include issues related to employment regularization, promotions, and recruitment, Jammu and Kashmir Electrical Engineers' Graduates Association (JKEEGA) has announced a 48-hour mass protest on September 25 and 26, 2-23 to draw attention to these

JKEEGA delegation led by its President Er. Sachin Tickoo and General Secretary Er. Pirzada Hidayatulla met with the Principal Secretary of the

Jammu and Kashmir Power Development Department (PDD) and discussed the lack of progress in addressing their concerns.

"The JKEEGA had previously organized a one-day peaceful protest on September 9, 2023, to draw attention to their grievances," they said adding that despite the peaceful protest and discussions there has been no significant progress in addressing their issues.

The association expressed concern over recent government orders that assigned additional responsibilities to certain officers rather than filling vacant positions within the Engineering cadre. They said this affects consumer grievances and service delivery negatively.

The JKEEGA also mentioned that the government had not fulfilled the direcof a State tives Council Administrative (SAC) decision from 2019 regarding the regularization of engineers and other HR issues. Due to the lack of resolution of their demands, they said, the JKEEGA approached the Lieutenant Governor's (LG) office for intervention. The LG's office had sought detailed action reports, but the

issues remain unresolved,

they added.

In response to the government's perceived lack of action, the JKEEGA's General Council decided to hold a 48-hour mass protest

on September 25-26, 2023. During this protest, engineers from the Power Development Department plan to assemble at PDD complexes in Jammu and Srinagar to demand the regularization of their employment, timely promotions, and recruitment at the Junior Engineer level.

They said that other associations within the PDD also intend to support the protest.
