



RAJOURI: A sarpanch allegedly shot dead his wife in Jammu and Kashmir's Rajouri district on Thursday, police said. He has been arrested after the registra tion of a case under charges of murder. According to the police, Yashpal, the sarpanch of Panchayat Halka Patrara, fired upon his wife, Neelam Devi, 46, using a .303 rifle in Sunderbani area of the district.
