



Woman arrested for abetment to suicide case

SAMBA: Police on Saturday arrested accused woman for abetment to suicide in case FIR No. 82/2023 under section 306 IPC of Police Station Ghagwal while conducting in-depth investigation into the death of "Rani" of Ghagwal, in which husband had been arrested earlier.

Earlier, inquest proceedings initiated under section 174 CrPC into the mysterious death of 42-year-old Rani Devi of Harsath, Ghagwal district Samba to ascertain the actual cause of death had been converted into FIR under sections 306 IPC and accused husband had been arrested.

On August 13, 2023, information was received at Police Station Ghagwal regarding suspicious death of Rani Devi and upon this inquest was initiated, postmortem was got conducted and other legal formalities were completed. Police collected evidence and concluded that deceased Rani Devi had consumed some poisonous substance due to abetment to suicide by her husband and one accused woman. The accused husband identified as Surinder Singh s/o Kartar Singh r/o Harsath tehsil Ghagwal district Samba was arrested earlier and is in jail on judicial custody. Now, olice has also arrested accused woman and further investigation is under

All the Tractor Trolleys and tanker have been

stolen from the jurisdiction of District Kathua by these 04 interstate thieves. Thereafter 04 Interstate Thieves were arrested and 03 Tractor Trolleys alongwith 01 water Tanker were recovered/seized whereas Investigation of the case is going on more recoveries and arrests cannot be ruled out.

Narco Smuggler arrested; 15 Kg poppy straw recovered, vehicle seized
