The work on the Defence Research and Development Organisation (DRDO) lab vill also be completed soon, Singh said.

During his visit in June, Singh had said that "everything from nuts and bolts to BrahMos missiles would be manufactured in the Uttar Pradesh Defence Industrial Corridor (UPDIC)".

3 terrorists killed...

destabilise peace in Jammu and Kashmir. So, we strengthened our counter-infil-

ration and surveillance grid," he said. "At 6.40 am this morning, despite bad weather, an ambush noticed three to four errorists trying to cross the LoC in the Hathlanga area. Immediately contact was stablished and the firefight continued for two hours," he added.

The officer said the army used under-barrel grenade launchers (UBGL), multigrenade launchers (MGL), and rocket launchers to neutralise the terrorists

"One terrorist was neutralised. The ambush party then realised that two injured terrorists had changed their movement. The ambush party then got into a second firefight with them at around 9.15 am which continued for about half an hour and resulted in the neutralisation of the second terrorist," he said.

Brigadier Dhillon said the third injured terrorist "exfiltrated" with the help of firng from a nearby Pakistani post.

"The Pakistani Army post gave fire support for his exfiltration and fired towards us. They fired on our quadcopters as well. According to our estimate, the injured terrorist succumbed about 300 metres from the Pakistani post, in the general area The weather is very bad, but the search continues in the area," he said

The officer said three terrorists from Pakistan have been neutralised in the operation and the bodies of the two have been retrieved.

"This shows how the Pakistan Army backs terrorists and lends them full support to infiltrate. It also establishes how Pakistan Army is involved in destabilising peace n Kashmir," he said.

The security forces also recovered an AK-47 and AK-74 rifle, seven magazines, a five-kg IED, some ammunition, a Chinese pistol and some grenades along with Indian and Pakistani currency from the terrorists.

"We think they wanted to use the IED at some sensitive target, including minority pocket or security forces' establishment," Dhillon said.

The infiltration bid and the subsequent encounter comes at a time when an operation is underway in Anantnag district to neutralise terrorists who have taken positions in the forest area in a hilly terrain. The gunfight entered its fourth day on

docket explosion and backlog of pending cases before the courts.

Highlighting the importance of the subject, Chief Justice observed that under the new regime, a clear timeline was given for the adjudication of disputes with minimal scope for the intervention of courts so as to ensure that litigants don't get struck in the legal hurdles. He expressed satisfaction over the growing trend and popularity of the arbitration as an alternate dispute resolution mechanism especially in dealing with commercial disputes and the encouraging results thereof. He further emphasised the need to give effect to the statute in true spirit of and to popularise the other methods of alternate dispute resolution so as to minimise the backlog.

Justice Sanjeev Kumar, in his special remarks, highlighted the salutary provisions of the Arbitration and Conciliation Act 1996 and subsequent amendments there-in. He also highlighted that arbitration, as an alternate mode of dispute resolution in a congenial atmosphere was prevalent in our country since centuries and a viable medium of out of court dispute resolution much prior to coming into force of the codified law.

Director, J&K Judicial Academy presented the welcome address and gave an overview of the programme. He described arbitration and conciliation as the way forward for the timely resolution of disputes. He emphasized that it is imperative to have a clear understanding of the provisions of law coupled with firm resolve to achieve the desired results

In the first technical sessions, Manish Mehrotra deliberated upon the historical background, aims and objects and discussed the basic provisions of the Arbitration and Conciliation Act thread bare. He also underpinned the scope of interim injunctions and relief u/s 9 of the Act and shared a number of important rulings on the subject. He referred to the Arbitration agreement in the light of the legal provisions and discussed the scope of reference to arbitration.

The resource person deliberated on the application and effect of legal proceedings on Arbitration. In the second technical session, the scope to challenge the award u/s 34 and the extent of court interference in arbitral awards was discussed in detail along-with the provisions of section 36 of the Act. The resource person also emphasised the need of expeditious disposal of matters relating to Arbitration proceedings and also the common issues and redress thereof confronted during the arbitral pro-

Both the sessions were essentially interactive and the participants took keen interest and made full use of the opportunity to deliberate and discuss various aspects of the subject topic by raising queries which were addressed to satisfactorily by the resource person.

The commander inspected the drone which has been used to survey the area and track the terrorists, the officials said.

He also interacted with troops deployed in the operation, they added.

The police believe two to three terrorists are trapped in the forest area as the forces maintained a tight cordon. Additional Director General of Police (Kashmir) Vijay Kumar late Friday night

said the operation was launched on the basis of specific input and claimed "two to three trapped terrorists will be neutralised. Meanwhile, adequate forces have been deployed in the upper reaches of Kishtwar to watch out for any terrorist movement from across the Pir Panjal Range, a senior

police officer said on Saturday. "For the last three days, adequate personnel of police and army are deployed in the higher reaches of Singhpora and we are dominating the area," Kishtwar Senior

Superintendent of Police Khalil Poswal said. Singhpora connects Kishtwar with Kokernag but the road between the two sides of the Pir Panial usually remains cut off during the winter owing to heavy snowfall at the 12,500-foot-high Sadna top. At present, a 10.3-km Vailoo-Singhpora tunnel

has been under construction since 2009 to ensure round-the-year connectivity. The SSP said police and army are working in close coordination to tackle any situation. "If there is any movement (of terrorists from the Kokernag side), we are

active on that front," he said. Commanding Officer of the 19 Rashtriya Rifles Colonel Manpreet Singh, Major Ashish Dhonchak, Deputy Superintendent of Jammu and Kashmir Police

Speaking about the RSS conclave, Vaidya said a wide range of topics were dis-

cussed by 250 representatives from 36 RSS-affiliated outfits.

The topics included women's empowerment, 'swadeshi', functioning and expansion of the RSS, the environment, family values and social harmony, he said. Asked if Manipur, which has been engulfed in sectarian violence since the begin

ning of May, was discussed, he said the situation there was worrisome and some participants informed about the happenings.

"In this situation, it is the government which has to take decisions. Sangh volun teers are in touch with both Maitei and Kuki community members and the Sangh's service work for both the communities is going on," he said. On the issue of reservations, he said society denied educational opportunities and

respect to the Scheduled Castes and Scheduled Tribes, and these communities should be given reservations based on the Constitution to take them along. All efforts should be made to end social disparity. Vaidya added. The other quota demands are political, hence no discussion took place on them at

the conclave, he said. Notably, Maharashtra recently saw a fresh agitation for a quota for the Maratha community.

Asked about the RSS's assessment of the Bharatiya Janata Party-led NDA's rule in the country since 2014, he said even a British newspaper like Sunday Guardian had published an editorial on May 18, 2014, stating that the "day may well go down in history as (comparable to) the day when Britain left India.

The 2014 Lok Sabha election results were declared on May 16 and for the first time after 1984 a single party (BJP) managed to garner a majority in the Lower

"So, if you see, after 2014 India is standing up on its cultural identity slowly India's foreign, defence and education policies witnessed major changes. The world is also sensing these changes," he said.

To set right what happened in the last several years would take 25-30 years but everyone now feels that everything is going in the right direction, Vaidya added.

On the Ram temple at Avodhya, he said the outfits concerned with its construc tion informed at the conclave that any date after Makar Sankranti will be decided for `pran pratishtha' or installation of the idol.

It was also resolved that RSS-inspired organizations will make special efforts to increase the participation of women in all fields, Vaidya said.

Family is the smallest unit in social life as per Indian philosophy and the role of women in a family is the most prominent one. Therefore, women should play a leadng role in every field of society, the RSS leader said.

The increasing activism of women in society is commendable, he said, adding that the meeting elaborately discussed the topic to ensure women's participation in the

centenary year of the RSS. As many as 411 conferences will be organized across the country. The RSS so far has organized 73 such conferences in 12 states and more than 1.23 lakh women took part in them, he said.

On the expansion of the RSS, Vaidya said the number of `shakhas' (local RSS branches/assemblies) is constantly increasing. In 2020, before COVID-19 pandem ic, shakhas used to be held at 38,913 places, while the number has gone up to 42,613 in 2023, he said.

to the families of the terrorists in different parts of Kishtwar by the special inves tigation units (SIUs) of the local police amid beating of drums, they added.

Senior Superintendent of Police (SSP), Kishtwar, Khalil Poswal said a total of 13 local terrorists, who are operating from across the border and making repeated attempts to revive terrorism in the district, were declared as proclaimed offender after they failed to respond to the non-bailable warrants issued earlier.

The warrants were issued by the special NIA court in March in a terror-related case registered at the Kishtwar police station last year under various sections of the Indian Penal Code and Unlawful Activities (Prevention) Act.

"If these proclaimed offenders fail to surrender within 30 days, the proceedings to attach their properties under section 83 of the CrPC will be initiated," the SSP told

In the proclamation notices served to the absconding terrorists at their birtle places, Additional District and Sessions Judge (fast-track court) Doda Sudesl Sharma said the warrants of arrest issued by the court of additional sessions judge Jammu were returned with the report that the accused could not be found.

"It has been shown to my satisfaction that the said accused has absconded or i concealing himself to avoid the service of the said warrant. Proclamation is hereby made that the accused is required to appear before this court within the period of 30 days from the date of publication of proclamation, failing which proceedings under section 83, CrPC shall be launched against him," the identical notices issued on Thursday read.

The officials said the proclamation was issued, among others, against Shahnawa Kanth alias "Umer" of Hullar, Nayeem Ahmed alias "Amir" of Jamia Masjid Kishtwar, Mohammad Iqbal alias "Bilal" from a place near the Kichloo market Shahnawaz alias "Nayeem" of Chirool and Javid Hussain Giri alias "Muzamil" o Kundali Pochal.

The list also included Bashir Ahmed Mughal, Gazi-ul-Din and Sattar Din alias "Saifullah" of Jugna Keshwan, Imtiyaz Ahmed alias "Dawood" of Banderna, Shabir Ahmed of Kither Bonjwah, Mohammad Rafig Keen of Patnazi Bonjwah, Muzaffer Ahmed of Zewar and Azad Hussain of Affani Padder, they added.
