

# CRIME REPORT

## ACB arrests Lambardar while accepting Rs 8,000 as bribe

SRINAGAR: The Anti Corruption Bureau on Monday arrested a Lambardar while taking a bribe of Rs 8000 in Kreri area of Baramulla district. An official said that the ACB has arrested Lambardar Nisar Ahmed Pandit, son of Ghulam Haider Pandit, resident of Authura Bala, while taking a bribe of Rs 8000.

He said that the accused was working as a commission agent of Patwari Halka Reshipora Intiaz Ahmed Dar. The official said that later the Patwari was also arrested and some objectionable revenue documents were recovered from his possession.

## SIA gets 15-day remand of 2 accused of narco terror case

JAMMU: The State Investigation Agency has been investigating cases related to narco terrorism in Poonch for the last several months. On Monday, a SIA team led by a DSP rank officer reached Poonch where the team presented two accused related to narco terrorism, Liaqat and Javed resident of Karmada in the court. Before being taken to the court, the accused were taken out of Poonch District Jail and taken to Raja Sukhdev Singh District Hospital, where after getting their health checkup done, they were presented in Poonch court.

In the afternoon, both these accused were sent on 15 days police remand by the judge. It is noteworthy that on May 31, 2023, three local terrorists were caught by security forces with arms, ammunition and drugs from across the Line of Control in Karmada of India-Pakistan controlled area in Poonch district. Of these, two accused have been sent on 15-day remand by the court today. Now similar further action will be taken regarding them. Three more people are also on SLA remand in this case.

## One arrested with 560 gelatin sticks

KISHTWAR: A man was arrested after 560 gelatin sticks weighing around 70 kilograms were found in his car in Kishtwar district, a senior police officer said on Monday.

The explosive substance used in road construction work was being transported illegally by the man and an FIR was registered against him, Senior Superintendent of Police, Kishtwar, Khalil Poswal said.

He said a joint checking party of police and security forces intercepted the car following specific inputs at Zelna village on Sunday and seized the gelatin sticks.

A preliminary investigation suggested that the material was being transported by a contractor involved in road construction from Gadigarh to Paddar, the official said. "There is a set procedure for transporting such materials to avoid its pilferage. We have taken a serious note of the illegal transportation of the gelatin sticks and registered an FIR for a thorough investigation," the SSP said. He said appropriate action would be ensured against the contractor.

## Former MLA booked for objectionable remarks

JAMMU: A case has been registered against former MLA and National Conference leader Dr Gagan Bhagat at RS Pura police station. This case has been registered under section 295A. It has been alleged that Dr. Bhagat has tried to hurt the religious beliefs of a section on which a case was registered against former MLA Dr Gagan Bhagat regarding this late on Sunday night.

According to the information, former MLA Gagan Bhagat had made objectionable remarks against a particular caste, Lieutenant Governor of Jammu and Kashmir Manoj Sinha, in a post on his social media account. In protest against this, Rejule son Satish Chandra, resident of Sarwal Bakshi Colony, Jammu, lodged a police complaint against the former MLA. Taking action on this, the police have registered a case under section 295A and started investigation.

## Woman found hanging

JAMMU: A woman was found hanging in her own house in Phallain Mandal area. According to the information, family members of Lakshmi Kumari, wife of Ramesh, resident of Maqbal, found her hanging in the house. She was taken to the hospital but during investigation the doctors declared her dead. After getting information about the death, police reached the spot and took her body into custody. A case has been registered in this regard for investigation.

## Woman dies in accident

KATRA: A woman has died in an accident in Katra area on Monday. According to information, Pooja Gupta, wife of Shankar Kumar, resident of Bihar, was injured in the area on August 28 as she was hit by a car. She was taken to the hospital where she was undergoing treatment but today she succumbed. After getting the post-mortem done, her body has been handed over to the family members.

## 13 vehicles involved in illegal mining seizures

SAMBA: Police on Monday seized 13 vehicles which were being used for illegal mining in district Samba.

## 6 gamblers arrested, stake money seized

Officers have seized stake money of ₹10,000/-, 06 Mobile Phones and playing cards from their possession.

They have been shifted to the police station where they remain in custody. Accordingly, a case under relevant sections of law has been registered at Police Station Qazigund and investigation has been initiated.

## Three dead as dumper plunges into gorge in Ramban

BANIHAL: Three persons were killed when a dumper skidded off the road and plunged into a deep gorge in Jammu and Kashmir's Ramban district on Monday, officials said.

The accident occurred near remote Tanger village around 6.15 pm, they said. The driver of the load carrier, which was on its way to Tanger from Sawlakote, lost control while crossing a blind curve and rolled down into a gorge, officials said. A rescue operation was immediately launched and all the three persons travelling in the vehicle were found dead, they said.

The deceased were identified as Bahar Din, Omkar Singh and Bhari Lal, all residents of Tanger.
