# JKSAC demands to implement Joint Parliamentary Committee's report

JAMMU: Jammu Kashmir Committee (JKSAC) is submitting a petition under the title, "Hamari Awaaz Suno" to Prime Minister, Narendra Modi, Amit Shah Home Minister and Manoj K. Sinha Lt. Governor and others concerned signed by over 1 lakh DPs of 1947 from POJK, demanding thereby the acceptance, implemen-Joint tation ofParliamentary Committee on Home Affair's Report No: 183, the only viable road-map to resolve the DPs grievances concerning their settlement, which is hanging due to lack of proper projection from the J&K govt. side.

Speaking to media, Gurdev Singh President said that JKSAC had launched a signature campaign over a year back with

an aim to aware the DPs about their rehabilitation issues and particularly to draw the attention of PM other concerning authorities towards the plight of lakhs of DPs spreading in 17 assembly segments of Jammu region awaiting the resolution of their proper settlement from the last seven decades.

The campaign has culminated and the signatures collected, represents the voice of over 1.2 million DPs would be submitted to alongwith detailed petition. The copy of petition would also be submitted to JP Nadda National BJP, President Jatinder Singh MOS PMO, Jugal Kishore Sharma (MP) and others by a delegation of DPs.

He apprised the media that JKSAC is a legendry organization and is in relentless struggle since 1967 for the resolution of settlement. The tremendous sacrifices made by DPs to save the Indian part of J&K have not been documented and went unnoticed. They have been discrimi-

nated, ignored and their rehabilitation issues were never highlighted and protive before the Central govt. The facts regarding their issues were concealed and distorted by the former govts. with an ulterior motives to weaken them economically, educationally and politically.

He further said that recently constituted JPC on Home Affairs also termed the DPs grievances as absolutely genuine and took serious view of the exgratia rehabilitation assistance/relief provided to them so-far as most insufficient with poor track record of implementation. The JPC recommended that they should immediately be given Rs 30 lakhs each family as interim relief, de-freezing of their assembly seats, reservation of their wards besides other components.

The representatives of MHA/GOI after long delibthe recommendations and assured that the same would be incorporated in the package-2015. But it is highly regretted that the govt. failed in keeping its words and earmarked only Rs 2000 crore in the package for 36,384 DPs families of 1947, 1965 and 1971 at the rate Rs 5.5. lakhs each family and after further division of the amount among increased families and each family got only Rs 60,000 share. So one can imagine that with such a small amount how DP family can plan the settlement of his future generation

This system is being added alongside the existing Aadhaar Enabled Biometric Attendance System (AEBAS), which is monitored by the Higher Education Department.

The strike was also in response to the withholding of salaries for teaching and non-teaching staff of colleges in the Doda District by the District Administration of

During the strike, faculty members from all the colleges gathered at their respective institutions to express their strong resentment against the unjust attitude of District

Rakesh President College Teachers Association (CTA)-Jammu strongly resented the highhandedness of the District Administration Doda despite the fact that college teachers are attending the colleges regularly for their duties and marking their attendance on BAS that is being monitored by Higher Education Department.

He further said when there is a uniform system of attendance (AEBAS) for all the employees of the UT of J&K and college teachers are also marking their attendance regularly on BAS at the time of arrival as well as departure from the college, the imposition of additional attendance system involving sending the clicks repeatedly shall unnecessarily create hassle in the teaching and other activities of the college. He mentioned that there

has been growing discontent among college teachers in J&Kregarding various issues, such as the release of

their legitimate arrears, restoration of advanced increments for higher qualifications, age enhancements, delayed placements, and the notification of new recruitment rules. The additional burden of the new attendance system by the District Administration has further added to their grievances, he added.

Dr. Jasrotia appealed to the Lieutenant Governor (LG) to intervene in the matter and resolve the issues promptly.

He clarified that the pendown strike was a symbolic gesture to convey the message to the administration to withdraw the unnecessary additional attendance system and release the salaries of college teachers in the Doda

District promptly. If their demands are not met, he warned that further democratic actions would be taken to address these concerns.
