Dr Mehta took note of the measures taken so far to stop the untreated sewage flowing into our water bodies to prevent their pollution. He directed the H&UDD to ensure that the waste collected by local bodies is segregated at source so that optimal recycling can be undertaken.

He maintained that ample awareness should be created among the public so that they are able to segregate the waste and handover it to the collection agencies separately. He also asked the department to enhance its capacity in terms of treating such waste in a proper scientific manner.

Dr Mehta observed that the landfill sites should be made attractive and odour free. He also underscored the need of incentivizing its establishment for the locals so that they do not feel any kind of reluctance. He advised them to identify the sites from the chunks of government land recently retrieved by the Revenue Department.

He also made out that no water body of J&K should be polluted. He stated that these bodies are our priceless resources and should be protected for future. He asked for ensuring that people residing near rivers, lakes, canals etc have at least septic

tanks for treatment of sewage. He also asked for creating oxidation ponds besides sewerage schemes in all the congested areas especially at Srinagar and Jammu where people don't have the provisions to create their own septic tanks so that untreated waste is not released into the environment.

The Chief Secretary also advised them to visit the Municipal Corporations like Mumbai, New Delhi, Indore, Ahmadabad etc for learning from their experiences. He asked them to study all the successful models there to adopt the most suitable ones in the UT. He asked them to ensure that the directives given by the NGT are fully implemented for safeguarding the environment.

the Constitution amendment bill were also cleared by the House. When the proposed legislation goes to Rajya Sabha for its consideration, it will be called the Constitution (106th Amendment) Bill, officials said.

Setting the tone of the debate, former Congress president Sonia Gandhi made a strong pitch for bringing OBC women in the ambit of the proposed law and asserting that any delay in bringing the reservation into effect would be "gross injustice" to women.

Intervening in the debate, Home Minister Amit Shah brushed aside apprehensions of a delay in the implementation of the proposed law and asserted that the next government will conduct a census and delimitation exercise soon after the elections, setting in motion the process to make women's reservation a reality.

Shah indicated that women's reservation will become a reality after 2029.

The home minister pushed back against the opposition's criticism for not including an OBC sub-quota and asserted that the BJP has given more representation to the community than those claiming to speak for them.

Nearly 29 per cent or 85 BJP MPs, 29 Union ministers, and 365 of its 1,358 MLAs, which is over 27 per cent, are from the OBC category, Shah said. He said over 40 per cent of its MLCs also belong to the Other Backward Classes (OBCs).

The debate also saw rival political parties claim credit for women's reservation, with Gandhi saving that the bill was a dream of her late husband and former prime minister Rajiv Gandhi, who made attempts to grant reservation to women in local bodies in 1989 but failed, and BJP members asserting that former prime minister Atal Bihari Vajpayee brought the bill twice only to be met with unruly scenes in the

The bill was brought in 2008 during the coalition government led by Prime Minister Manmohan Singh and passed by the Rajya Sabha, where it was introduced, in 2010. However, the bill could not be passed in the Lok Sabha due to political differences. It subsequently lapsed with dissolution of the 15th Lok Sabha

AIMIM leader Asaduddin Owaisi was the lone voice of opposition to the bill contending that the measure would provide reservation only to "savarna women", and exclude OBC and Muslim women who have little representation in Parliament.

The AIMIM has two members in Lok Sabha.

On the issue of immediate implementation of the proposed law. Shah said such a move would lead to allegations of partiality and insisted that the matter be best left to the delimitation commission which would carry out the exercise in a transparent

"If we do it and Wayanad becomes reserved you will say it is a political step. If Hyderabad becomes a reserved seat, Owaisi ji will say it is politically motivated," the home minister said. Wayanad in Kerala is represented in Lok Sabha by Congress leader Rahul Gandhi.

Shah said the delimitation commission was an appropriate forum for demarcation of constituencies reserved for women as it is chaired by a retired Supreme Court judge and has representation from political parties.

Several members had demanded immediate rollout of women's reservation and criticised the provisions that said that the quotas will come into effect after the delimitation exercise undertaken after the first census after the commencement of

Speaking on the bill, Trinamool Congress MP Mahua Moitra said, "Women's reservation is dependent on two totally indeterminate dates, can there be a greater jumla? Forget 2024, this may not be possible in 2029."

Former Congress chief Sonia Gandhi said, "For the last 13 years, Indian women have been waiting for their political responsibilities, and now they are being asked to wait for a few more years -- two years, four years, six years, eight years.

Several opposition leaders said that the women's reservation bill was a panic reaction of the government after the formation of the opposition group INDIA.

We support the bill. We want to empower all women. But this is nothing but a 'jumla'. This is nothing but a panic reaction (of the ruling dispensation) to the formation of the opposition group INDIA.... This government has no intention of empowering women. Their only intention is to capture power," Janata Dal (United) leader Rajiv Ranjan Singh said.

NCP member Supriya Sule termed the legislation a "post-dated cheque" and demanded the government spell out the date and timeline for its implementation. Akali Dal member Harsimrat Badal also targeted the BJP over its leaders being booked for crimes against women.

"Women wrestlers, who brought so many medals, have been sitting for months but the Bahubali is still sitting here," she said, referring to former Wrestling Federation of India president and Lok Sabha member Brij Bhushan Sharan Singh, who has been accused of sexual harassment by several women wrestlers. Singh has denied

Bahujan Samaj Party member Sangeeta Azad, Bharat Rashtra Samithi leader Nama Nageswara Rao and Shiv Sena member Bhavana Gawali wholeheartedly supported the bill.

stipulates that no member of Parliament shall be liable to any proceedings in any court in respect of anything said or any vote cast in Parliament or any committee thereof. A similar provision exists for MLAs under Article 194(2).

In 2019, a bench headed by then chief justice Ranjan Gogoi, which was hearing an appeal filed by Sita Soren, JMM MLA from Jama and daughter-in-law of party chief Shibu Soren, who was an accused in the JMM bribery scandal, had referred to a 5-judge bench the crucial question, noting it had "wide ramification" and was of substantial public importance".

Sita Soren was accused of taking bribe to vote for a particular candidate in the Rajya Sabha election in 2012. She had contended that the constitutional provision granting lawmakers immunity from prosecution be applied to her.

The three-judge bench had then said it will revisit its verdict in the sensationa Jharkhand Mukti Morcha (JMM) bribery case involving Shibu Soren, a former Jharkhand chief minister and ex-union minister, and four other party MPs who had accepted bribes to vote against the no-confidence motion against the then P V Narasimha Rao government in 1993. The Narasimha Rao government, which was in a minority, survived the no-confidence vote with their support.

The CBI registered a case against Soren and four other JMM Lok Sabha MPs bu the Supreme Court quashed it citing the immunity from prosecution they enjoyed under Article 105(2) of the Constitution.

Today, a five-judge constitution bench headed by Chief Justice D Y Chandrachud said it will set up a seven-judge bench to examine the matter afresh and "straight en" the law even as Attorney General R Venkataramani opposed reconsideration o the 1998 judgement.

We are of the considered view that correctness of the view of the majority in PV (Narasimha Rao case) be reconsidered by a bench of seven judges. The purpose of Article 105 is to ensure that members of the Parliament and the state legislatures are able to discharge their duties in an atmosphere of freedom without fear of con sequences which may follow for the manner in which they speak or exercise their vote on the floor of the house.

"The object is not to set apart the members of the legislature as persons who wield higher privileges in terms of immunity of general law of the land which citizens of the land do not possess," the bench said.

As the proceedings commenced today before the bench, also comprising Justices AS Bopanna, MM Sundresh, JB Pardiwala, and Manoj Misra, senior advocate Raju Ramachandran, appearing for Sita Soren, submitted the mater was a regular crim inal appeal which involves the question of application of the PV Narasimha Rao case verdict.

Venkataramani, appearing for the Centre, referred to the facts of Sita Soren's case and said to qualify for protection under Article 194(2) of the Constitution, applica ble to MLAs, bribe had to be taken for proceedings for business or function of the

"(Shibu) Soren had received a bribe for the no-confidence motion (for voting against it) in the Parliament. There is nothing (in Sita Soren's case) to do with the business of the House. The function must have a nexus with the legislative business or purpose," he said.

Rebutting his submission, the bench said, "As a constitution bench, if we have a particular issue which deeply affects the morality of our polity, shouldn't we take an opportunity to straighten the law.

We have four eminent counsels appearing in this. What better opportunity to straighten the law? Normally you don't want to get into a broader issue of law where you may not feel that you'd get the correct assistance because then the entire bur den is on us. Even then we take up the burden sometimes. But here you have square ly a conflict between the viewpoints...we should set the law straight," the bench said

Senior advocate PS Patwalia, who was appointed amicus curiae in the matter, stat ed there was a "fractured" kind of concurrence in the PV Narasimha Rao judgement which necessitated that the matter be referred to a larger bench.

Senior advocate Gopal Sankaranarayanan, appearing for one of the intervenors echoed the views of the amicus curiae (friend of the court).

Sita Soren had appealed against the Jharkhand High Court order of February 17 2014 refusing to quash a criminal case lodged against her for allegedly taking bribe to vote for a particular candidate in the 2012 Rajya Sabha elections. The CBI had accused her of accepting bribe from one candidate and voting for another.

# Ancient Mela Patt begins with religious fervour Jal Jivan Mission: DC Rajouri starts work


