"The arrest of the narcotic smuggler and seizure of commercial quantities of heron from his possession is a big success for the ANTF," the officer said, adding an FIR was registered and further investigation to expose the backward and forward links of the arrested smuggler is going on.

He said heroin is mostly smuggled from across the border and "we are looking into details how the consignment reached this side whether it was smuggled or airdropped through a drone.'

Some more arrests are expected in the case as the investigation progresses, he said, adding that it is a matter of investigation whether the case is linked to narcoterrorism.

Kumar said this year ANTF registered 15 FIRs, mostly related to the seizure of commercial quantities of narcotics from different parts of the Union Territory and arrests of the accused were even made from outside J-K, including Punjab, Harvana, Gujarat and Delhi.

"The assets/properties raised by the smugglers are being identified and confiscated. Several bank accounts were also frozen," he said, adding that the same process will be followed in this case.

He appealed to the general public to come forward and cooperate with law enforcing agencies in identifying and capturing the drug smugglers to safeguard the vounger generation.

"Narcotics is a major threat to our society and we need to join hands to end this menace," the SSP said.

Earlier in the day, a private agency hired by India to carry out the initial scrutiny of visa applications of Canadians put out a note on its website on suspension of visa services due to "operational reasons". However, the note was withdrawn within hours and then again it was put up online.

The agency, BLS International, also informed the stock exchanges that it had suspended India visa services in Canada with immediate effect.

India and Canada are embroiled in a diplomatic row over the killing of Khalistani separatist leader Hardeep Singh Nijjar in June.

The row erupted following Canadian Prime Minister Justin Trudeau's allegations of a "potential" involvement of Indian agents in the killing.

India on Tuesday rejected the allegations as "absurd" and "motivated" and expelled a senior Canadian diplomat in a tit-for-tat move to Ottawa's expulsion of an Indian official over the case.

In reflection of hardening of its position, India on Wednesday advised all its nationals living in Canada and those contemplating travelling there to exercise "utmost caution" in view of growing anti-India activities and "politically-condoned" hate crimes as well as "criminal violence" in that country.

At the media briefing, Bagchi also said that there was a degree of "prejudice" in Trudeau's allegations against.

He said Canada did not share any specific information with India on the case. hill of Gandoh tehsil's Chanti-Bala Panchayat, 124 km from Doda town, has a religious significance for Nag devotees and has been worshipped for centuries by the

Surrounded by a thick coniferous forest, the visibly different tree because of its gigantic size, was located by the field staff, Divisional Forest Officer, Bhaderwah Chander Shekhar told PTI at the scene.

"The Deodar, also known as cedar, has a trunk diameter of 54 feet and 35 feet breast size, which is the scientific way of measuring the size of a tree. As per our research and the data we have collected, this is the largest tree of this species (Cedrus Deodara) in the world and seems to be the oldest one as well," he said.

Shekhar said the department would refer this to the Forest Survey of India to cal-"We have adopted the procedure so that this will be declared as a heritage site for

its unique size," the forest official said, adding "once the tree is declared heritage, people from all over the world will start visiting here to see this unique tree which gives a nostalgic feeling due to its size"

Sarpanch Chanti Bala Sansar Chand claimed that the tree had been worshipped for 12 generations.

"Our forefathers told us that when someone tried to cut the branches of the tree, blood and milk-like fluid started oozing out of it since then no one dared to harm the

The sarpanch said they are fortunate to have this tree, which is going to give them an identity in this far-off place and turn their fortunes if visitors start arriving there.

The residents of the panchayat and adjoining areas led by PRI members including Block Development Council Chairman Abbas Rather and District Development Council member Changa Nadeem Sharief Niaz have urged the government to officially declare the tree as the largest cedar tree in the world and take necessary steps to bring it under tourism map.

Niaz sanctioned Rs 10 lakhs for the beautification and lighting of the site around

the tree so that visitors can enjoy its beauty.

"This tree is of course an asset for us to attract tourists in this area which other wise is one of the most backward places in Jammu and Kashmir. We as public rep resentatives will try our best to showcase the glory of this unique asset of nature to the outer world. We hope the government, especially the forest department, will also do the needful at the earliest," he said.

Defaulting borrowers cannot...

Justice Pardiwala, who penned the 111-page verdict said, "We hold that as per the amended Section 13(8) of the SARFAESI Act, once the borrower fails to tender the entire amount of dues with all cost & charges to the secured creditor before the publication of auction notice, his right of redemption of mortgage shall stand extinguished/waived on the date of publication of the auction notice in the newspaper in accordance with Rule 8 of the Rules of 2002."

The verdict came on an appeal of Celir LLP challenging a Bombay High Court

The High Court had allowed another firm Bafna Motors (Mumbai) Pvt Ltd to redeem its mortgaged property on payment of dues to the bank.

Allowing the appeal, the top court said the auction purchaser was "left high and dry" by the respondent borrower firm and others as they were permitted to redeem the mortgage of the secured asset, more particularly after the auction proceedings attained finality.

The bench said, "To read it (section 13(8)) otherwise in a strict manner as to only stipulating a restriction upon the secured creditor and not on the borrower's right of redemption would lead to a very chilling effect, where no auction conducted under the SARFAESI Act would have any form of sanctity, and in such a situation no per son would be willing to come forward and participate in any auction due to the fear and apprehension that despite being declared a successful bidder, the borrower could still at any time come and redeem the mortgage and thereby thwart the very auc tion process.'

Terming such a scenario where a borrower can redeem the mortgage at any time as "more worrisome", the bench said, the general public who participate in such auc tions are often neither aware nor informed by the secured creditors conducting the auctions that as long as the sale certificate is not issued, they will not have a right in the said asset and that the borrower whose asset is being auctioned could sweep in and redeem the mortgage any time.

"Thus, it is necessary to interpret the amended Section 13(8) of the SARFAES Act in such a manner where a legal sanctity is attached to an auction process and a bright line is drawn where a mischievous borrower is told 'no more and no further and precluded from hastily exercising its right of redemption from nowhere at the very end of the process and thereby set the entire auction process at naught," the bench said.

The top court set aside the Bombay High Court verdict, saying it was not justified in exercising its writ jurisdiction, particularly when the borrowers had already availed the alternative remedy available to them under the SARFAESI Act.

It directed the Union Bank of India to refund Rs 129 crore, the entire amount deposited by the borrowers for redemption of mortgage of the secured asset, at the
