including some opposition MPs in Parliament, who questioned the use of 'Nari Shakti Vandan' terminology by the government for the bill, he asked should not women of the country be paid obeisance and their honour enhanced.

The BJP is set to make the passage of the bill a major talking point of its poll campaign for the five state elections expected in November-December and the Lok Sabha elections likely in April-May next year; more so as those women voters who are persuaded by the welfare factor rather than social faultlines are seen to have emerged as an important voting bloc in recent years.

The prime minister said it was the BJP's good fortune that its government got the opportunity to pass the bill. The party's commitment made for the last three decades has now been fulfilled, he said.

Some decisions have the power to change a country's fate, Modi said, describing the proposed law as one such measure that will infuse new confidence among women and multiply India's strength to advance.

A new history was made on September 20 and 21, Modi said, referring to the days the bill was passed by the Lok Sabha and then by the Rajya Sabha. "It was our good fortune that people gave this government the chance to do so," he said, adding future generations will discuss this.

It was made possible because people elected a strong, stable and decisive government that has a full majority, the prime minister asserted. It was passed with record support and a long-held dream was finally fulfilled, he said.

This shows how the country takes big decisions where there is a decisive government enjoying a strong majority, Modi said. The self-confidence of women is touching the sky and their entry into decision-making will multiply the country's strength

This is proof of fulfilling "Modi's guarantee" that he will usher in a new era of women-led development, the prime minister said amid loud cheers from the women resent at the BJP headquarters.

Citing a number of his government's schemes and decisions for women's welfare, Modi said it has made every attempt to unshackle women with programmes for their security, respect and prosperity.

"From family to panchayat, from the economy to education and entrepreneurship, our sisters and daughters are doing unprecedented work in every field today. Women have played a significant role in taking India to the moon. Be it in startups, self-help groups or social campaigns, the role and participation of women are becoming the strength of the country," he said.

General J&K also asked the Deputy Custodians to liaise with the District Administration to identify evacuee land/property which has potential for commercial purpose including other lands which may be fenced and sign boards installed to avoid any encroachment.

He further asked that the land not viable for departmental use be put to open auction through e-auction mode for which the department has already developed an e-

Acting upon the directions of Custodian General J&K, the Evacuee Property Department Jammu through Dy. Custodian Samba has in the first instance reclaimed the possession of Evacuee Land measuring 3 kanaI Land under Khasra No. 722 alongwith structures raised thereon. As per the department the person was occupying the Evacuee Property illegally, though the land in question was leased out to him but he failed to deposit the premium fixed by the department and violated the terms and conditions of the lease.

"Ample opportunity was provided to the occupant to deposit the premium as provided under the provisions of J&K Evacuees' (Administration of Property) Act 2006 and on failure, the action was taken in the matter."

The Custodian General, while appreciating the action taken in the matter reiterated that the drives be undertaken by the department against the encroachers, illegal occupants and violators and may be intensified. and who bears little resemblance to the person they were years earlier? It is tempting to say that they are no longer the same person.

"Yet, the insistence of guidelines, obdurately, to not look beyond the red lines drawn by it and continue in denial to consider the real impact of prison good behaviour, and other relevant factors (to ensure that such individual has been rid of the likelihood of causing harm to society) results in violation of Article 14 (equaity before law) of the Constitution," the bench said.

Excluding the relief of premature release to prisoners, who have served extremely long periods of incarceration, not only "crushes their spirit, and instils despair, but signifies society's resolve to be harsh and unforgiving", the court said.

The bench noted that Rule 376 of the Kerala Prisons and Correctional Services (Management) Rules, 2014 prescribes that prisoners shall be granted remission for keeping peace and good behaviour in jail.

The man sought a direction to the state government to prematurely release him as he has been in custody (actual imprisonment) for over 26 years and served a sentence of over 35 years (including over 8 years of remission earned).

While ordering release of the convict with immediate effect, the apex court said as per the records produced by the state, the man has earned over 8 years of remission, which demonstrates his good conduct in jail.

The discussions in the minutes of the meetings of the jail advisory board are also positive and find that he is hardworking, disciplined, and a reformed inmate, the bench noted.

It said redirecting the petitioner, who has already served over 26 years of incarceration (and over 35 years of punishment with remission), to undergo consideration before the advisory board again and thereafter, the state government for premature release would be a "cruel outcome, like being granted only a salve to fight a raging fire, in the name of procedure"

The bench said the prison laws in India encapsulate a strong underlying reforma-

The practical impact of a guideline, which bars consideration of a premature release request by a convict who has served over 20 or 25 years, based entirely on the nature of crime committed in the distant past, would be to crush the life force out of such individual altogether, it said.

Giving an example, the bench said a 19 or 20 year old individual convicted of a crime which finds place in the list barring premature release altogether would mean that such a person will never see freedom and die within the prison walls.

"There is a peculiarity of continuing to imprison one who committed a crime years earlier who might well have changed totally since that time. This is the condition of many people serving very long sentences. They may have killed someone (or done something much less serious, such as commit a narcotic drug related offence or be serving a life sentence for other non-violent crimes) as young individuals and remain incarcerated 20 or more years later," it said.

by the medical board of the college. One male student and one female student were found ineligible on the basis of disability though both of them have been issued disability certificates by the Poonch CMO.

The basis of 40 percent disability is considered permanent. It has been reported that both of them have passed the NEET exam on the basis of disability. Sources said that for the first time in the history of GMC, cases of fake disability certificates have been detected.

According to Dr. Ashutosh Gupta, Principal of GMC Jammu, the medical board of the college has found both the students ineligible under disability category. "We have recommended BOPEE to cancel the disability eligibility of both the candidates and have sought two new seats", he said.

Accordingly, two new candidates will be sent to GMC for admission. In comparison to last year, GMC Jammu has got eight less seats than allotted for the year 2023 and 24. This year MBBS admissions are taking place on 172 seats. Of these, four seats are reserved on the basis of disability. Last year, GMC had admitted candidates to 184 seats instead of the prescribed 180 MBBS seats.

Police apprehends assailant in Ganderbal student attack case

SRINAGAR: Police have arrested an accused person in connection with an attack on a student at Qamariva Park in Ganderbal.

On a specific day at around 15:30 hrs, a scuffle broke out at Qamariya Park in Ganderbal between two individuals. During this altercation, a student named Mohd Irfan, son of Ab Hamid Sheikh and a resident of Saloora Ganderbal, sustained injuries when he was attacked with a sharp object or a thread cutter by another person, police official said. The injured student was quickly taken to the District Hospital in Ganderbal to receive immediate medical treatment. The local police, led by SHO Ganderbal Insp. Manzoor Ahmad, arrived at the scene prompty to investigate the incident. Preliminary investigation revealed that the attacker was identified as Abrar Ahmad Parray, the son of Mohd Ismail Parray and a resident of Rangil Nagbal. Abrar Ahmad Parray fled the scene after the attack. Consequently, a case, registered as FIR No. 271/2023, was filed at PS Ganderbal under the relevant sections of the law.
