In pursuance of the Notification No.063-BOPEE of 2023 dated 20.08.2023, the Board has conducted the Online Counseling for admission to the B.Sc. Nursing / B.Sc Para-Medical and B.Sc. Technology Courses-2023 in the Government / Private Colleges / Institutions of the UT of J&K w.e.f 25-08-2023 to 30-08-2023.

The candidates who have been allotted seats provisionally on the basis of Merit-cum-Preferences filled by them during the online process of counseling is hereby notified as per Annexure-A to this Notification, which shall remain available on the official website of the Board: www.jkbopee.gov.in only.

The candidates shall have to report to the respective Colleges allotted to them for completion of admission process w.e.f. 28.09.2023 to 02.10.2023 alongwith following documents in original:-

- 12th Class Marks Card.
- Domicile Certificate.
- Category Certificate, wherever applicable.
- Paramedical (12th Based) Diploma, (For Lateral Entry candidates only).
- Any other document as may be required by the College Authorities.

The provisionally selected candidates shall have to mandatorily report for admission to the allotted Colleges/Institutions by or before 02.10.2023 upto 04:00 p.m alongwith their relevant certificates in original, failing which they shall not be eligible for further rounds of counseling, if any, conducted by the Board.

The Colleges shall submit the shortfall, if any, on 02.10.2023 upto 05:00 p.m positively to enable the Board to take further appropriate action in the matter.

Note:-

- The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate(s) proves to be false / fabricated and action as warranted under law shall be initiated against those candidates.
- If any candidate(s) is found to have concealed any information, his/her selection/admission shall be cancelled ab-initio and fine/penalty shall also be imposed upon him as may be deemed proper by the Board in accordance with the laid down rules.
- It is hereby implored upon the management of all Colleges/ Institutions to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a Reserved Category. So far as the Persons with Disability are concerned, if selected under Open Merit or against a Reserved Category, it shall be ensured that his/her PwD Certificate/eligibility is in conformity with Indian Nursing Council (INC) Guidelines / Regulations framed by the concerned Regulatory Body and wherever required shall refer the matter to the concerned Medical Board to assess such candidate(s) and make recommendations based on which Institution(s) shall take further necessary action. In case any candidate does not fulfill the benchmarks of eligibility as per INC Guidelines, his/her admission shall be cancelled on his/her own risk and responsibility under intimation to the Board.
- All the Heads of the Institutions shall check & verify the Diploma of candidates who have been provisionally selected for B.Sc. Paramedical Courses under Lateral Entry category as per his/her eligibility under that category, if not so, then they shall be considered under normal course.
- All the Heads of the Institutions/Colleges are requested to keep their admission counters open on Holidays/OFF days to facilitate the candidates to complete their admission well in time and the candidates should in their own interest, avoid waiting for the last day for completing the admission formalities as the delay in such matters has the potential of causing hardships to the candidates only.
- The Heads of the Institutions shall keep record of the admissions and send the shortfall of the candidates, if any, who have not completed their admission within the prescribed time mentioned above through E-mail viz. coejakbopee@gmail.com & helpdesk@jkbopee@gmail.com on 02.10.2023 upto 05:00 p.m positively along with hard copy duly signed by the Head of the Institution.
- As mentioned in the Notification No. 063-BOPEE of 2023 dated 20-08-2023 that the seats under CDP Category shall be allotted to the concerned eligible category candidates separately or physically during the Second round of the counseling on the basis of valid Priority Certificates uploaded by the said candidates during submission of the Online Application Form. However, any CDP Category candidate filling under Open Merit shall be allotted a seat as per the preference filled up by the candidate during the process of online counseling. Moreover all the eligible candidates are advised to report alongwith their CDP Priority Certificate issued by Zila Sainik Welfare Board on the day of counseling as and when notified by the Board.
- As communicated by the Director College Development Council, University of Jammu vide letter No. CDC/2023/3009-10 dated 19.09.2023 to fill up only eighty (80) seats in the Government B.Sc Nursing College Jammu, Govt. Nursing College, Gangyal and forty (40) seats in the Government, B.Sc. Nursing College Akhnor instead of 100 and 60 seats respectively in these Colleges as reflected in the seat matrix uploaded on website of the Board, therefore, in the larger interest of the students, the Board has taken into consideration the actual approved intake communicated by the College Development Council, University of Jammu in respect of these Nursing Colleges and accordingly allotted seats to the candidates in these Institutions on the basis of their merit cum preferences.

The other Terms and Conditions shall, however, remain the same as notified by the Board in the e-Information Brochure and Notifications/Notices issued from time to time in this regard. **E & O E**

Pursuant to Notice No. 028-BOPEE of 2023 dated 22.09.2023, the second round of counselling (physical) for up-gradation/allotment of seats to NEET MD/MS/PGD and MDS Courses including seats under the HM and NRI quota in the ASCOMS-2023 was conducted by the Board on 23rd and 24th of September, 2023 at BOPEE Office Jammu/Srinagar simultaneously. The lists of the candidates who have been provisionally upgraded / allotted seats / disciplines in Government/private Medical/Dental Colleges/Institutions are hereby notified as per the Annexure "A" (for MD / MS / PGD Courses) and Annexure "B" (for MDS Courses) to this notification which shall remain available on official website of the Board i.e. www.jkbopee.gov.in only.

The candidates upgraded / allotted seats/disciplines / Institutions shall have to join in the allotted institutions by or before 28.09.2023 upto 4.00 p.m. positively.

It is further notified for information of all the concerned candidates that the upgradation/allotment of seats during the Second Round of Counselling shall be purely on provisional basis and shall not confer any preferential right upon the selected candidates and shall be subject to the outcome of writ petition WP(C) No 2233/2023, CM No 5216 / 2023 titled Nadeem-ur-Rehman & Ors. vs. UT of J&K & Ors and any other writ petition, subjudice in the Hon'ble High Court of J&K and Ladakh, on the subject.

It shall be sole responsibility of the Colleges/ Institutions concerned to ensure proper checking/verification of documents/ eligibility as per the guidelines of MC/NMC /DCI before the candidate is allowed to join the course he/she is provisionally selected for.

The Colleges/ Institutions shall submit the shortfall, if any, to BOPEE Office, Jammu/Srinagar upto 5.00 PM on 28.09.2023 through e-mail jakbopee@gmail.com / helpdesk@jkbopee@gmail.com / coejakbopee@gmail.com.

In view of the limited time available for completion of admission process, all participating Institutions/ Colleges shall treat all Sundays and Gazetted holidays as working days especially for the concerned admission sections so that the candidates may not face any problem in completion of their admission formalities in time.

Note:
