The candidates shall report for admission to the colleges allotted to them w.e.f. 04.09.2023 to 11.09.2023 - along with following documents in original:-

- Marks Card of B.Sc. Nursing / Post Basic B.Sc./B.Sc. Honors. Nursing course with 55% marks.
- Domicile Certificate of UT of J&K and for the candidates of UT of Ladakh, ST certificate issued by the competent authority of Ladakh shall be treated as domicile certificate.
- One Year work experience after B.Sc. Nursing/Post Basic B.Sc. Nursing;
- Certificate as a registered Nurse or Registered Midwifery or equivalent with any State/UT Nursing Council.
- Category certificate, wherever applicable.
- Any other certificate as may be required by the College Authorities.

The candidates provisionally selected shall mandatorily have to report for admission to the allotted College/Institution by or before 11.09.2023 upto 4:00 pm along with their relevant certificates in original, failing which they shall not be eligible for further rounds of counseling, if any, conducted by the Board.

The Colleges shall submit the shortfall, if any, on 11.09.2023 upto 5:00 pm positively to enable the Board to take further necessary action in the matter.

Note:-

- The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate proves to be false/ fabricated, and action as warranted under law shall be initiated against such candidates
- The candidate(s) if any found to have concealed any information, his/her selection/admission shall be cancelled abinitio and fine/penalty shall be imposed upon him/her as may be deemed proper by the board in accordance with the laid down rules.
- All the Heads of the Institutions/Colleges are requested to keep their admission counters open on holidays/off days to facilitate the candidates to complete their admission process well in time. Consequent upon declaration of the NEET UG- 2023 result by the National Testing Agency (NTA) on 13-06-2023, and to update the category status vis a vis preparation of the Provisional UT Merit List of registered candidates for admission to BAMS/BUMS/BPT Courses-2023, it is hereby notified for the information of all the candidates who have secured the minimum qualifying marks in NEET UG -2023 and have not registered themselves earlier but are willing to participate in online counseling process for BAMS/BUMS/BPT Courses shall be required to register themselves afresh and upload the following documents with effect from 04-09-2023 to 07-09-2023:-

- NEET -UG - 2023 Score Card
- 10+2 marks card.
- Domicile Certificate of UT of J&K (ST Category Certificate in respect of candidates belonging to the UT of Ladakh).
- Category Certificate, wherever required.
- Date of Birth Certificate (Matriculation).

The tentative NEET score list of candidates of J&K, who have appeared in the NEET UG 2023 has already been notified by the Board vide Notification No.035-BOPEE of 2023 dated 06.07.2023 and Notice No. 041-BOPEE of 2023 dated 15.07.2023, which are available on the BOPEE website viz. [www.jkbopee.gov.in](http://www.jkbopee.gov.in) only.

The candidates who have already registered for NEET MBBS/BDS Courses-2023 and whose name(s) are already figuring in PML notified vide Notification No. 045-BOPEE of 2023 dated 27-07-2023 need not to register again for Ayush Courses - 2023.

The candidates who are already registered for NEET MBBS/BDS Courses - 2023 but have either failed to clear their deficient documents as per Notification No. 045-BOPEE of 2023 dated 27-07-2023 or whose forms are incomplete due to one reason or other are also eligible to participate in the counseling process for Ayush Courses - 2023 subject to the condition that they shall have to approach BOPEE office physically for clearing their deficiencies enabling them to participate in registration process within cutoff date fixed by the Board.

The e-information Brochure for NEET-UG BAMS/BUMS/BPT-2023 Courses has already been uploaded on website of the Board. The candidates are advised to go through the e- information Brochure before registration.

- No under process certificates shall be entertained.
- There will be no Registration fee charged from the candidates.
- Mobile phones should not be used for registration purposes for uploading of documents, as the software will not accept the same.
- The category certificates issued only up to the last date of registration shall be entertained. Any certificate issued after the registration date shall not be entertained by the Board under any circumstances.
