
SHRADHANJALI

CRIME REPORT

2 drug peddlers arrested; contraband substances recovered

BARAMULLA: Continuing its efforts to eradicate the menace of drugs from the society, Police have arrested 02 drug peddlers in Baramulla and recovered contraband substances from their possession.

A police party of Police Post Palhallan headed by Incharge PP Palhallan at a checkpoint established at Palhallan Morh intercepted a person identified as Hashim Ramzan Gojree son of Mohd Ramzan resident of Gojree Mohalla Palhallan. During checking, 4.2 Kgs of poppy straw like contraband substance was recovered from his possession. He has been arrested and shifted to police station where he remains in custody.

Meanwhile, a police party headed by SHO PS Kunzer at a checkpoint established at Mangloora Baramulla intercepted a person identified as Wakeel Ahmad Rather son of Abdul Karim resident of Mangloora Kunzer. During checking, 75 grams of Charas like contraband substance was recovered from his possession. He has been arrested and shifted to police station where he remains in custody.

Accordingly, cases under relevant sections of law have been registered at respective Police Station and investigations have been initiated.

7 vehicles seized, 7 persons arrested for illegal extraction and transportation of minerals

BARAMULLA: Acting tough against the persons involved in illegal extraction and transportation of minerals, police have seized 7 vehicles and arrested 7 persons in Baramulla.

A police party under the supervision of SDPO Tangmarg assisted by SHO PS Tangmarg seized 4 vehicles (3 tippers, 1 tractor) and arrested 4 drivers for their involvement in illegal extraction and transportation of minerals at Shrai & Ferozpora Tangmarg. They have been identified as Farooq Ahmad Malik son of Mohd Akbar, Zahid Ahmad Reshi son of Ab Rahim, Waseem Ahmad Malik son of Gh Ahmad all resident of Paraswami Kunzer & Balder Ahmad Ahanger son of Mohd Sultan resident of Ferozpora.

Meanwhile, a police party under the supervision of DySP Hqrs Baramulla assisted by SHO PS Sheeri seized 03 vehicles (3 tippers) and arrested 3 drivers for their involvement in illegal extraction and transportation of minerals at Sheeri. They have been identified as Farooq Ahmad Dar son of Mohd Maqbool, Bashir Ahmad Reshi son of Ab Hamid both residents of Jalsheeri & Khalid Hussain Malla son of Gh Ahmad resident of Kitchama.

Accordingly, cases under relevant sections of law have been registered at respective Police Station and investigations have been initiated.

Three arrested for raping minor girl

SAMBA: Police has arrested gang-rape accused within 24 hours after commission of heinous crime in Rangarh.

A case FIR No.53/2023 under section 457/363/376-D IPC, 3/4 POCSO Act was registered at Police Station Rangarh and investigation is underway.

The accused have been arrested by the investigating officer (IO) Inspr. Sham Lal under the supervision of SDPO Vijaypur/Rohit Kumar and Additional SP Samba SurinderChoudhary.

Two people injured in land dispute

JAMMU: One group opened fire on people of another group in Meldi Panchayat adjacent to Udhampur city over a land dispute on late Thursday night, due to which two people were injured.

The aggrieved party told that they were having a long standing dispute with a person from Rathian over land, whose case was in the court. The verdict came in his favor on Wednesday, after this, on Thursday, another group reached outside his house with a his supporters and asked him to compromise, but he told them that he had won court case. Irked over it, they opened fire on some people who came out of the house and as soon as they saw the police who reached the spot, they ran away.

The victim's side told that two of their people were injured in this firing. A child was shot in the leg and was taken to GMC for treatment.

Bovine smugglers attack police team; case registered

SAMBA: Cattle smugglers have pelted stones on a police team after which the police have registered the case vide FIR number 216. The police also scanned the CCTV of the area on Friday morning so that clues can be found about the smugglers, but till now nothing has been found by the police.

Later smugglers fled from the spot with the vehicle.
